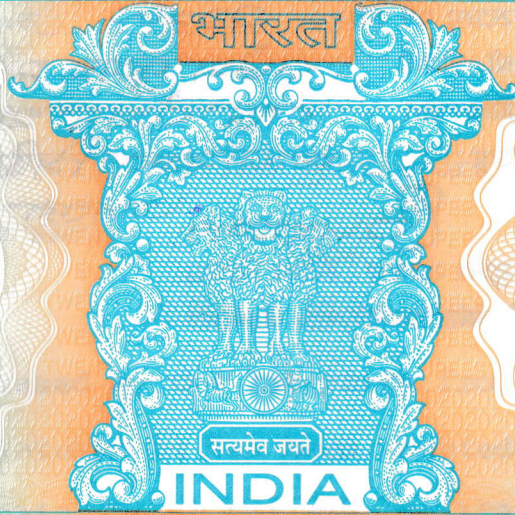

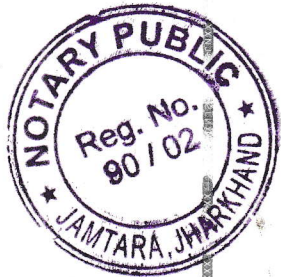

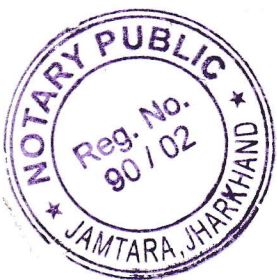
WHEREAS Plot no. ~~13~~ 728/D/1/M area 8.24 sq.mtr.
