The Plot No. of land is 2712/A, 2713/A.

That THE SAID DONEE i.e. the state shall and may from time to time and at all times here after peaceably and qutely use the said strip of land as a public property and have liberty to construct the road etc. And that the DONAR hereby declare that neither the DONAR nor his legal heirs, shall claim any right, title or interest over the schedule land shall not encroach the said strip of land.
