Executive Officer, Ramgarh Nagar Parishad, Ramgarh (hereinafter called the done) of the P.K. SIN OTHER PART.

WHEREAS THE said Donor is the absolute owner in Possession of land, Tenement and provises situated at Village- Kaitha, P.O.- Kaitha, P.S.-Ramgarh, Dist- Ramgarh being R.S. Markha Plot No. 1865, Khata No. 20 Thana No.

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has got a building Plan sectioned by the C.E.O. Ramgarh Nagar Parishad Ramgarh vide BC. Case No. RNP/BP/0013/W26/2022 date 17.03.2022.

AND WHEREAS for the development or widening of road in front & side of the above mentioned land the Donor has left a strip of land for Road / Widening and is ready to donate the said strip of land to the State mentioned in Schedule below for the benefit of Society as a whole.
