BETWEEN

Manjar Ali Khan and Sanjar Ali Khan, S/o Md Mosarraf Khan, by faith Islam, by occupation Business, Resident of Village Hcsia, P.S- Mandu, Dist- Ramgarh (hereinafter called the DONOR) of the ONE PART.

AND

Executive Officer, Ramgarh Nagar Parishad, Ramgarh (hereinafter called the done) of the OTHER PART.

WHEREAS THE said Donor is the absolute owner in Possession of land, Tenement and premises situated at Vilalge-Hesla, P.S- Ramgarh, Dist-Ramgarh being R.S. Plot No. 465, Khata No. 28, Thana No. 138.

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has got a building Plan Sectioned by the C.E.O Ramgarh Nagar Parishad Ramgarh vide BC Case No. RNP/BP/0040/W11/2022 date 28.10.2022.

AND THAT the Donor hereby declares that neither the DONOR nor his legall heirs shall oldin any night, title on interest owen the sollechile and ishall i not encroach the said strip of land.


