SHRI HERMAN TIRKEY, S/O LATE PRABHUDAS TIRKEY, by faith- Christian, Occupation-Retired Teacher, Resident of Mahtotoli, Khijri, Simdega., P.O.- Simdega, P.S.-Simdega, District-Simdega (herein after the donor) of the **One Part**.

#### AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the Other Part.

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:- Mahtotoli,Khijri District- Simdega, being R.S. Plot No.- 2728, Khata No.- 19, Thana No.- 105.
