#### BETWEEN

**PIUS KERKETTA**, S/O Late Stefan Kerketta By Faith Christian, Occupation – Service, Resident of Dumar Toli, P.S. – Simdega, P.S.No. – 116, Dist – Simdega (herein after called the DONOR) of the ONE PART.

#### AND

THE STATE OF JHARKHAND through the Government of the state, at SIMDEGA (herein after called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land.

Tenement and premises situated at Mawza – Simdega, Dumar Toli, P.S. – Simdega, P.S. No. – 116, RS Plot No. 265, Khata No. – 91/123

AND WHEREAS in the order to construct a building over the land mentioned here in above the DONOR has got a building plan sectioned by the SIMDEGA NAGAR PARISHAD, SIMDEGA vide B.C. case No. – SINPC/BP/0466/W15/2023 Dated – 03.01.2024

AND That the said DONEE i.e. the State shall and may from time to time and at all here after peaceably and quietly use the said strip of land as a public property and all have liberty to construct the Road etc.

AND THAT the DONOR hereby declares that neither the DONOR nor his legal heirs all claim any right, title or interest over the schedule land and shall not encroach the land strip of land.
