BETWEEN

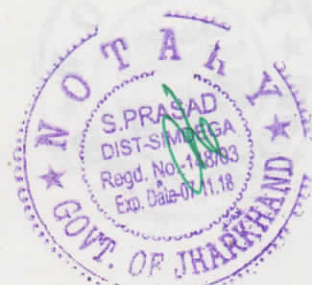
