### BETWEEN

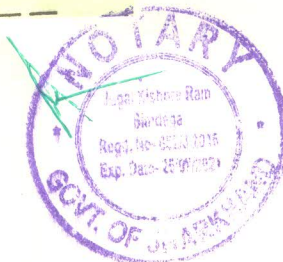
