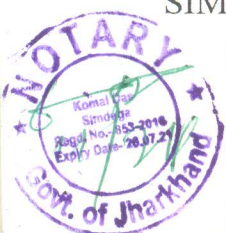

THE STATE OF JHARKHAND through the Governor of the state, at SIMDEGA (here in after called the DONEE) of the OTHER PART.

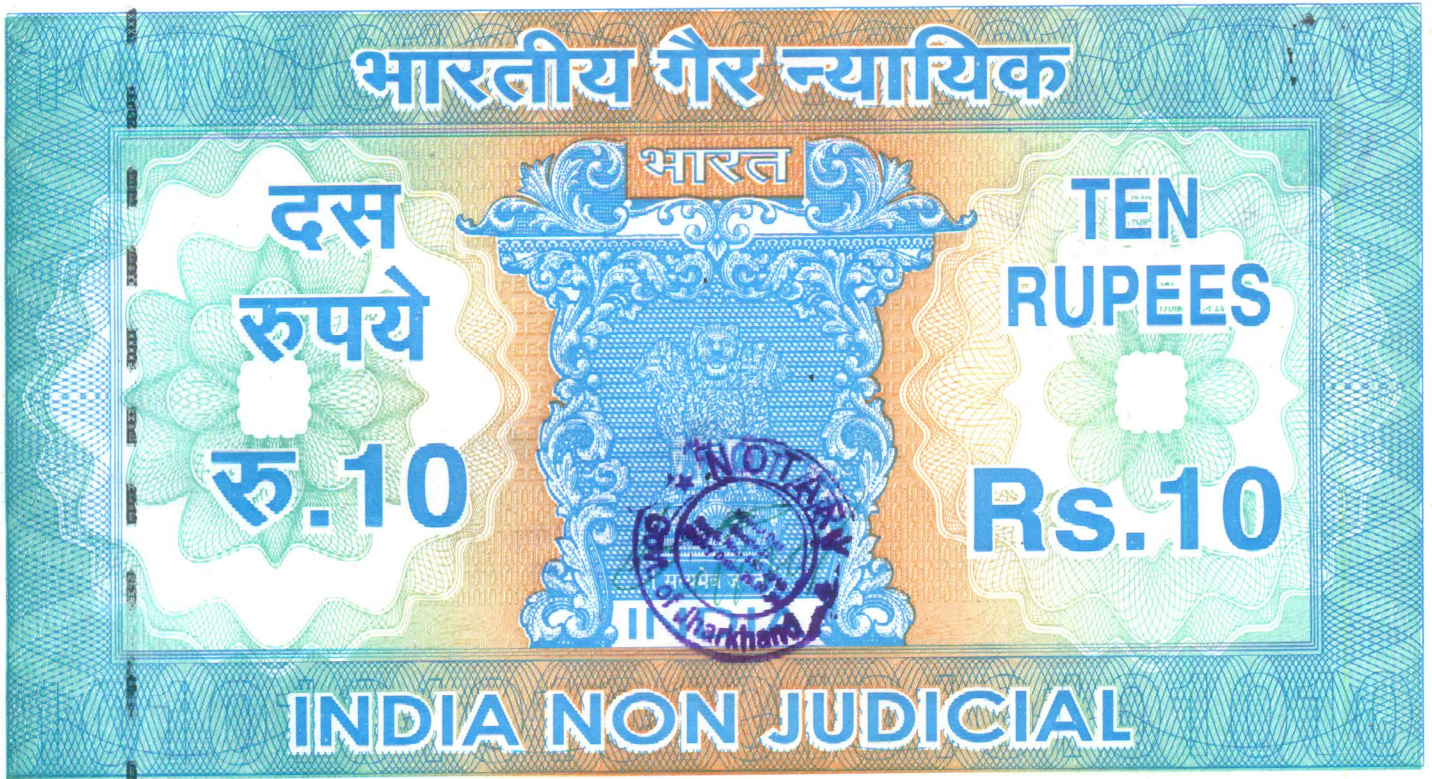

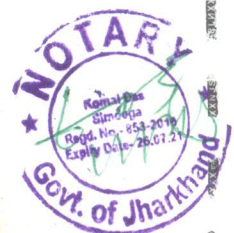

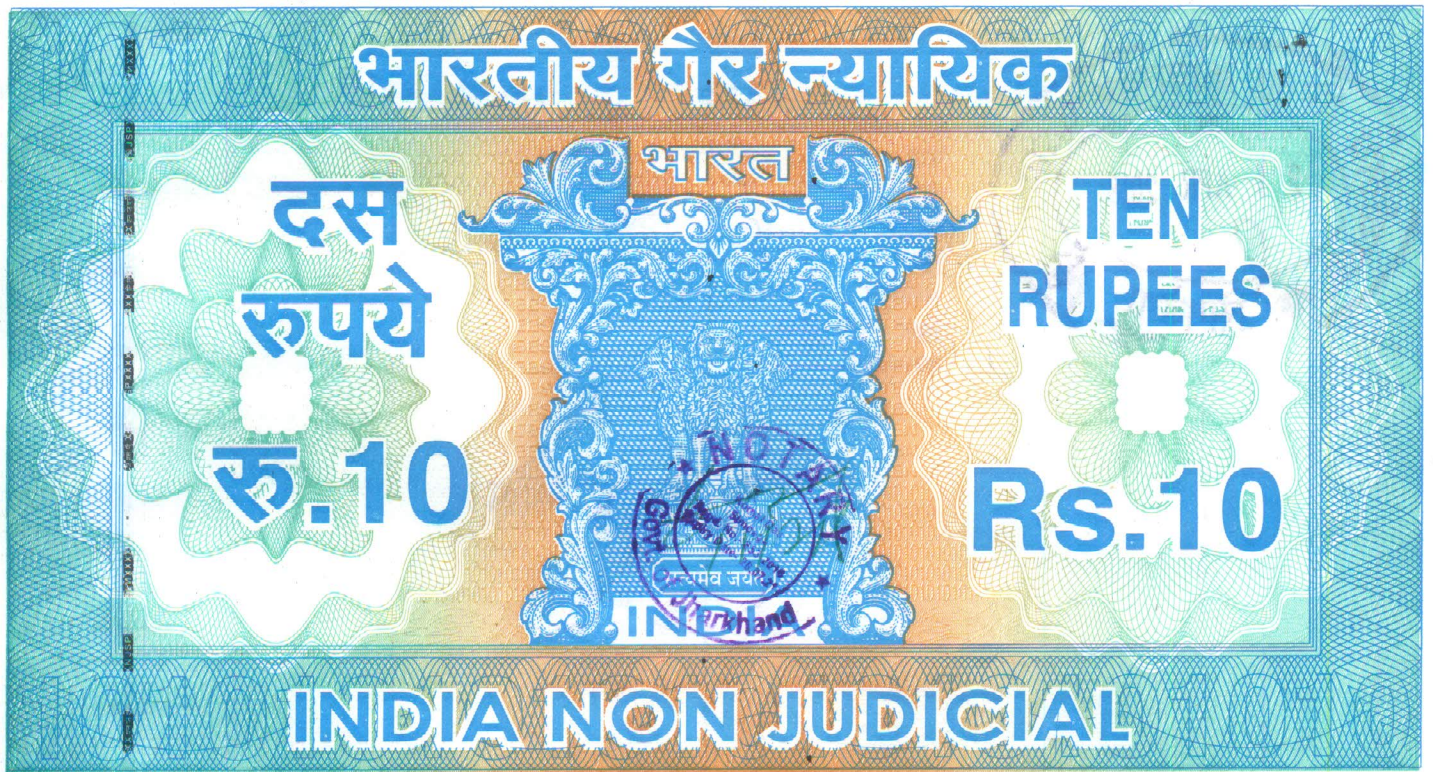
NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS:-

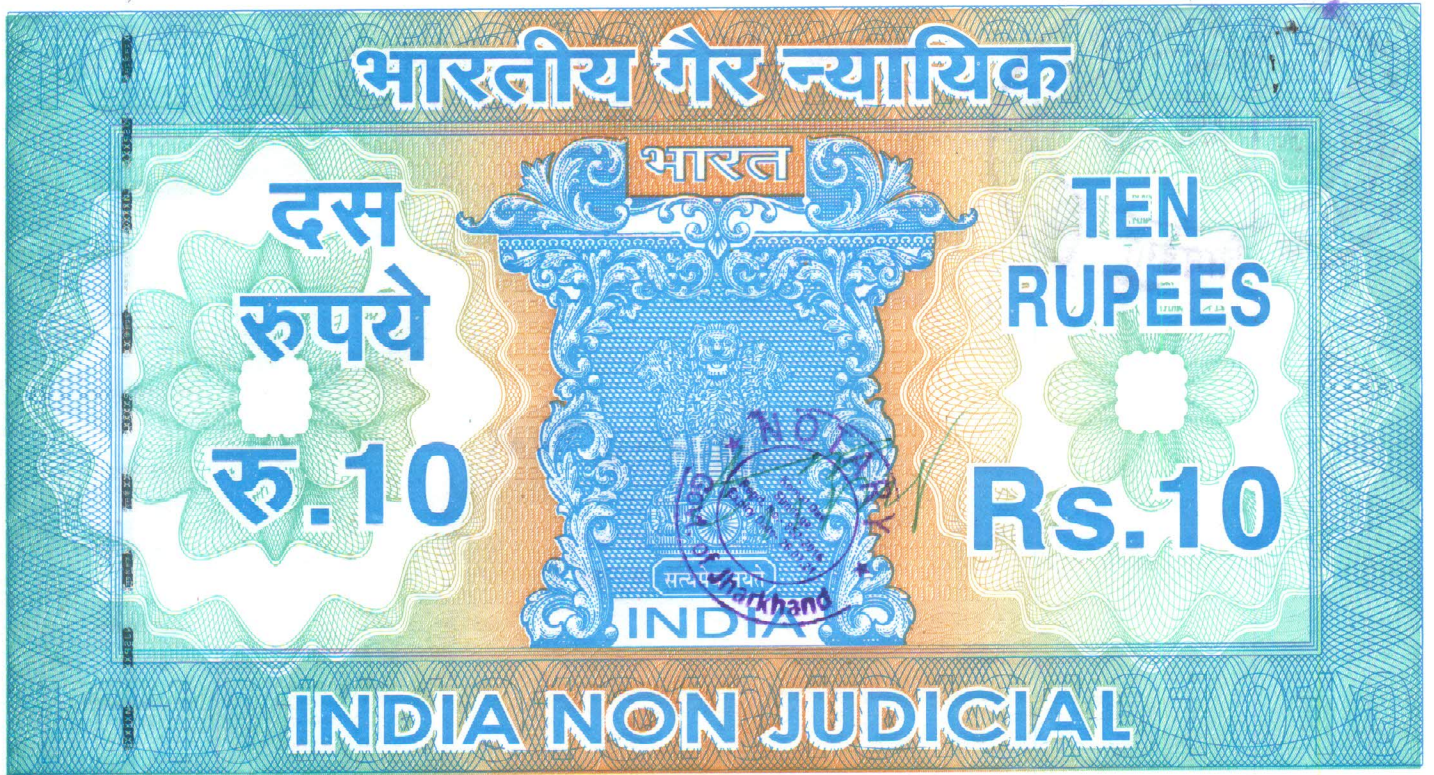

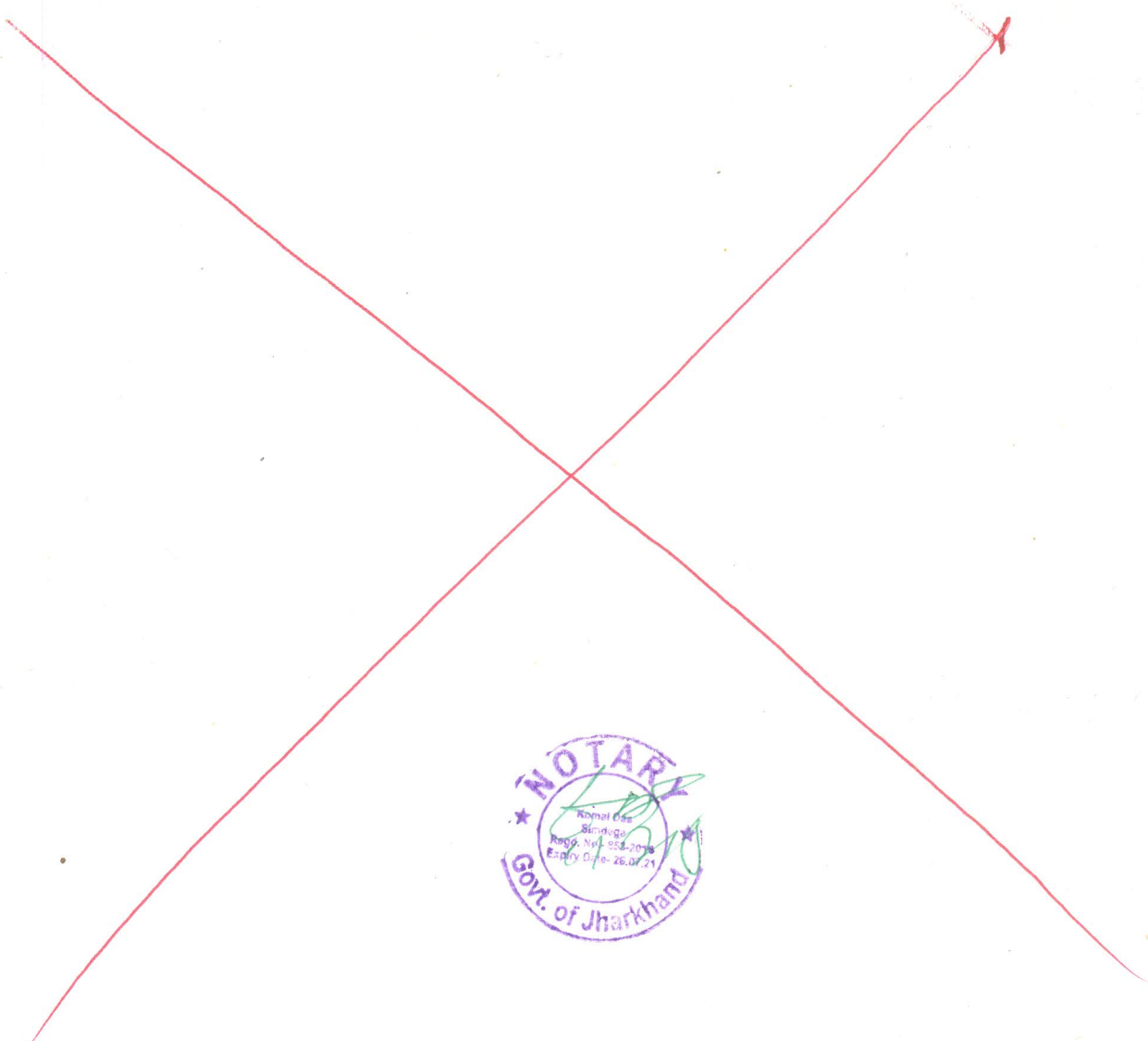
