#### AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the Other Part.

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:— KHIJRI,SAMTOLI,SIMDEGA District- Simdega, being R.S. Plot No.-2385, Khata No.- 113, Thana No.- 105.

And whereas in the order to construct a building over the land mentioned herein above the DONOR has the Nagar Parishad, Simdega sanctioned a building plan vide BC Case No.-SINPC/BP/0293/W06/2022 and whereas for the development of road land for widening and is ready to donate the said stirp of land to the state mentioned in Schedule below for the benefit of the society as a whole.

Title of interest over the schedule of land and shall not encroach the said strip of land.
