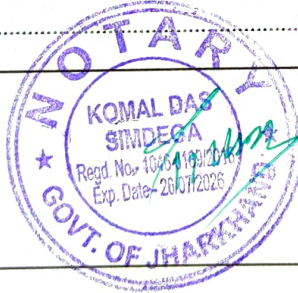

Hereafter peacefully and quietly use the said strip of land as a public property and have liberty to construct the road etc. and that DONOR hereby declares that neither the DONOT nor his legal heris shall claim any right. Title of interest over the schedule of land and shall not encroach the said strip of land.
