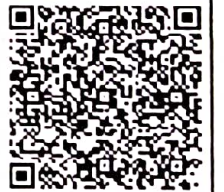
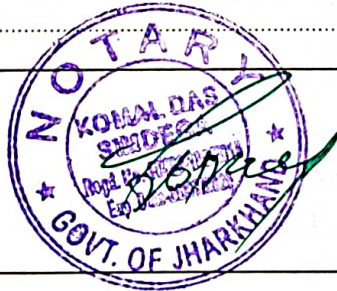

THE DEED OF GIFT IS MADE ON THIS THE 26<sup>TH</sup> DAY OF JULY 2024 A.D.

**BETWEEN**

**SHASHI PRABHA LAKRA, W/O. ARBIND BARA, by faith-CHRISTIAN, Occupation-Housewife, Resident of Village -MAHTO TOLI, KHLJRI, P.S. 105, District:- Simdega (hereinafter called the Donor) of the ONE PART.**

**AND**

**THE EXECUTIVE OFFICER, Simdega Nagar Panchayat, Simdega (Hereinafter called the DONEE) of the OTHER PART.**

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at: Village:—MAHTO TOLI, KHLJRI District:-Simdega, being R.S. Plot no:-2170, Sub Plot: -2170 , Khata No:-152, Thana No:-105

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has the Simdega Nagar Panchayat, Simdega sanctioned a building plan vide BC. Case no **SINPC/BP/0508/W06/2024** AND WHEREAS for the development or road widening of the road in front of the Above mentioned land the DONOR has left a strip of the land for Road Widening and is Ready to Donate the said strip of land to the state mentioned in schedule below for the benefit of the society as a whole.  
NOW this deed of Gift witnesses as follows:-

1. That in pursuance of the said intention and in consideration of benefit to the society as whole the DONOR out of his free will, without coercion or undue influence from anybodywhosoever hereby convey, grant, transfer and conform into the DONEE- "the state" all that strips of land measuring an area 17 SQM.

(182.92sq.ft.).

Mournfully described in schedule below and shown in RED wash in the map attached herewith forming part of this Deed. The value of land is Rs- 6,297.85

2. And that the said DONEE i.e. the state shall and may from time to time and at all times, hereafter peaceably and quietly use the said strip of land as a public property and have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
