THE DEED OF GIFT IS MADE ON THIS THE DAY OF 15/04/2019

BETWEEN

SMT. SUCHITA SORENG, W/O - ASHOK KULLU, by Faith -CHRISTIAN, by Occupation-TEACHER, Resident of MARIYAMPUR, SIMDEGA, Thana No.- 105, District- SIMDEGA (HERE IN AFTER CALLED THE donor) of the ONE PART.

AND

THE NAGAR PARISHAD, SIMDEGA through the Executive Officer Simdega, at Simdega (here in after called the DONEE) of the OTHER PART.
