THE DEED OF GIFT IS MADE ON THIS THE DAY OF 03/07/2018 A.D.


BETWEEN

BEDNATH MAHTO, S/O – SRI SHIVRAM MAHTO, by Faith HINDU, by Occupation - SERVICEMAN, Resident of SALDEGA, KUMHARTOLI, THANA NO - 117, District – SIMDEGA (here in after called the DONOR) of the ONE PART.

AND

THE STATE OF JHARKHAND through the Governor of the state, at SIMDEGA(here in after called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land. Tenement and premises situated at Village - SALDEGA, KUMHARTOLI, District - SIMDEGA being R.S. Plot No-.1036, Khata No - 82, Thana No - 117.



Influence from anybody whomsoever hereby convey, grant transfer and confirm unto the said DONEE "The State" all that strip of land measuring an area of 19.64 Sq.mt more fully described in schedule below with forming part of this deed the value of gifted land is RS. 34376.00 under Rupees THIRTY FOUR THOUSAND THREE HUNDRED SEVENTY SIX ONLY.





And that the said DONEE i.e. the State shall and may from time to time and at all here after peaceably and quietly use the said strip of land as a public property and all have liberty to construct the road etc.

AND THAT the Donor hereby declares that neither the DONOR nor his legal heirs all claim any right, title or interest over the schedule land and shall not encroach the strip of land.
