### BETWEEN

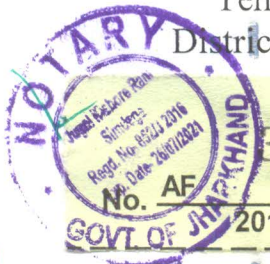

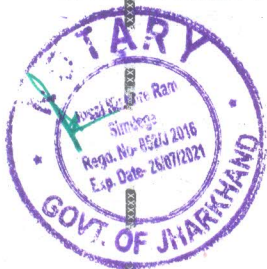

**NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS:-**

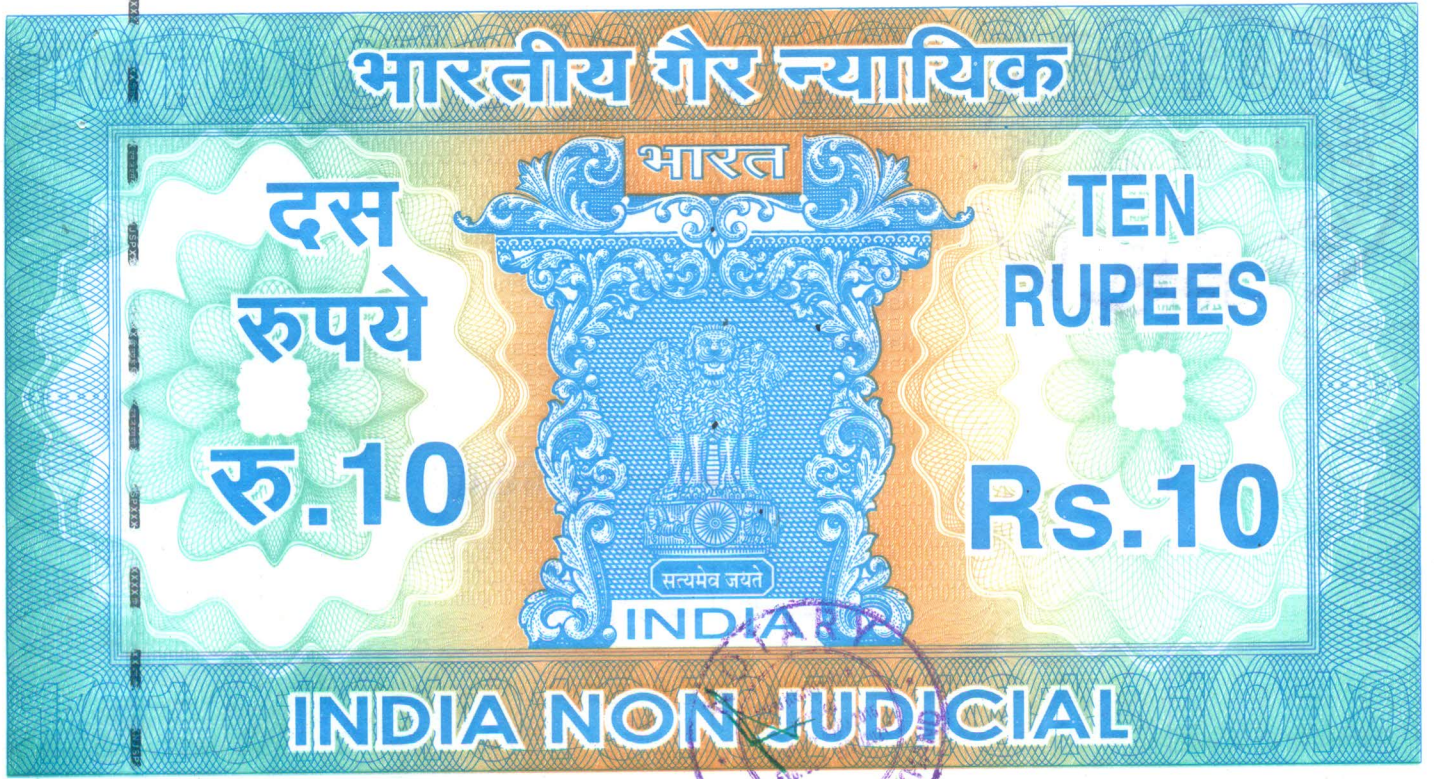
That in pursuance of the said intention and consideration of benefits to the society as whole the DONER out of his free will, without coercion or undue.

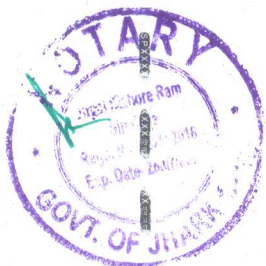

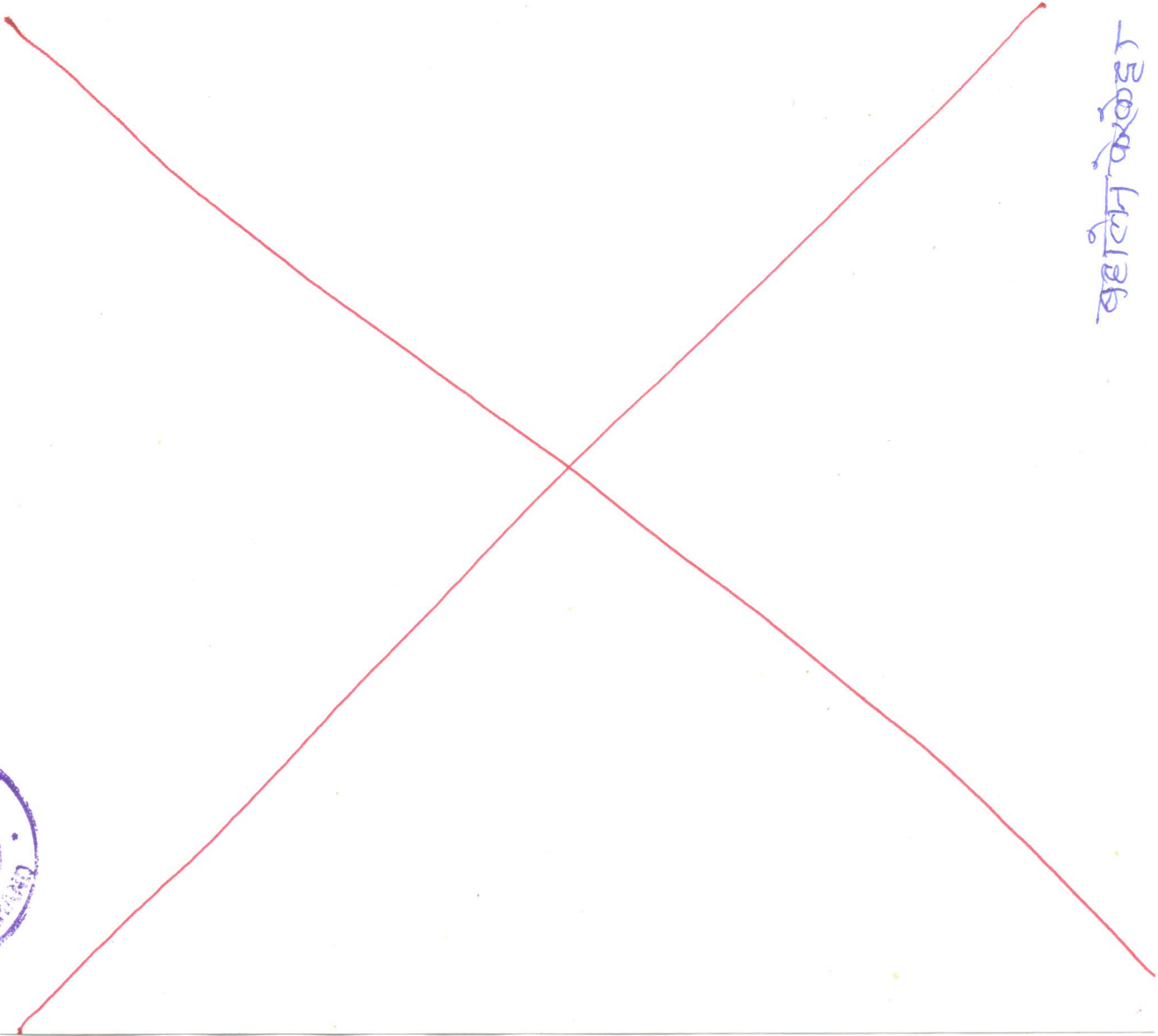
