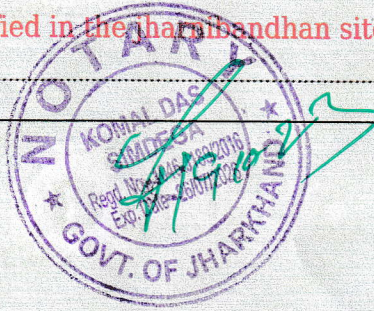

the OTHER PART.

WHEREAS the said DONOR is the absolute owner In Possession of land, Tenement and

AND WHEREAS in the order to construct a building over the land mentioned herein above

herewith forming part or this Deed. The value of land is **Rs- 4940.93**


2. And that the said DONEE i.e. the state shall and may from time to time and at all times,
