THE EXECUTIVE OFFICER, Simdega Nagar Panchayat, Simdega (Hereinaster called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at: Village:- DUMARTOLI District:-Simdega, being R.S. Plot no:-1252, Sub Plot: -1252, Khata No:14, Thana No:-116

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has the Simdega Nagar Panchayat, Simdega sanctioned a building plan vide BC. Case no SINPC/BP/0462/W08/2023 AND WHEREAS for the development or road widening of the road in front of the Above mentioned land the DONOR has left a strip of the land for Road Widening and is Ready to Donate the said strip of land to the state mentioned. in schedule below for the benefit of the society as a whole.
