AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the Other Part.

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:- Officer Colony, Samtoli, Gotra District- Simdega, being R.S. Plot No.- 3469, Khata No.- 44, Thana No.- 80
