THE EXECUTIVE OFFICER, Simdega Nagar Panchayat, Simdega (Hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at: Village: - PUSPUR, KHIJRI District:-Simdega, being R.S. Plot no:-2327, Sub Plot: -2327, Khata No:59, Thana No:-105
