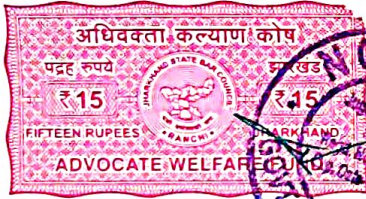

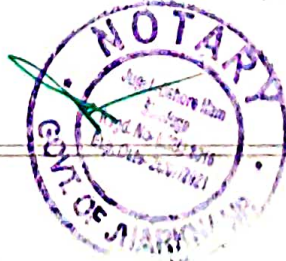

NOW THIS DEED OD GIFT WITNESSES AS FOLLOWS:-

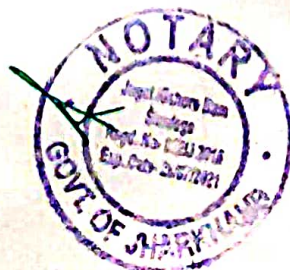
