## GIFT DEED

THE DEED OF GIFT IS MADE ON THIS 17<sup>th</sup> DAY OF AUGUST 2024.

### BETWEEN

SHRAWAN BARAİK S/O LATE CHARKU BARAİK, by faith- Hindu, Occupation- Retired, Resident of Thakurtoli, Simdega., P.O.- SIMDEGA, P.S.-SIMDEGA, District- Simdega (herein after the donor) of the **One Part.**

### AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the **Other Part.**

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:- THAKURTOLI, SIMDEGA District- Simdega, being R.S. Plot No.- 2482/2483, Khata No.- 62, Thana No.- 80.

And whereas in the order to construct a building over the land mentioned herein above the DONOR has the Nagar Parishad, Simdega sanctioned a building plan vide BC Case No. **SINPC/BP/0506/W02/2024** and whereas for the development of road land for widening and is ready to donate the said strip of land to the state mentioned in Schedule below for the benefit of the society as a whole.

Now this deed of gift witness as follows:-

1. That in pursuance of the said intention and in consideration of benefit of the society as whole the donor out of his free will. Without correction or undue influence from anybody whosever hereby conveys. Grant, transfer and confirm into the DONEE: - "Nagar Parishad, Simdega". All the strip of land measuring area 11.94 Square Meter.  
Mournfully described in schedule below and shown in RED wash in the map attached herewith forming part of this deed. The Value of land is INR- 26,422/-
2. And the said DONEE i.e. the Nagar Parishad, Simdega shall always and may from time-to-time and. Hereafter peaceably and quietly use the said strip of land as public property and have liberty to construct the road etc. And that DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right. Title of interest over the schedule of land and shall not encroach the said strip of land.
