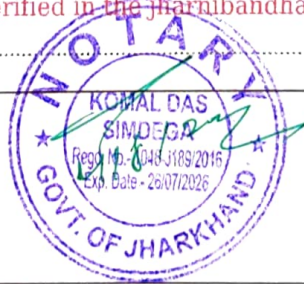

THE DEED OF GIFT IS MADE ON THIS 04th DAY OF AUGUST 2022.

SRI THADEUS TIRKEY, S/O LATE LUCAS TIRKEY, by faith- CHRISTIAN, Occupation- TEACHER, Resident of THAKURTOLI, Simdega.,P.O.- SIMDEGA, P.S.-SIMDEGA, District- Simdega(herein after the donor)of the One Part.

AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the Other Part.

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:- THAKURTOLI, SIMDEGA District- Simdega, being R.S. Plot No.- 4879, Khata No.- 101, Thana No.- 80.

And whereas in the order to construct a building over the land mentioned herein above the DONOR has the Nagar Parishad, Simdega sanctioned a building plan vide BC Case No.- SINPC/BP/0220/W02/2021 and whereas for the development of road land for widening and is ready to donate the said stirp of land to the state mentioned in Schedule below for the benefit of the society as a whole.



Now this deed of gift witness as follows:-

Without correction or undue influence from anybody whoseever hereby convey. Grant, transfer and confirm into the DONEE:- "Nagar Parishad, Simdega". The Value of land is INR- 41235..00

And the said DONEE i.e. the Nagar Parishad, Simdega shall and may from time to time and at all times.hereafter peaceably and quietly use the said strip of land as a public property and have liberty to construct the road etc. And that DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right. Title of interest over the schedule of land and shall not encroach the said strip of land.
IN WITNESS WHEREOF the said donor has hereto set and subscribed his signature and delivered in the presence of witness as present day. Month and year first above mentioned.


