AND

THE EXECUTIVE OFFICER NAGAR PARISHAD, Simdega Hereinafter the (DONEE) of the **Other Part**.

Whereas the said donor is the absolute owner in possession of land. Tenement and premises situated at village:- THAKURTOLI, SIMDEGA District- Simdega, being R.S. Plot No.-5011, Khata No.- 12, Thana No.- 80.


Now this deed of gift witness as follows:-

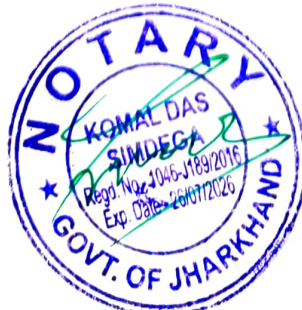

The Value of land is INR- 46,143/-
2. And the said DONEE i.e. the Nagar Parishad, Simdega shall and may from time to time and at all times. Hereafter peaceably and quietly use the said strip of land as public property and have liberty to construct the road etc. And that DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right. Title of interest over the schedule of land and shall not encroach the said strip of land. IN WITNESS WHEREOF the said donor has hereto set and subscribed his signature and delivered in the presence of witness as present day. Month and year first above mentioned.


