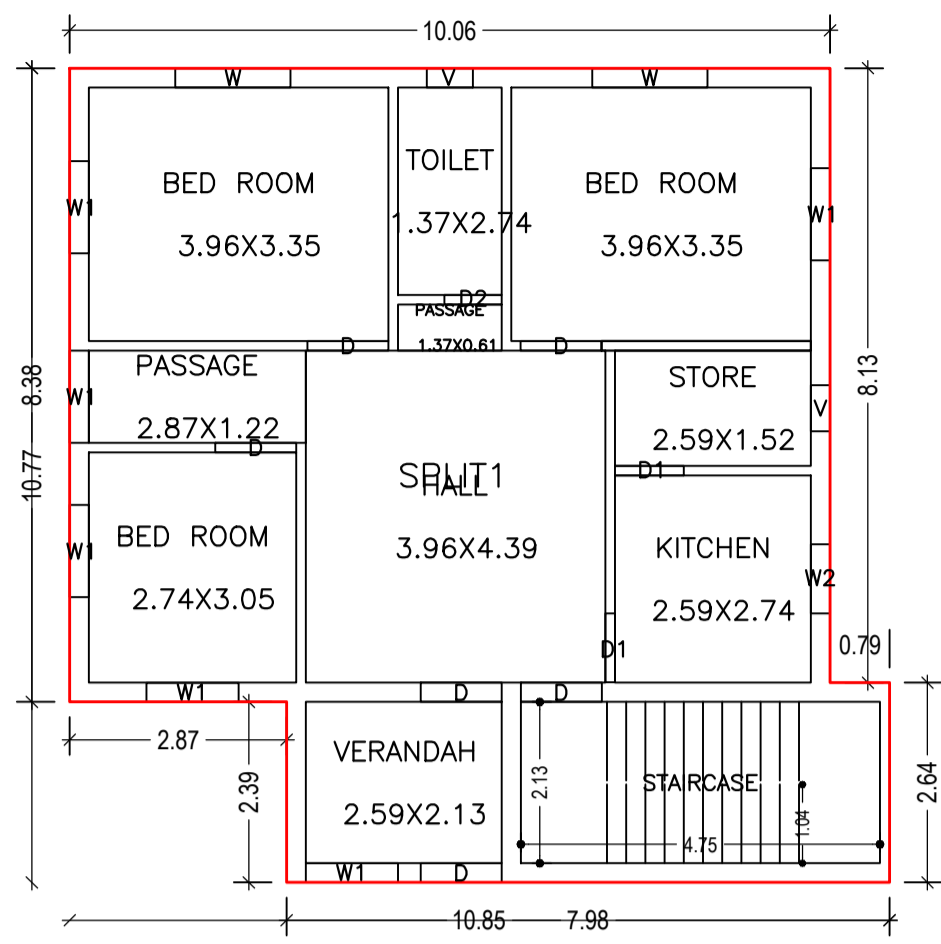

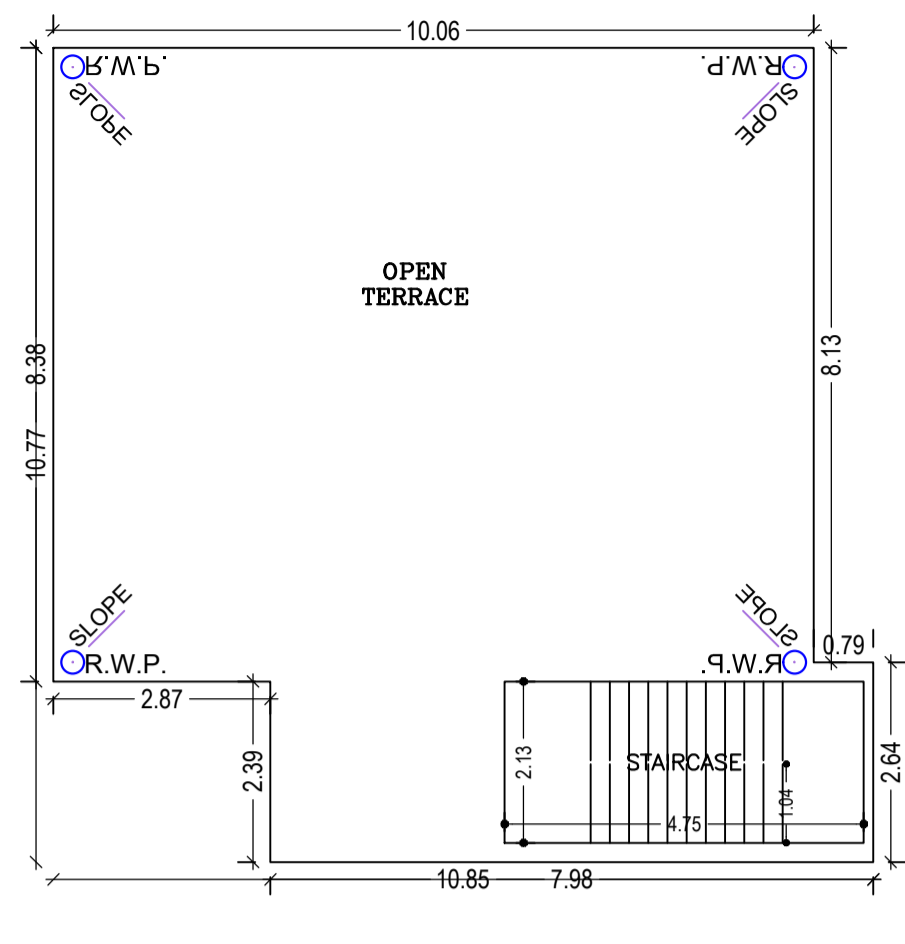

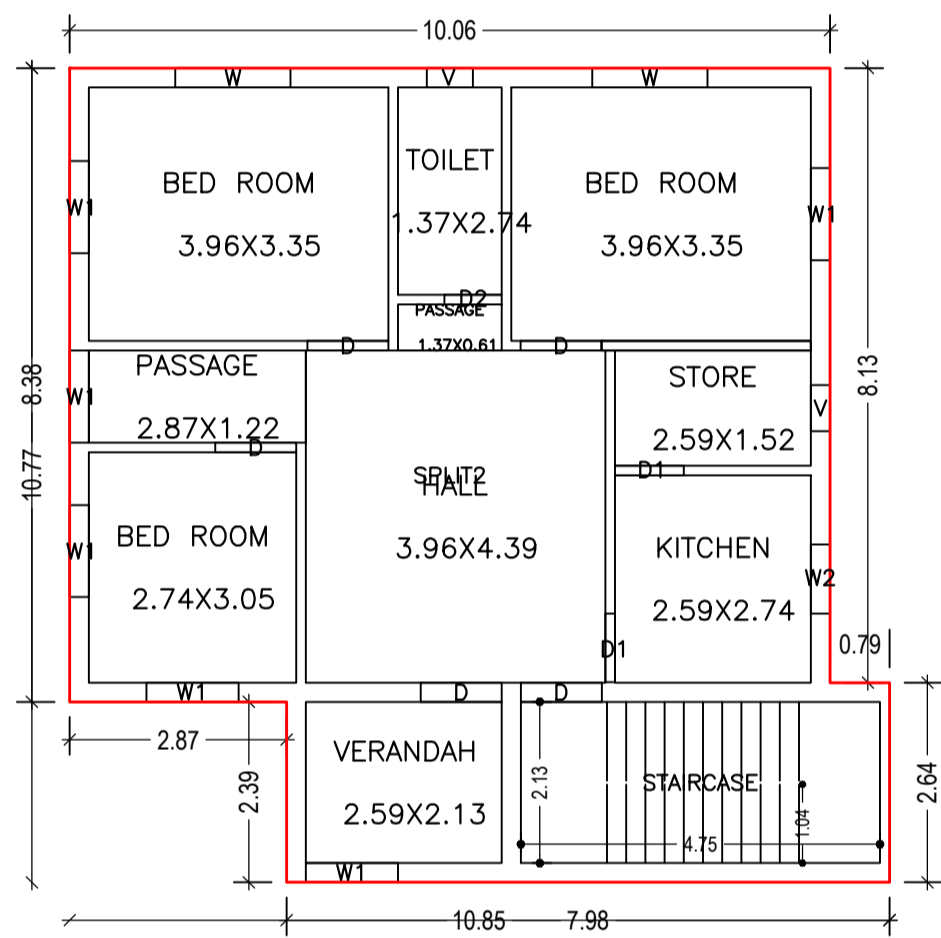

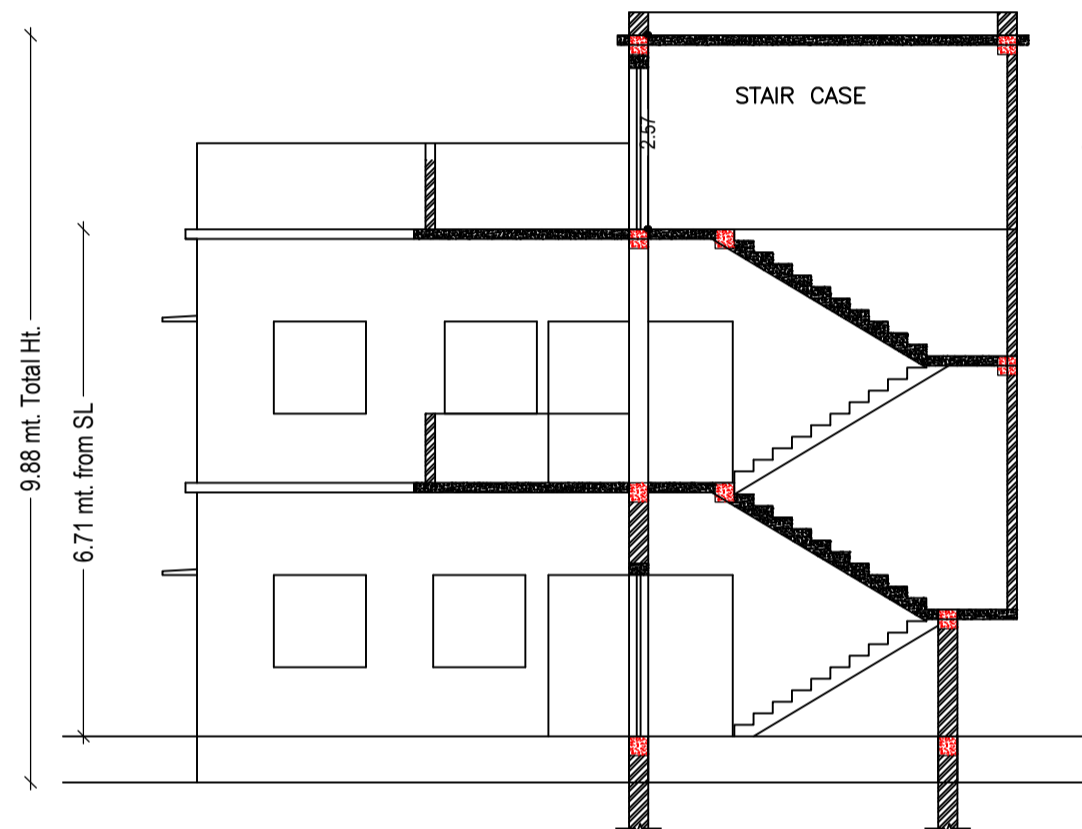
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



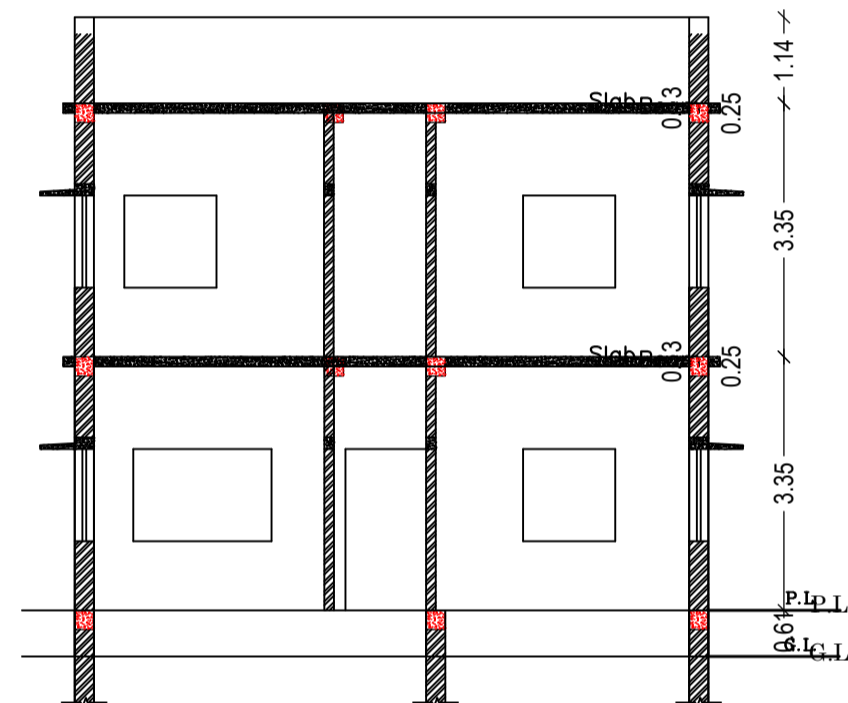
TERRACE FLOOR PLAN (SCALE 1:100)

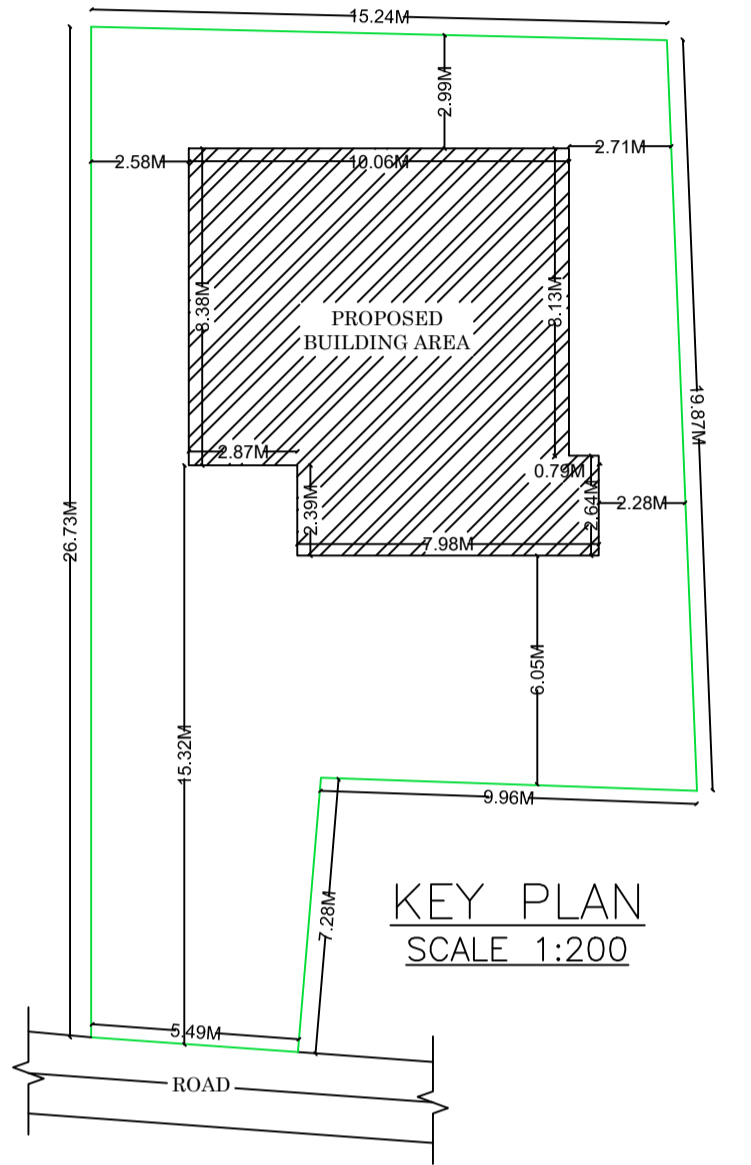

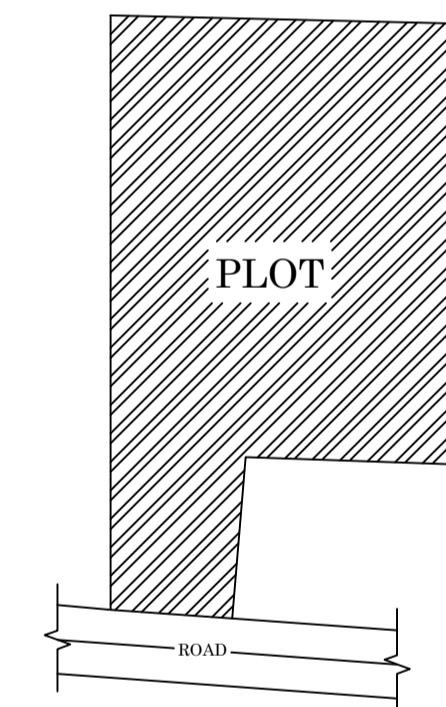

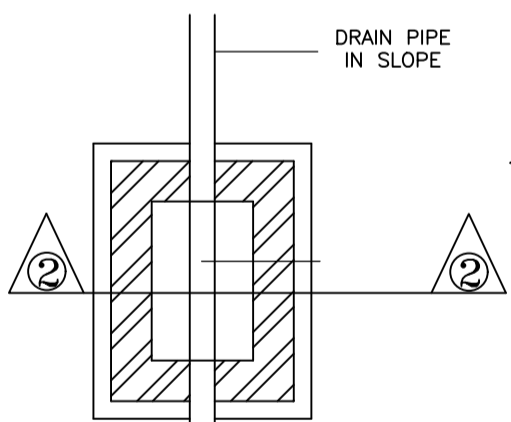
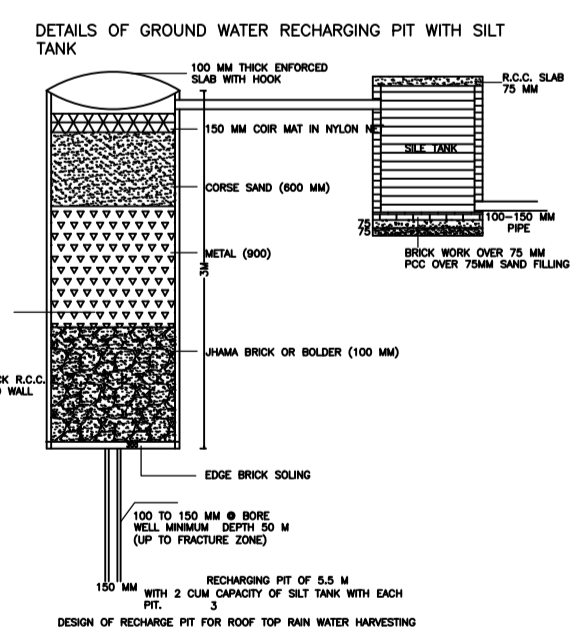
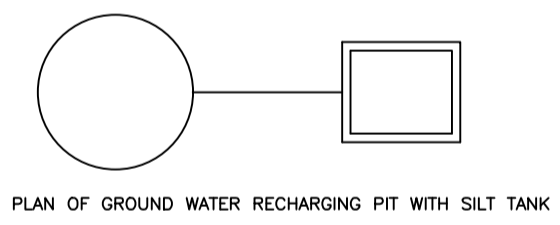
KEY PLAN SCALE 1:200

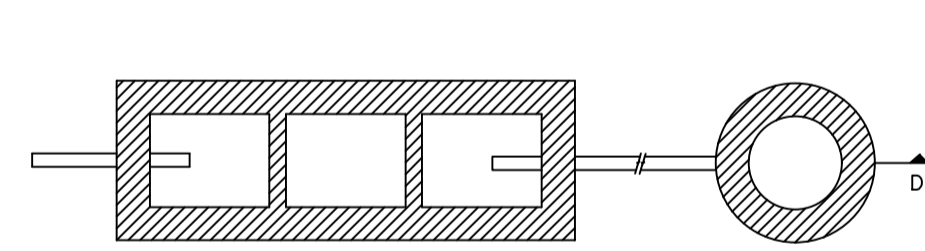


LOCATION PLAN NOT TO SCALE



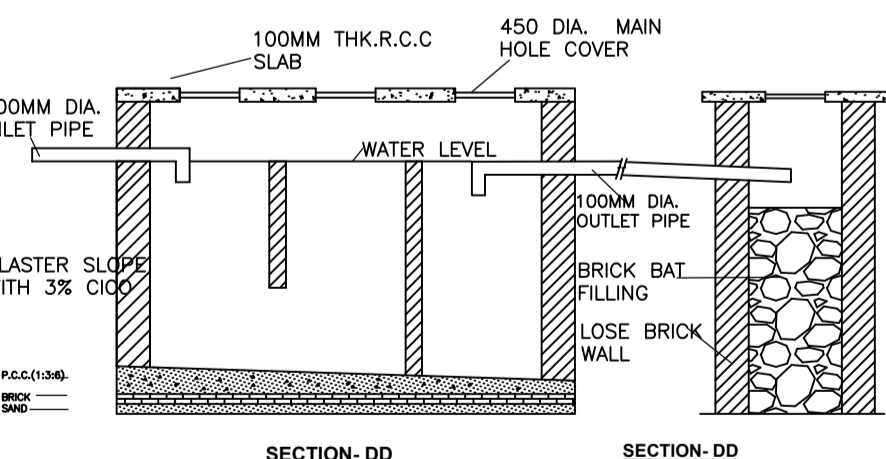
PLAN I.C.DETAILS R.C.C. COVER
