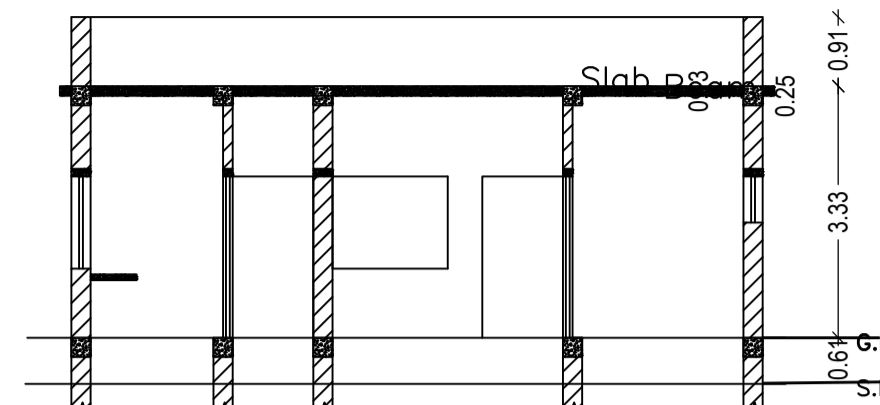
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



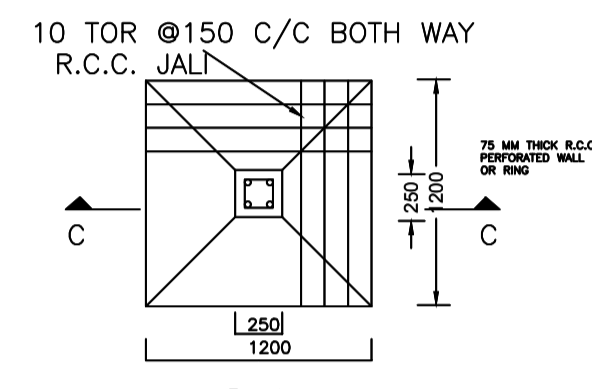
TERRACE FLOOR PLAN (SCALE 1:100)



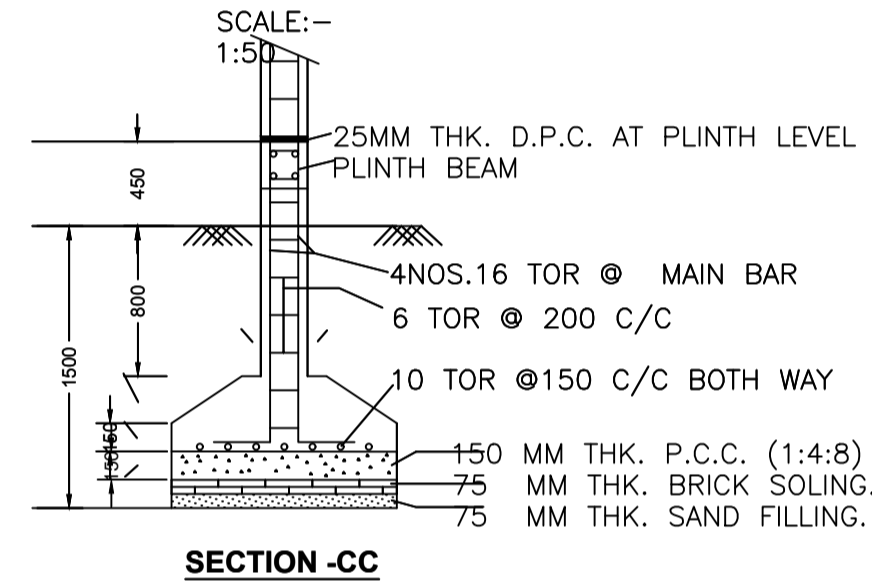

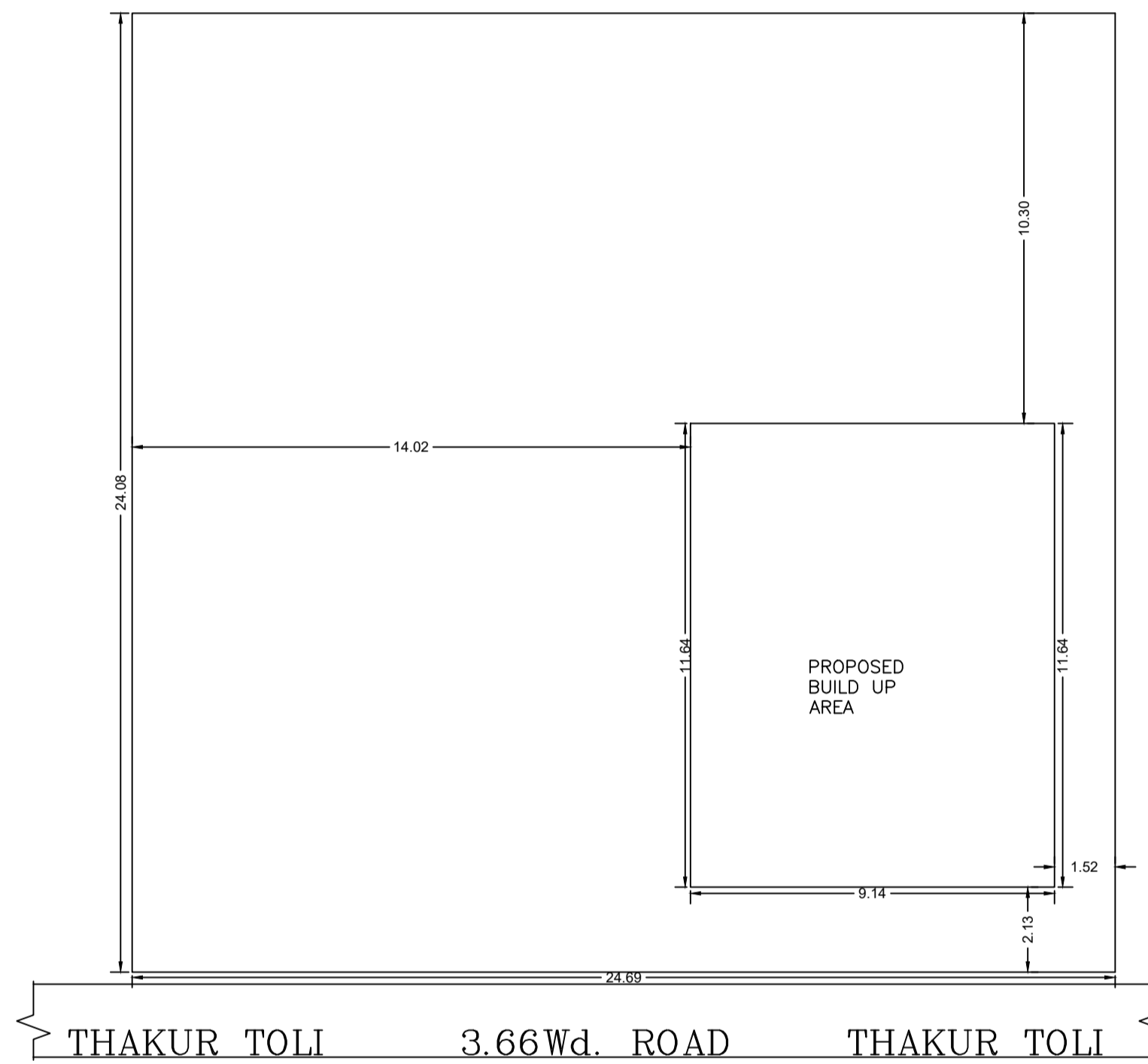

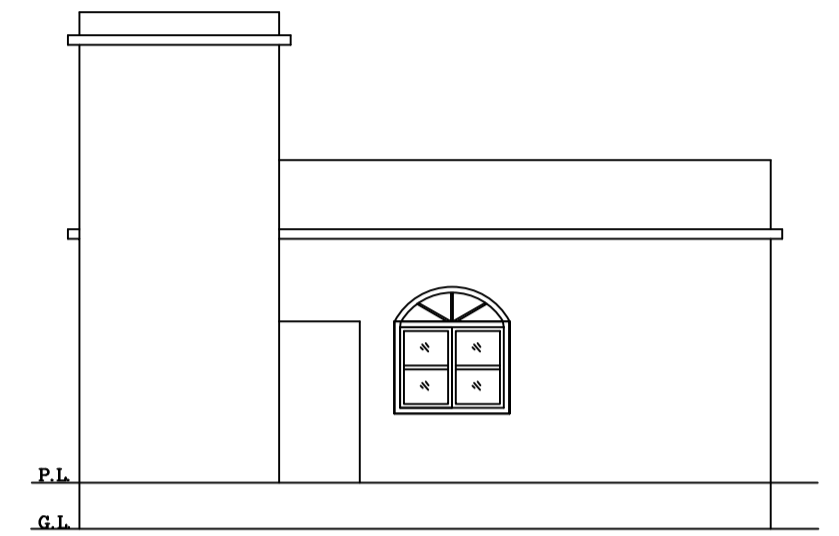
PLAN DETAIL OF FOUNDATION SCALE:- 1:50



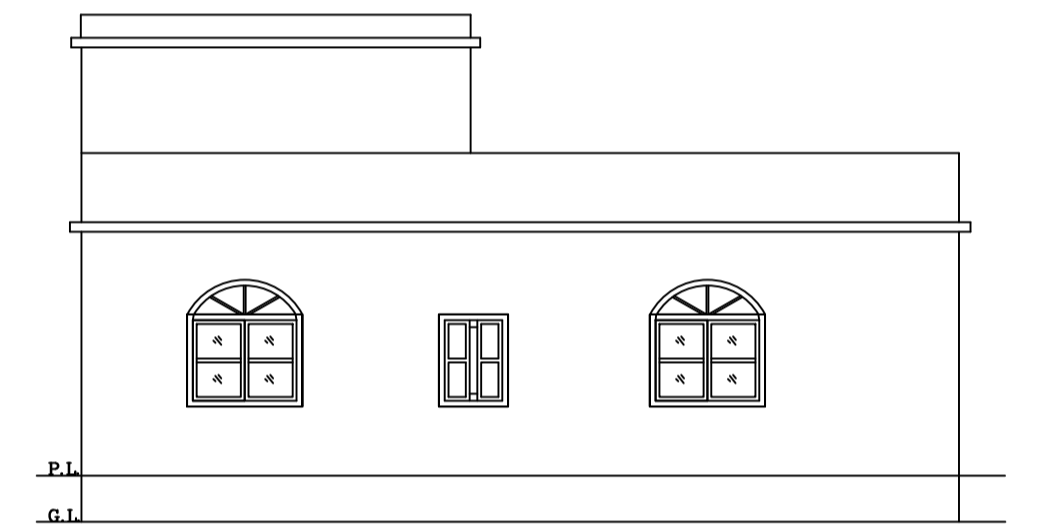

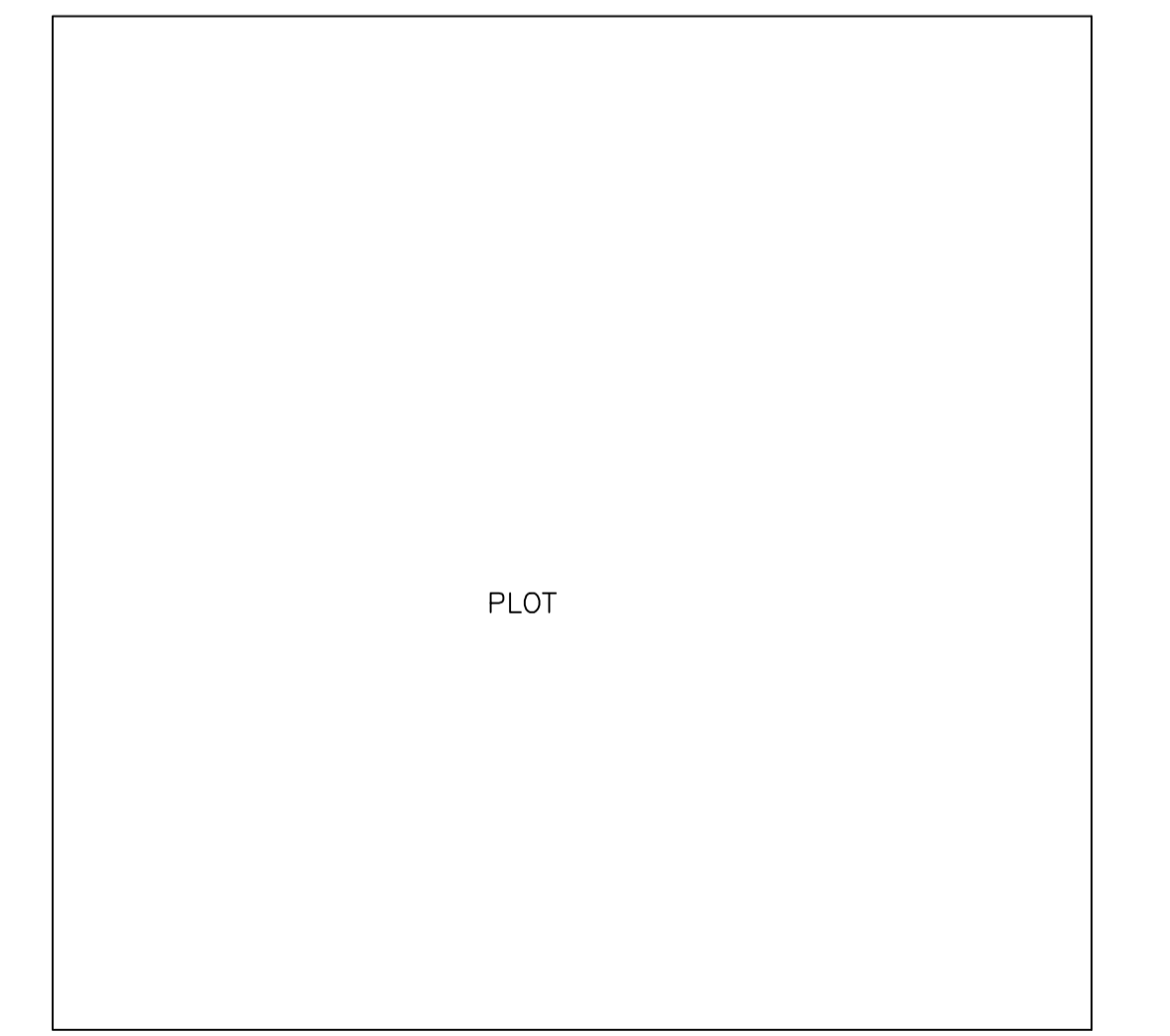
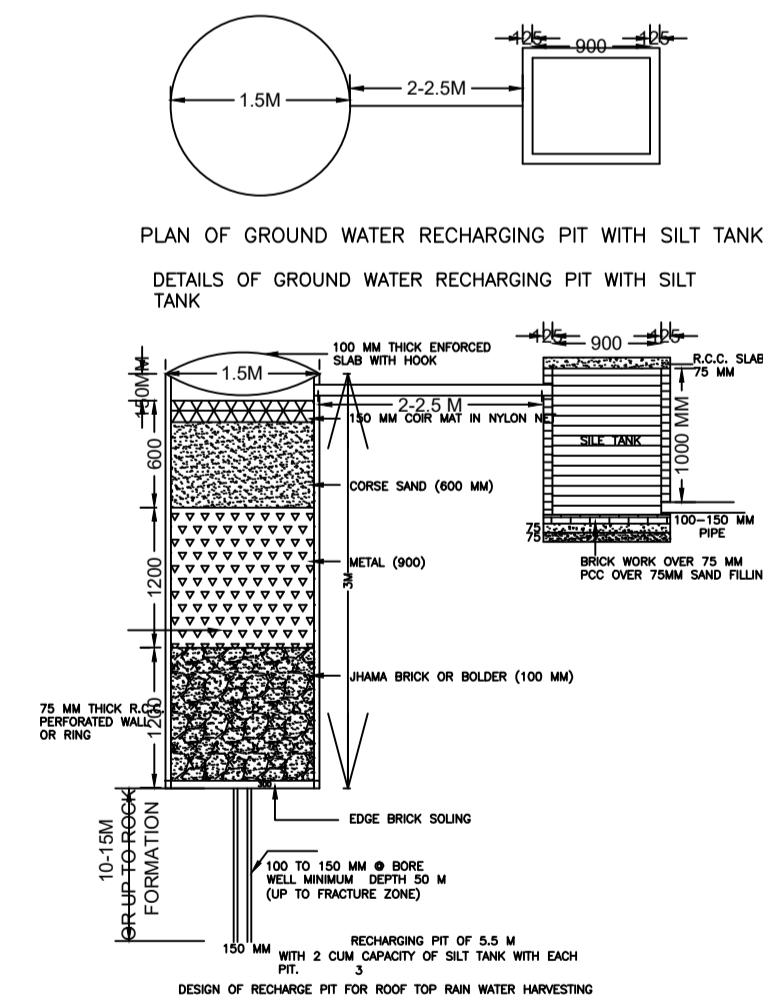
KEY PLAN SCALE 1:200

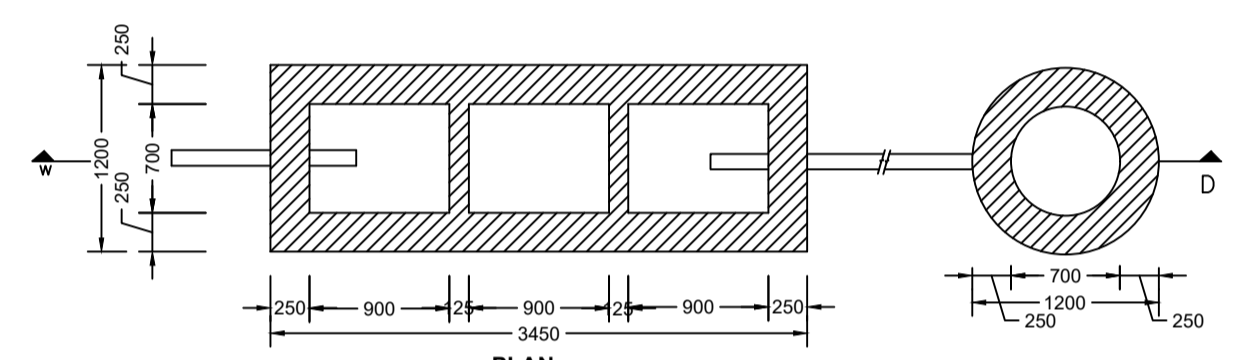
