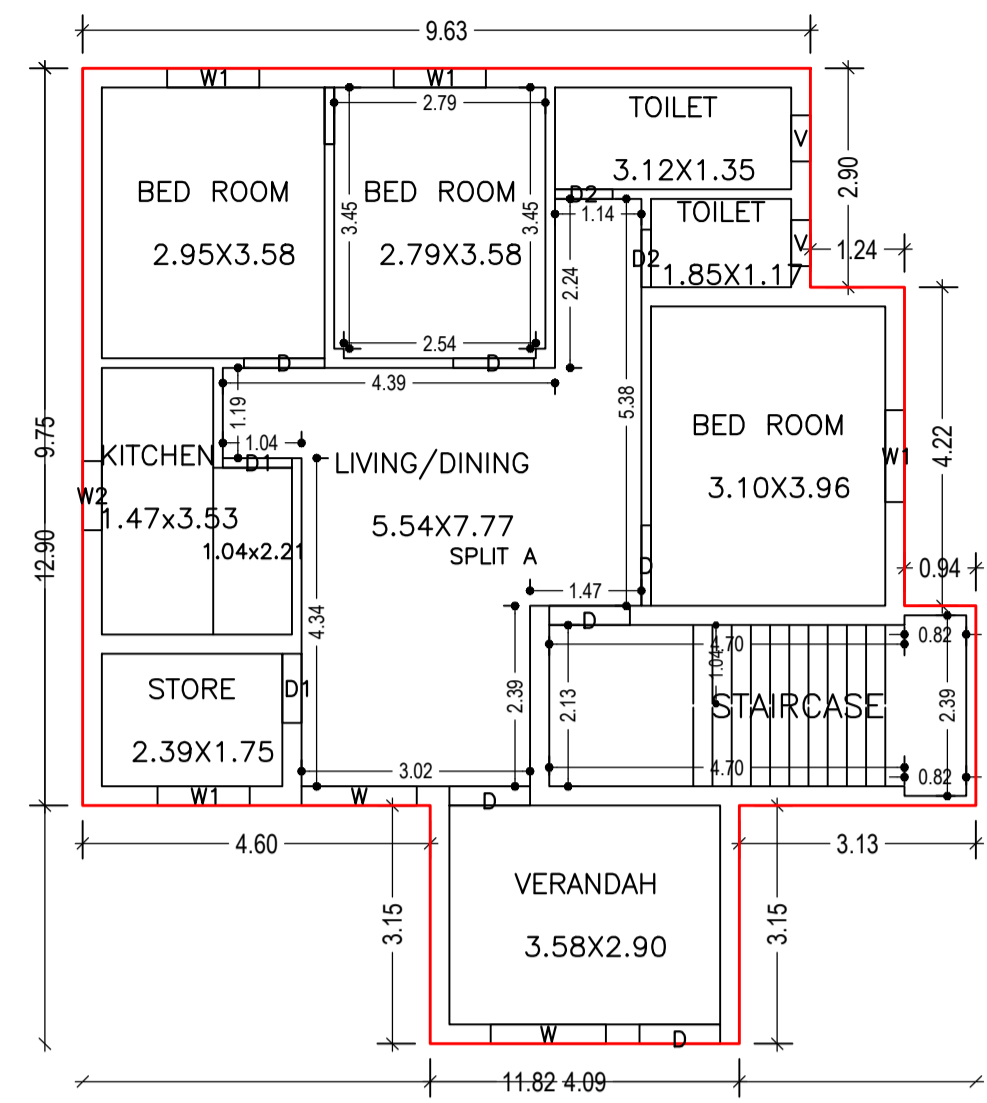

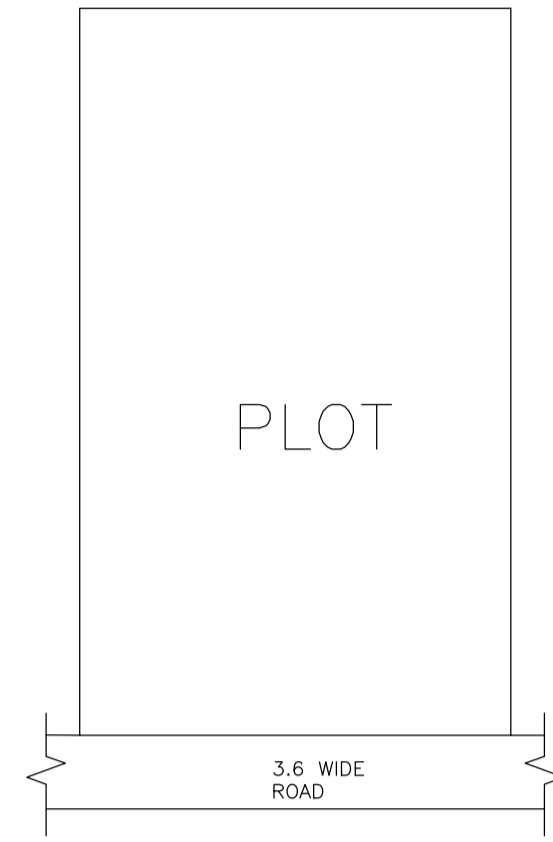

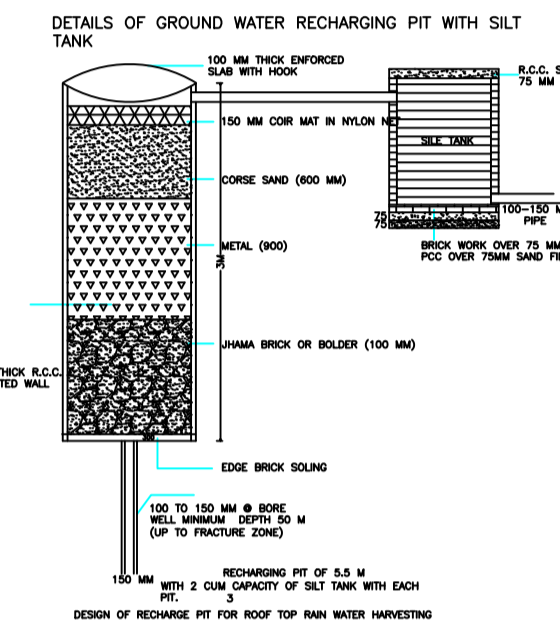
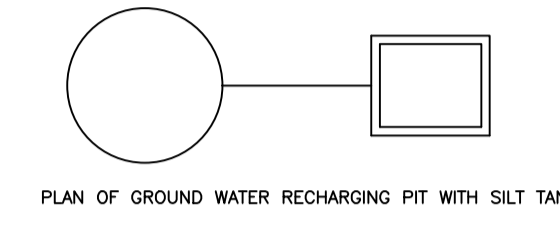
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



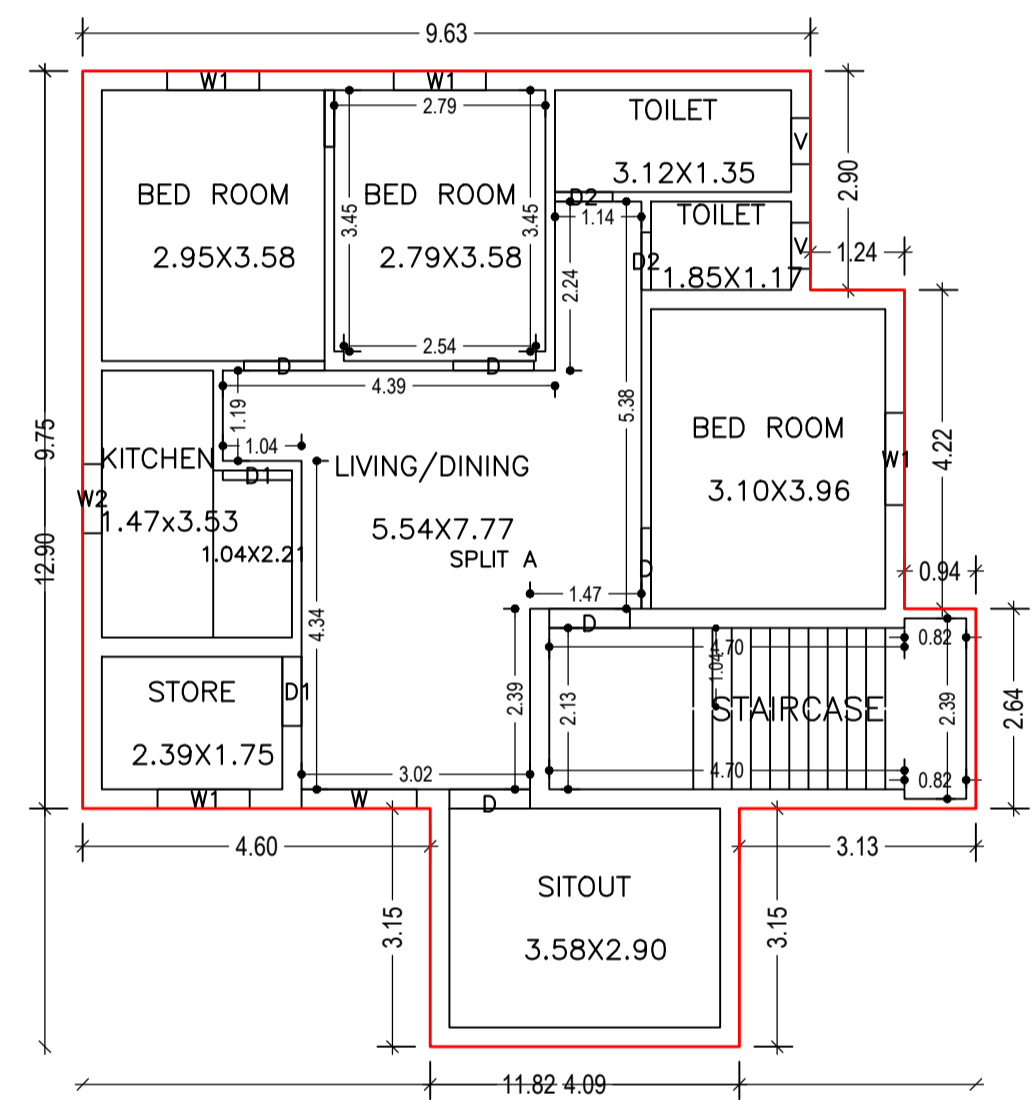
TERRACE FLOOR PLAN (SCALE 1:100)



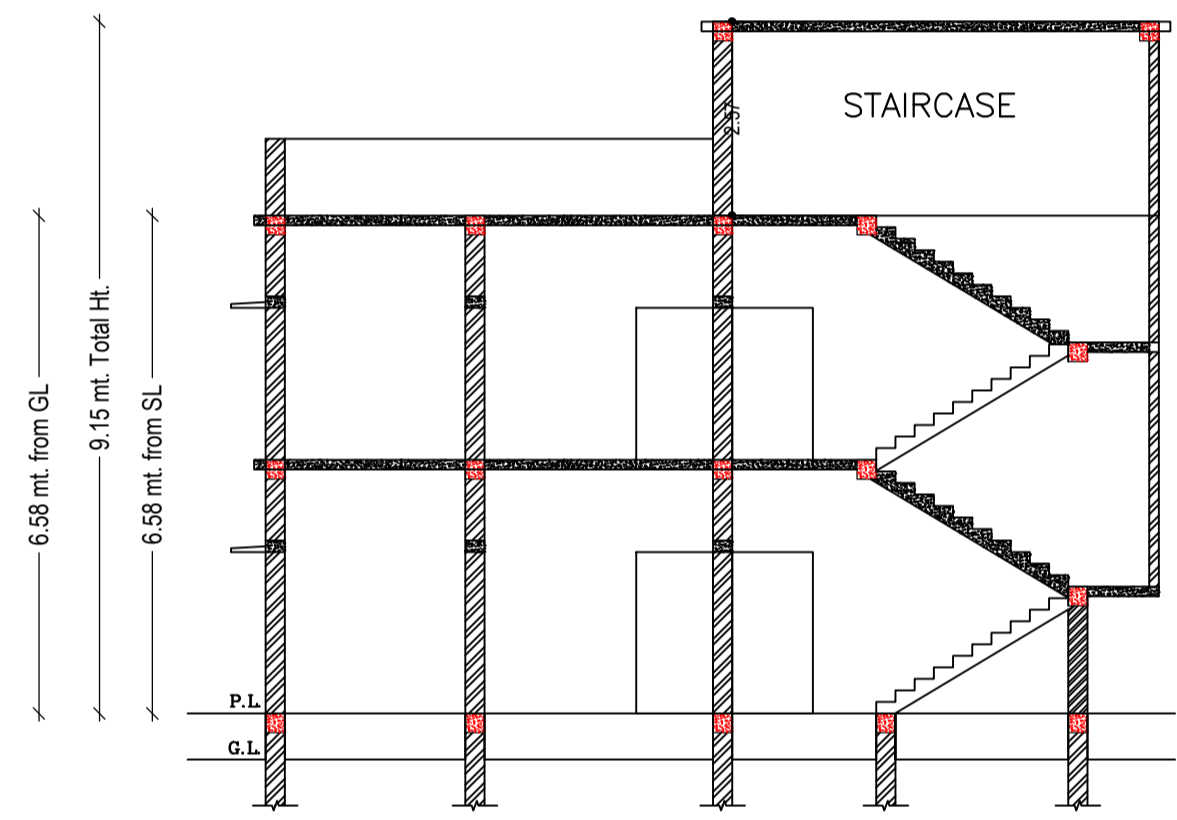
LOCATION PLAN NOT TO SCALE



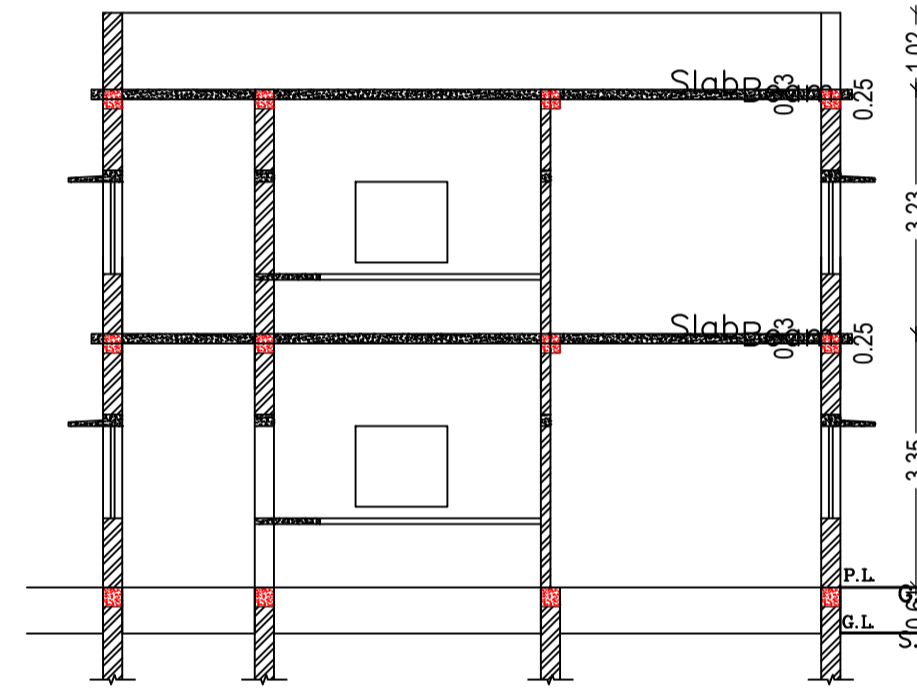

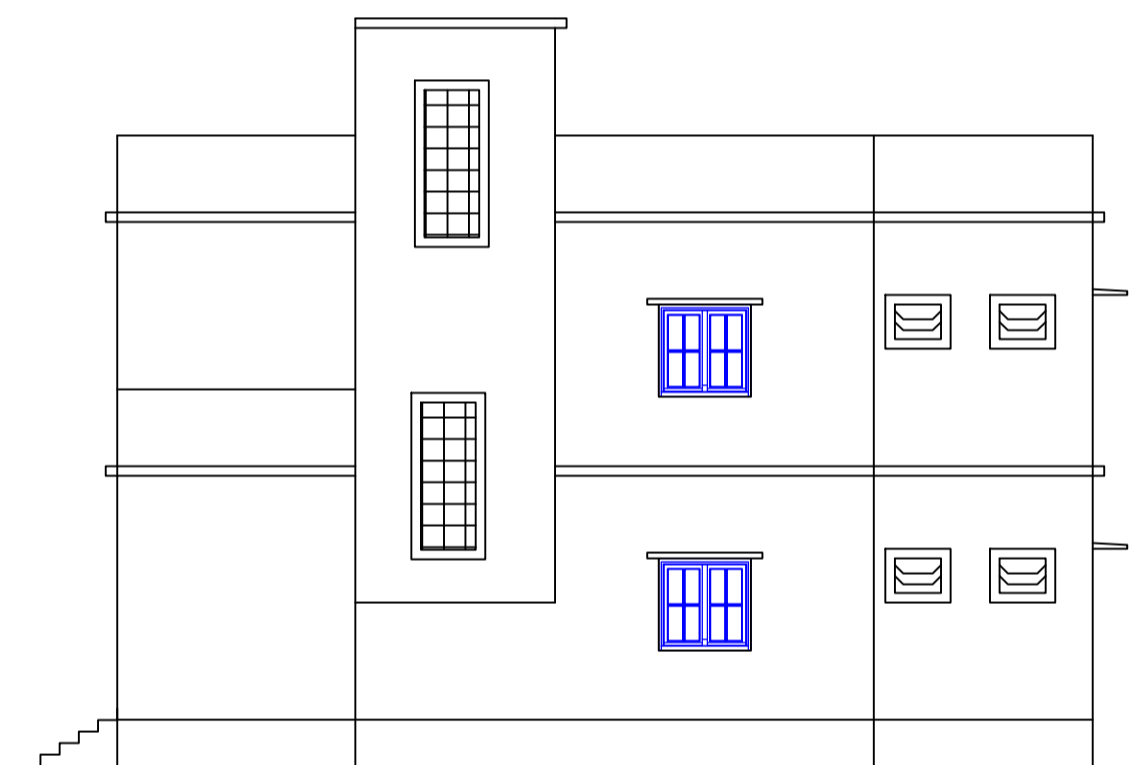
FIRST FLOOR PLAN (Proposed) (SCALE 1:100)

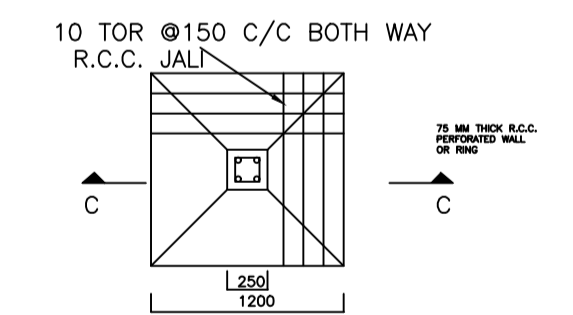
