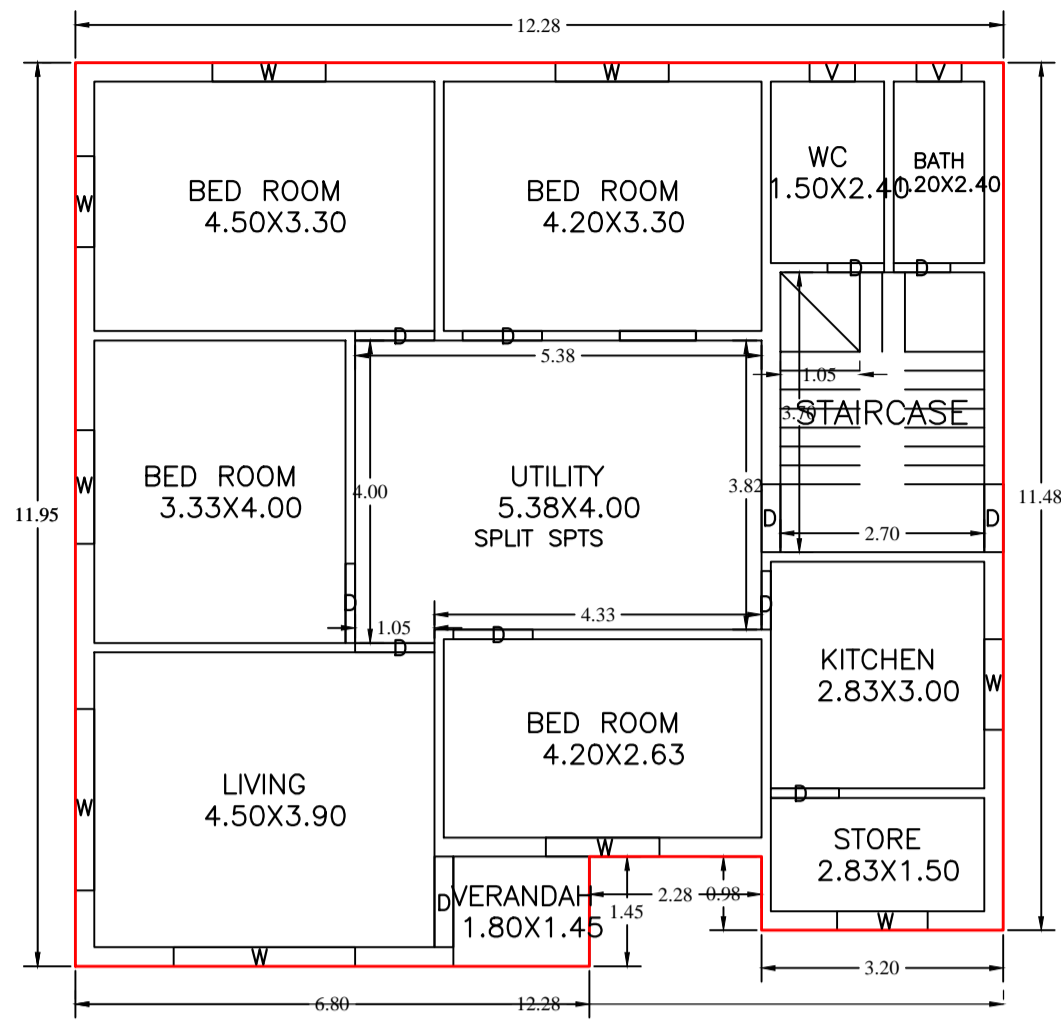

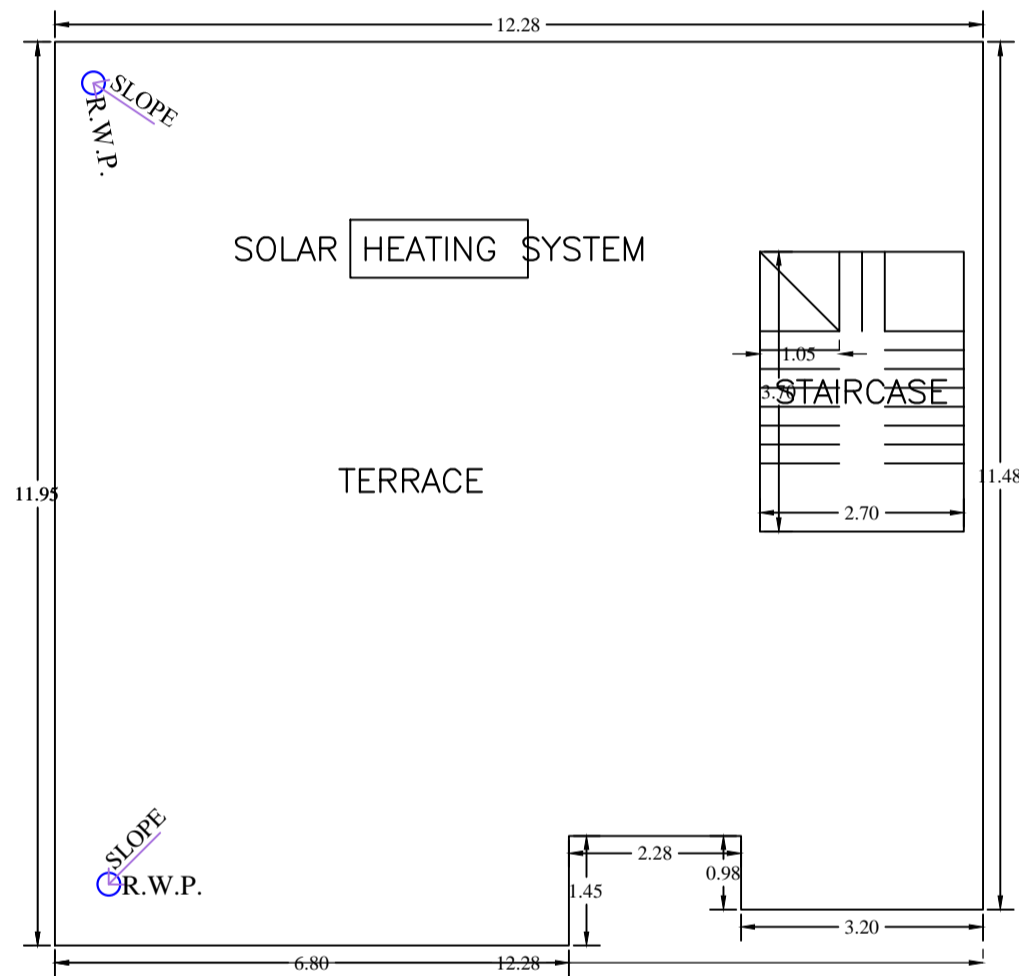

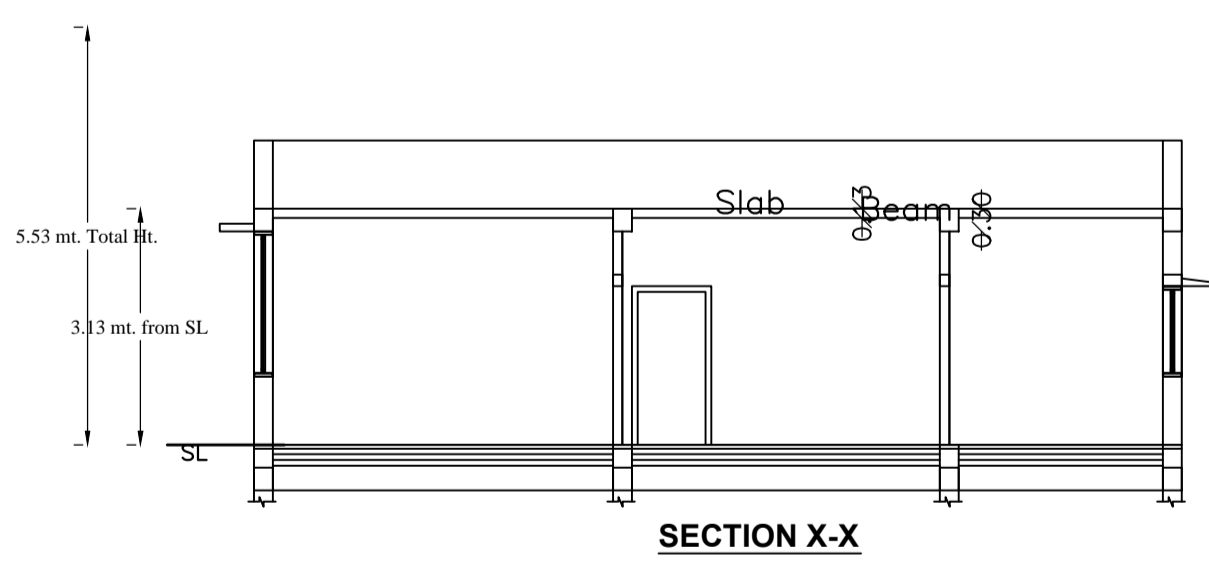

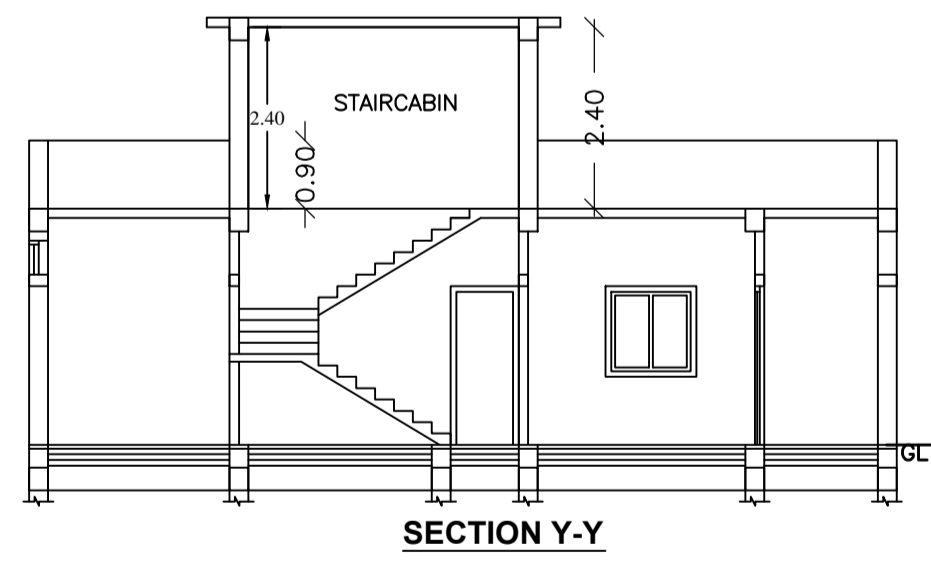
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)

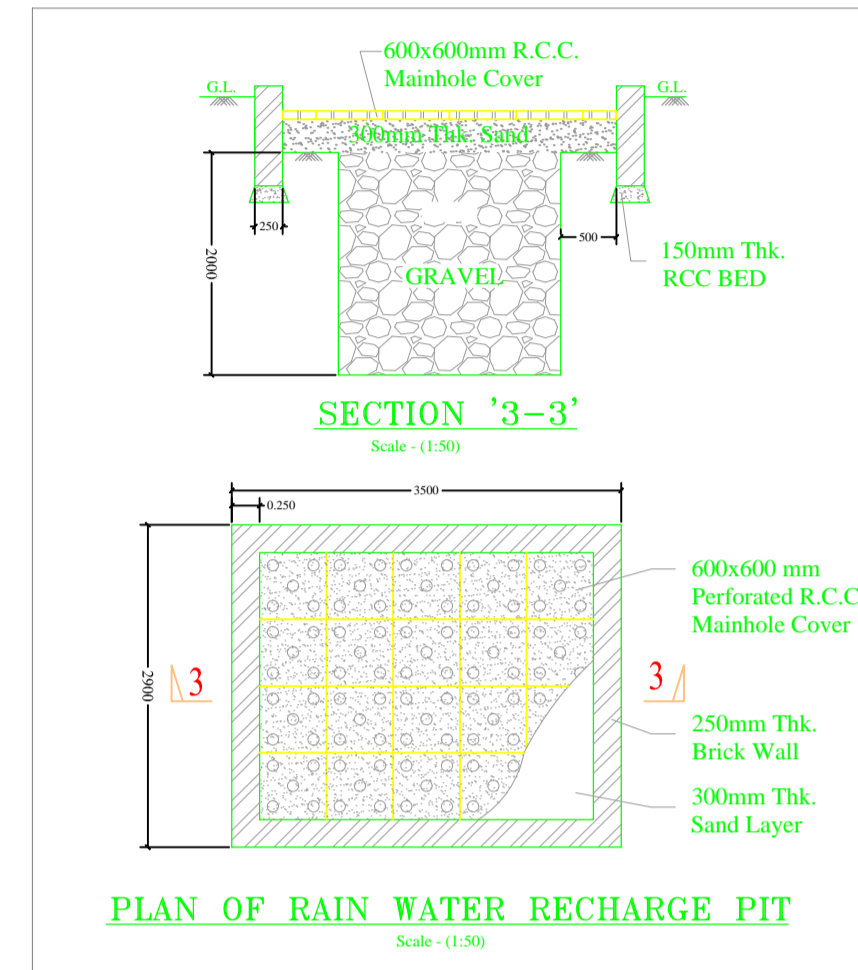

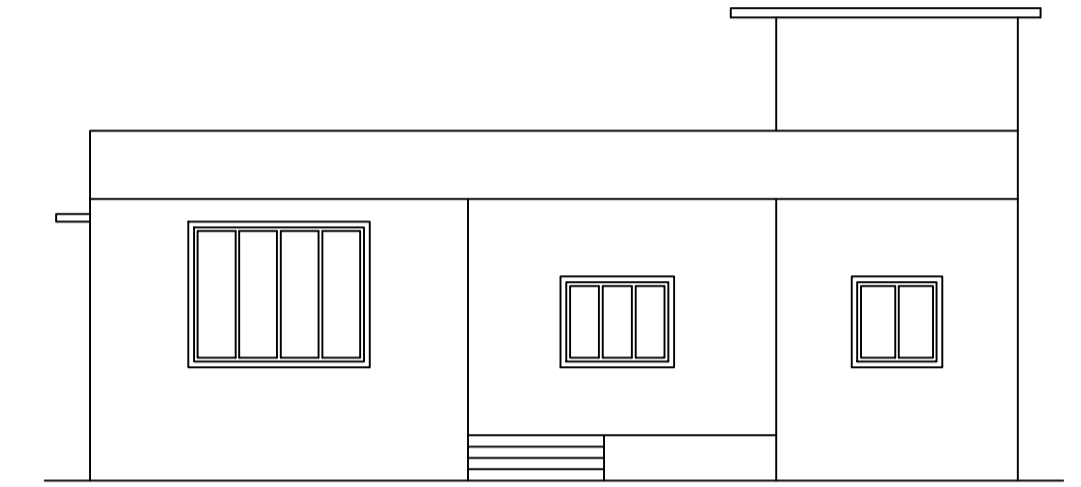

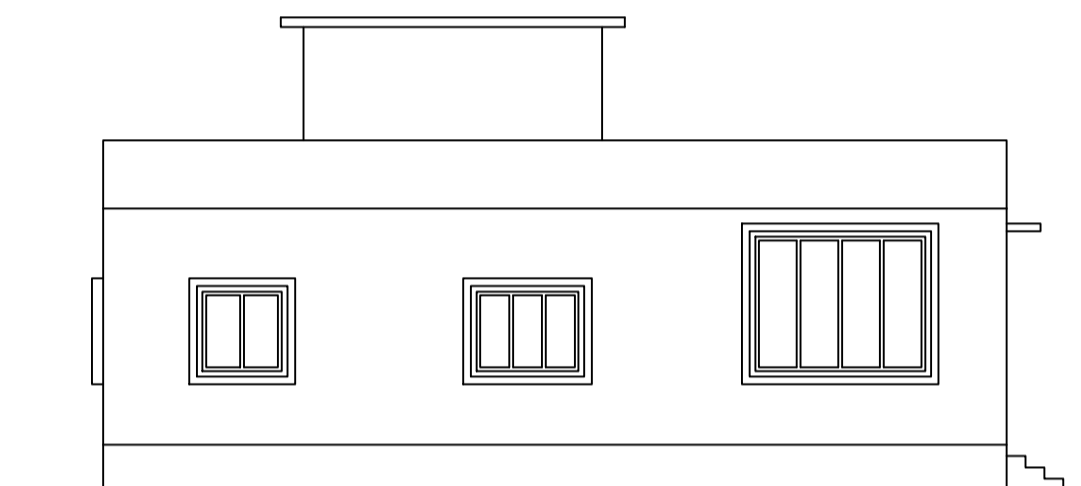
FOOTING PLAN & SECTION



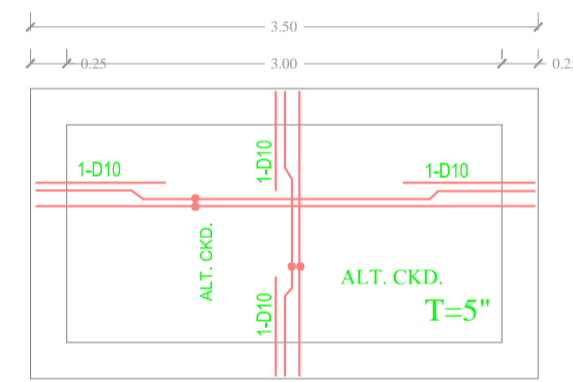
PLAN OF RAIN WATER RECHARGE PIT



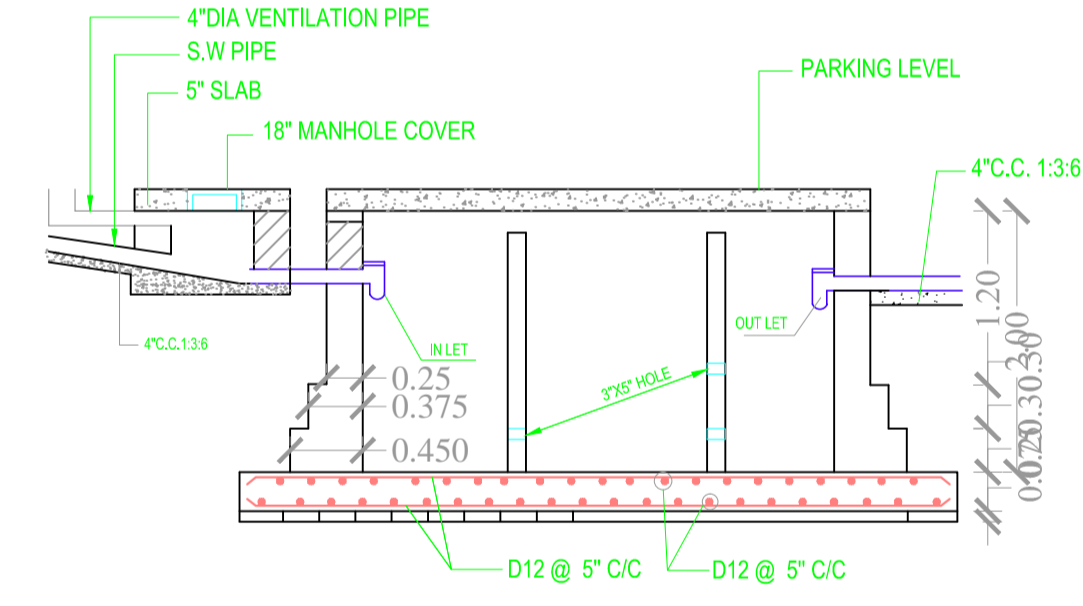
FRONT ELEVATION



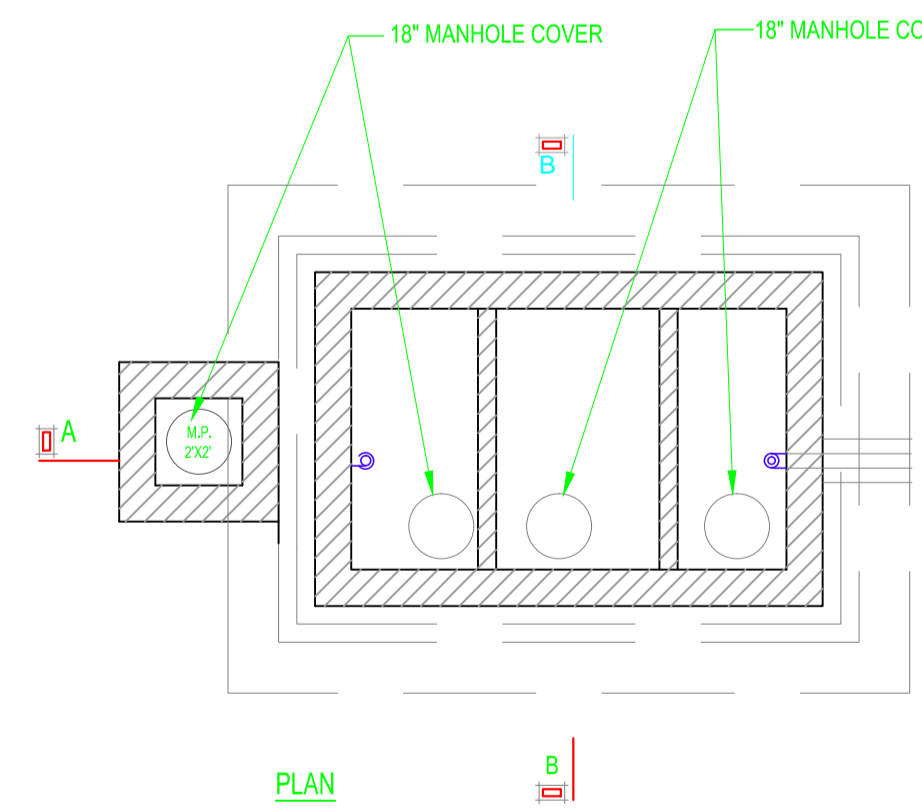
SIDE ELEVATION



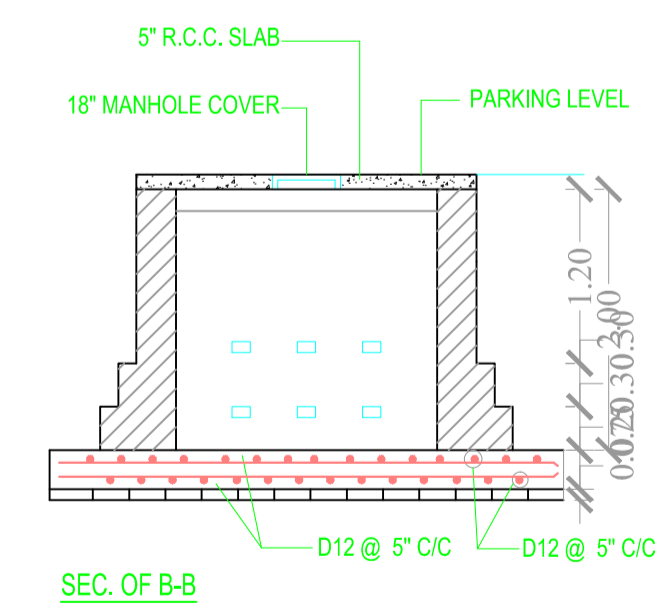
REINFORCEMENT DETAILS OF TOP SLAB FOR SEPTIC TANK

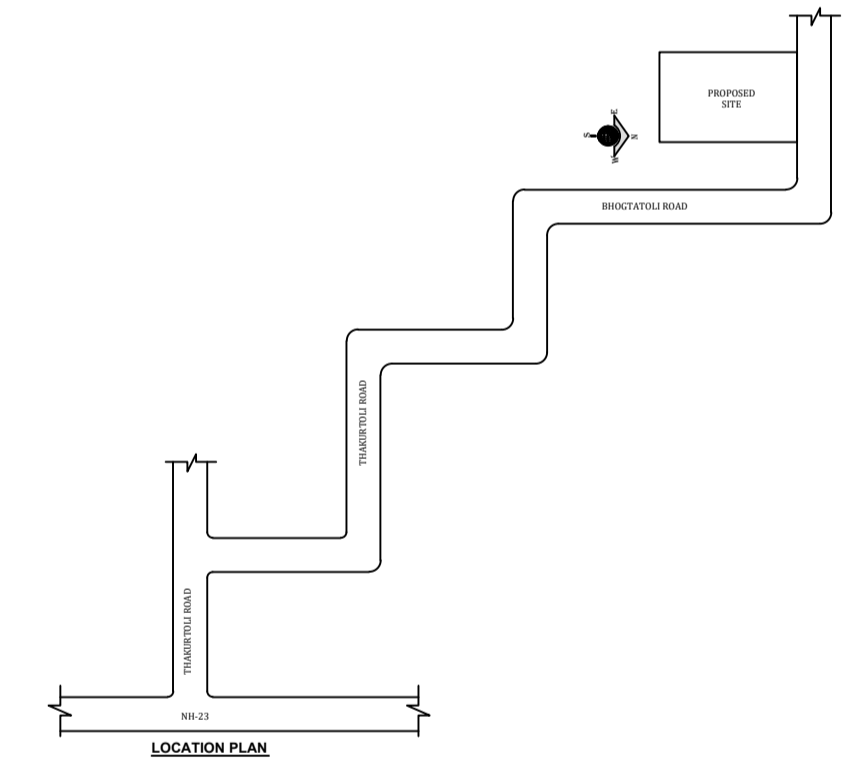
