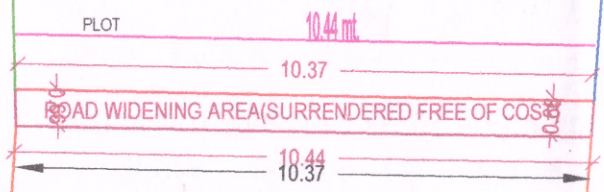
PROPOSED SITE
