recorded in my name.

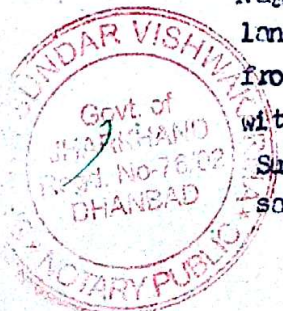
