called the DONOR of the ONE PART.

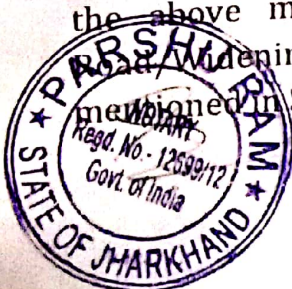

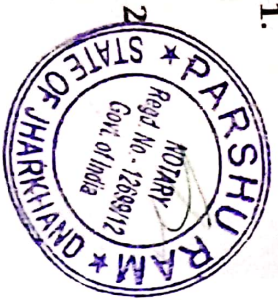
