3. for widening of road whenever it is necessary.

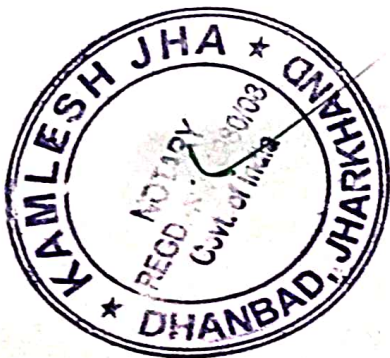

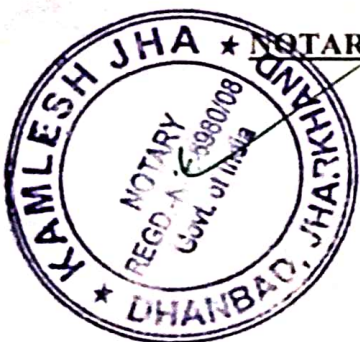
