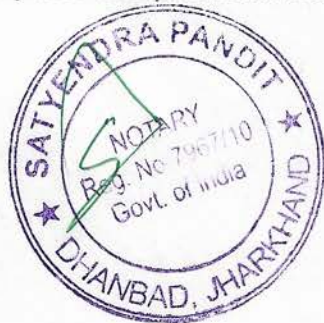

6. That I am sweating this certificate for needful and to submitted before the authority concerned of Dhanbad Municipal Corporation in support of our contents.

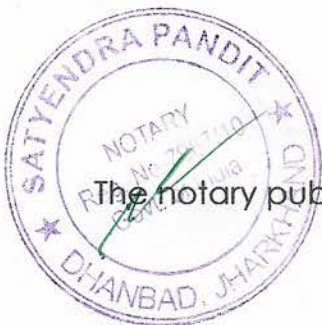
