I, Smt. Dauli Kumari, Wife of Chunnu Kumar, by faith-Hindu, resident of Pathlakulhi, Near Mandir, P.S.-Dhansar, Dist.-Dhanbad (Jharkhand), do hereby solemnly affirm and declare that the statements made herein below are true to the best of my knowledge and belief.

1. That, I am the owner of land having Mouza-Pathlakulhi, Mouza No.-46, New Khata No.-136, Old-204, New Plot No.-15, Old Plot No.-12, corresponding to holding No.-0290002818000MO, Ward No.-20 in the name of Authority-Dhanbad Municipal Corporation, measuring an Area 4042.85 Sq.ft. at Village-Pathlakulhi, Mouza No.-46, P.S.-Dhanbad, District-Dhanbad.
2. That, the land mentioned above is a tree hold property and does not belong to Khas Mahal, Estate of Government. It does not either Gair Mazaruwa, Khas (Aam), Kesharihind, District Board, Tribal land, forest land, BCCL land, C.N.T. Land or acquired land.
3. That, I have applied a Building Plan vide file No.-DMC/BP/0019/W29/2020 to Dhanbad Municipal Corporation for sanction of plan for construction of Residential Building.
4. That, as per Building Bye-laws 2016 and (Vth Amendment) Notification 2019, Clause No.-37 and Sub-clauses No.-39.7 for sanction of plan in my case Dhanbad Nagar Nigam needed 0.27m wide Road in front of land of land owner (Donor) but the present Road width in front of my land is only 3.04m so far widening of the road width as per (Vth Amendment), we are ready to donate/surrenders the effected portion of land only or to say 5.31 sq.mtr. out of total land purchase.

5. That, I donate/surrender the land 5.31 sq.mtr. only in favour of the Dhanbad Municipal Corporation for widening of Road without any claim of compensation of through a TOR scheme implemented by the Govt.
6. That, the donated/surrender land by this Affidavit being butted and bounded as :-
 - North :- 3.047 + 0.27 = 3.31m wide Road.
 - South :- Owner's land.
 - East :- 2.43m wide Road.
 - West :- Kashinath Kushwaha.
7. That, I am swearing this affidavit for needful and to submit it before the authority concerned or Dhanbad Municipal Corporation in support of the above contents.
