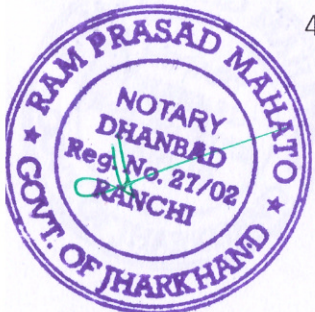
## Before the Notary Public, Dhanbad

### Affidavit

Ashram, P.S Saraidhela, Dhanbad, District Dhanbad (Jharkhand) do hereby solemnly affirm and declare as follows :-

1. That my father Sri Bhim Sai @ Bhim Singh being the Guardian purchased some landed property in my name in the year 1966 when I was minor at Mouza Kolakusma, Mouza No. 12 Khata No. 30 by virtue of Regd. Sale Deed No. 1905 dated 14.02.1966 from its rightful owners Renghu Mahto son of Late Hari Ram Mahto and Balram Mahto, Matiram Mahto both sons of Late sufal Mahto and Gomati Khemia Mahtain wife of Late Sufal Mahto of village Kolakusma, P.O- K.G. Ashram, P.S. Saraidhela District Dhanbad and came in actual physical possession of the purchased land.
2. That the aforesaid property although purchased in my name but the same were always treated as joint family property.
3. That my father Bhim Sai @ Bhim Singh while thus in possession died leaving behind his three sons including myself namely Sri Shankar Prasad Singh, Bharat Prasad Singh and Raj Kumar Singh who jointly inherited the aforesaid land left behind by our father.
4. That I alongwith my brothers Bharat Prasad Singh and Raj Kumar Singh got their name mutated in the Government Sherista vide Mutation Case No. 975 (II)/2015-2016 and paid rent to the State Government under Jamabandi No. 6079 of the Mouza and rent is paid upto date.

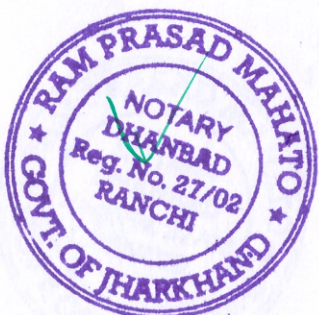


5. That **Shankar Prasad Singh and Shankar Prasad Sai** is the name of one and same person and he is commonly known by both name in the locality.
