1. That in consideration of the sanction of the plans by NA Authority for construction of the basement the executant undertakes that he/she shall at all times keep.....

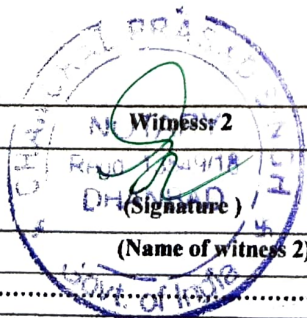
