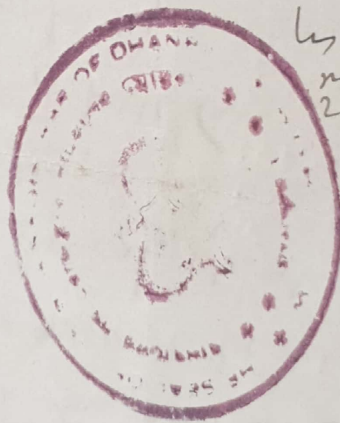
Mathematics

The first part of the question is to find the area of the shaded region. The figure shows a square with side length 10 cm. Inside the square, there is a smaller square with side length 6 cm. The shaded region is the area of the larger square minus the area of the smaller square.

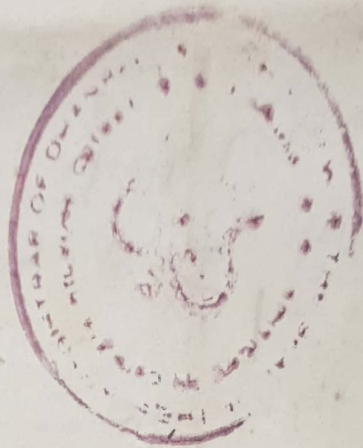
Area of the larger square = $10 \times 10 = 100$ cm²
 Area of the smaller square = $6 \times 6 = 36$ cm²
 Area of the shaded region = $100 - 36 = 64$ cm²

The second part of the question is to find the perimeter of the shaded region. The shaded region is a square with side length 4 cm. The perimeter of a square is given by $4 \times \text{side length}$.

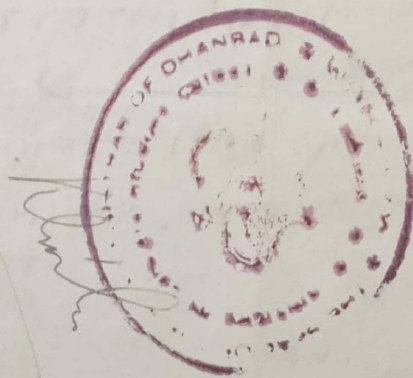
Perimeter of the shaded region = $4 \times 4 = 16$ cm

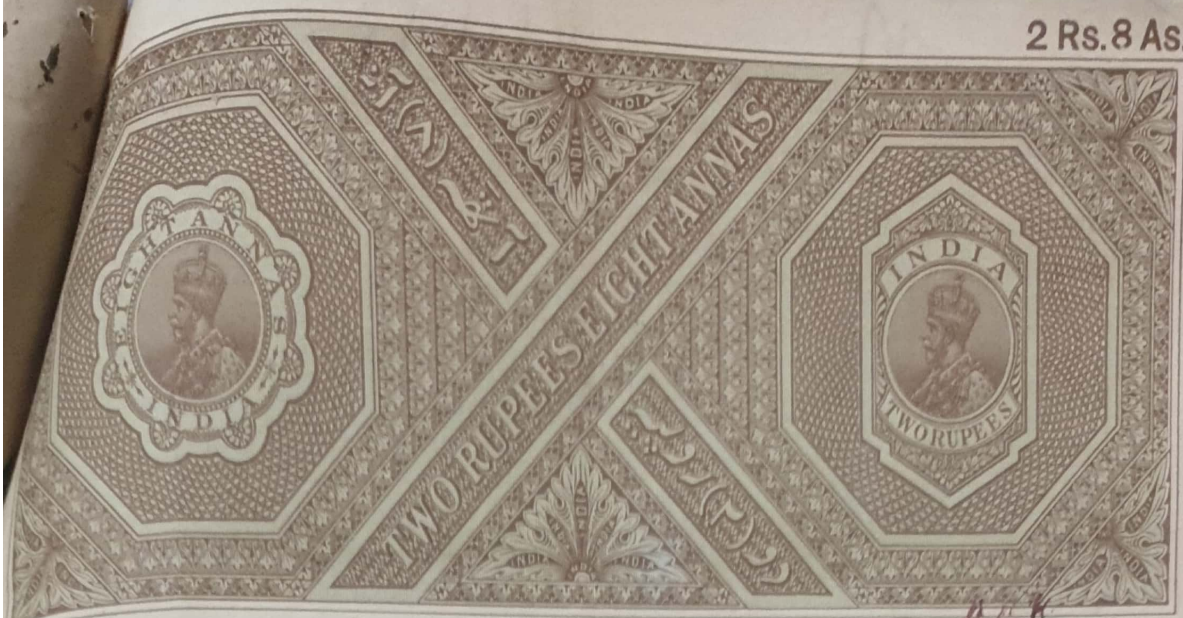

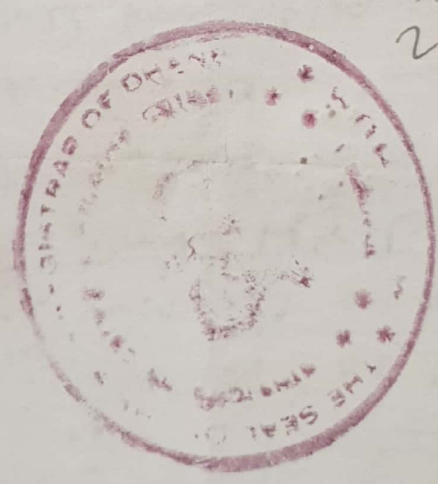

 6. That, now presently the family detail of my maternal grand father Abdul Rahman is as follows :-




