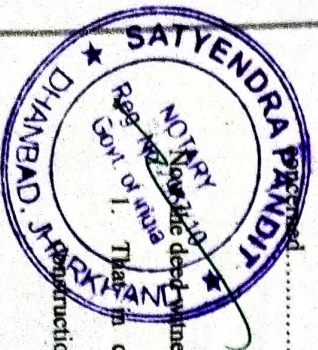

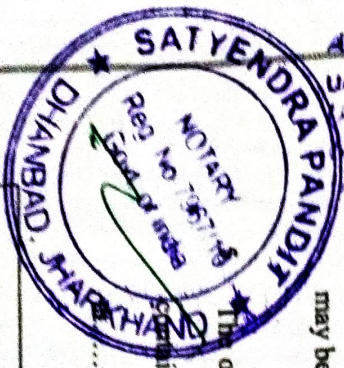

 D.M.C. Dhambad Authority.

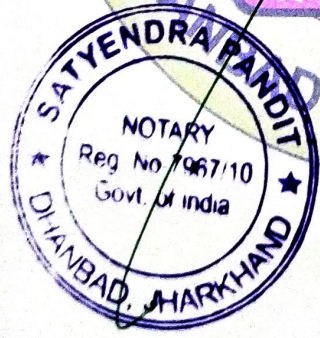
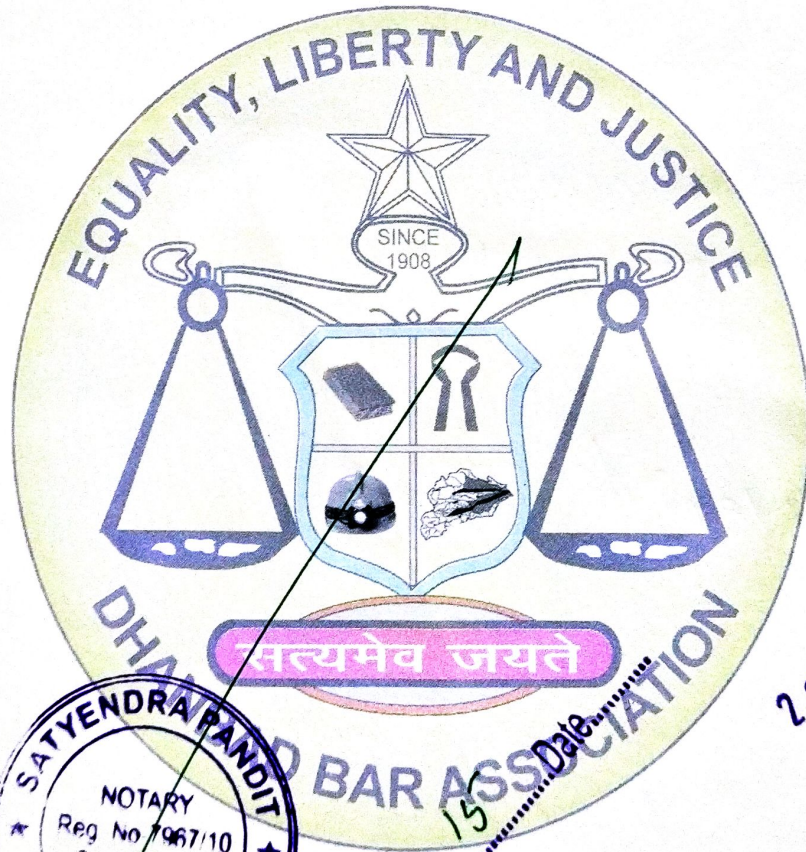
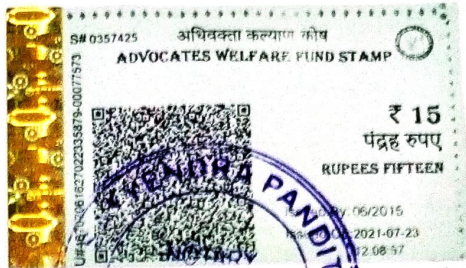
