

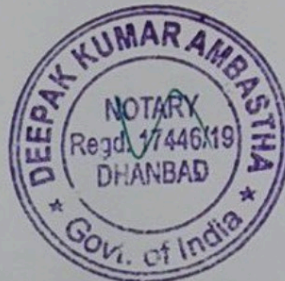

6. That, in case of any deviation comes out during construction only & only We shall be responsible for this deviation. We shall by the decision of the competent authority.

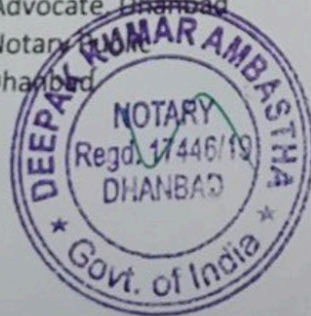
