The indemnity Bond is executed by Shri/ Smt. Sarad Mishra Mishra in favour of D.M.C. Authority.

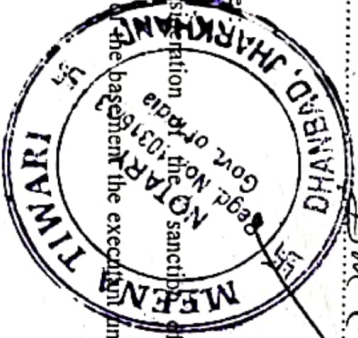
Whereas the Executant has submitted to the concerned Authority the plans for sanction of basement over Plot No(CS) 303, 310 (near 291) Plot No(MSP) --- khata No. 101 (near 102) Holding No. 052 000000 2000 MO.

Village/ Mohalla Dhanbad of --- Municipal Corporation /Municipal Council /Nagar Panchayats/Municipality/Notified Area

Committee/Regional Development Authority/Industrial Area Development Authorities/Mineral Area Development Authority, Gram Panchayat are covered under development plan or planning scheme notified under Jharkhand Municipal Act 2011, Jharkhand Regional Development Authority Act 2002, Mineral Area Development Authority Act Jharkhand Industrial Area Development Authority Act within the development plan area. D.M.C. And whereas the executant has agreed to execute an indemnity bond to the above affect and also to abide by the terms imposed by the concerned D.M.C. Authority the grant of sanction for construction of the basement.

1. That in construction of the plans by D.M.C. Authority for construction of the basement the executant undertakes that he/she shall at all times keep D.M.C.



Authority free from any liability, loss or damages/ flowing from any injury or damage caused to the adjoining built up properties or to any person as a consequence of the construction of at the time of digging of its foundations or during the course of its construction or at any time thereafter.

The owner agreed and undertakes that in the event of any claim being made by any person or persons against the concerned Authority either in respect of the sanction granted by the concerned Authority to the owner for the construction of basement or in respect of the construction or manner of construction of the basement by the owner of the consequences flowing from the said sanction the executant shall be responsible and liable and not .....


