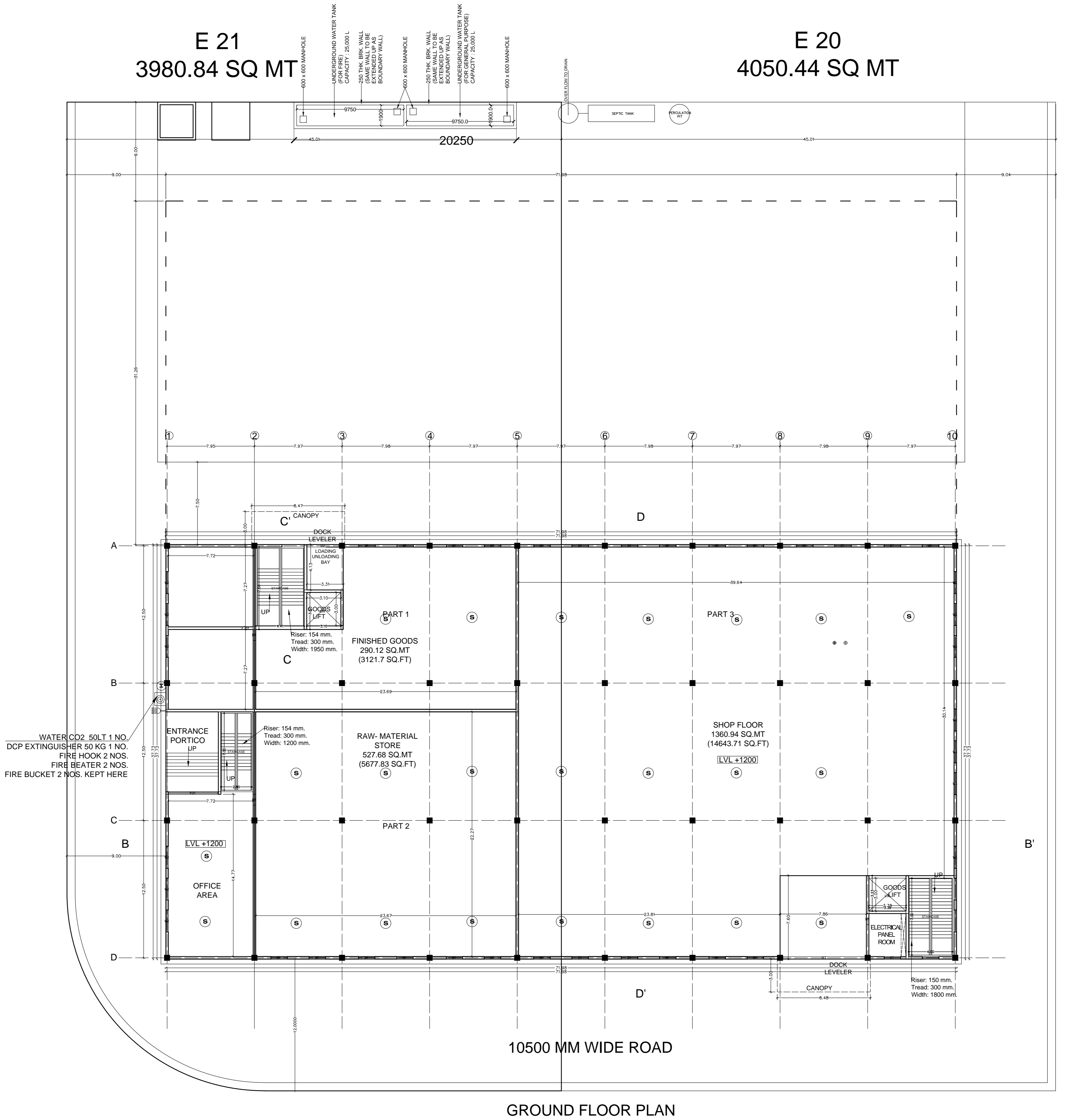


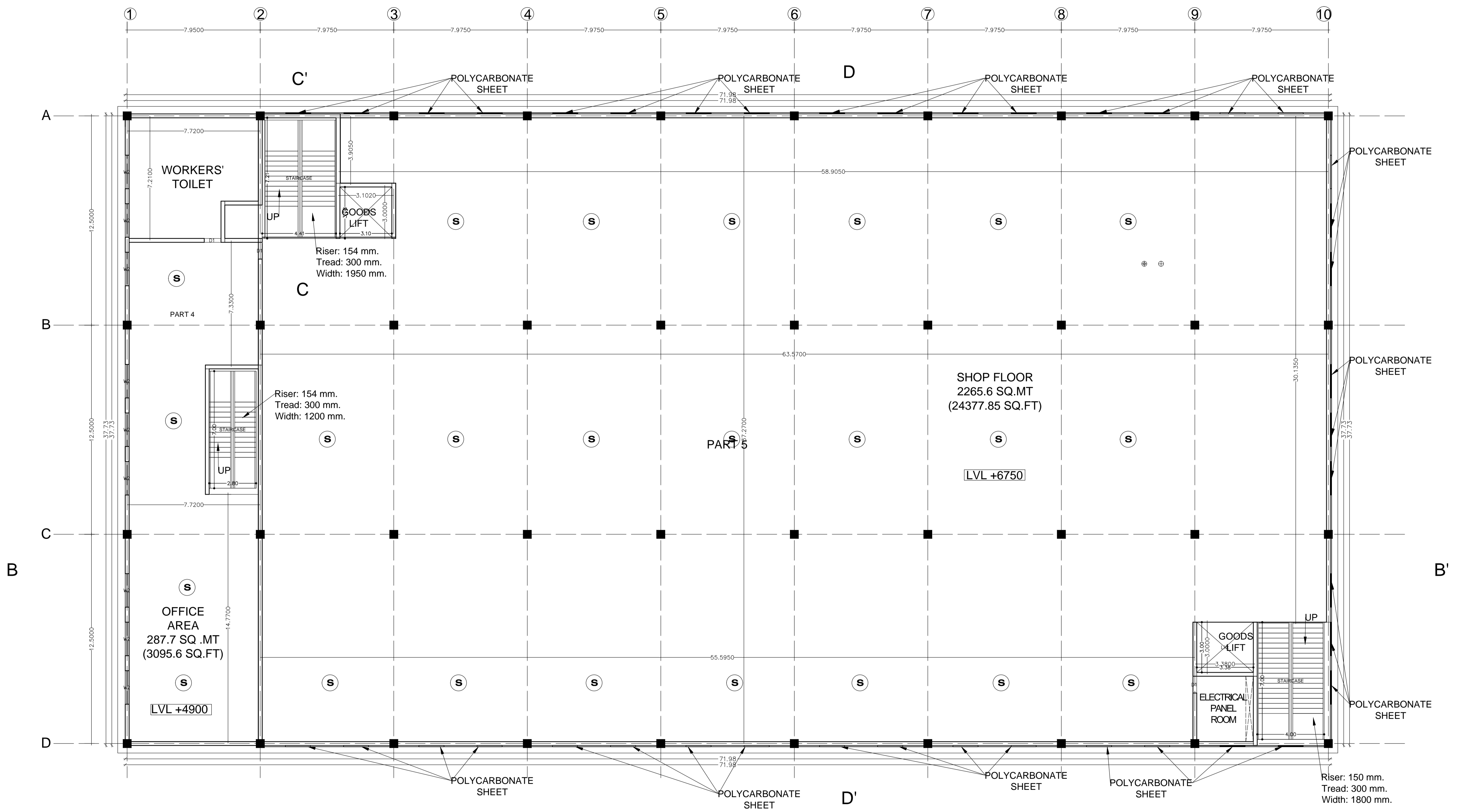

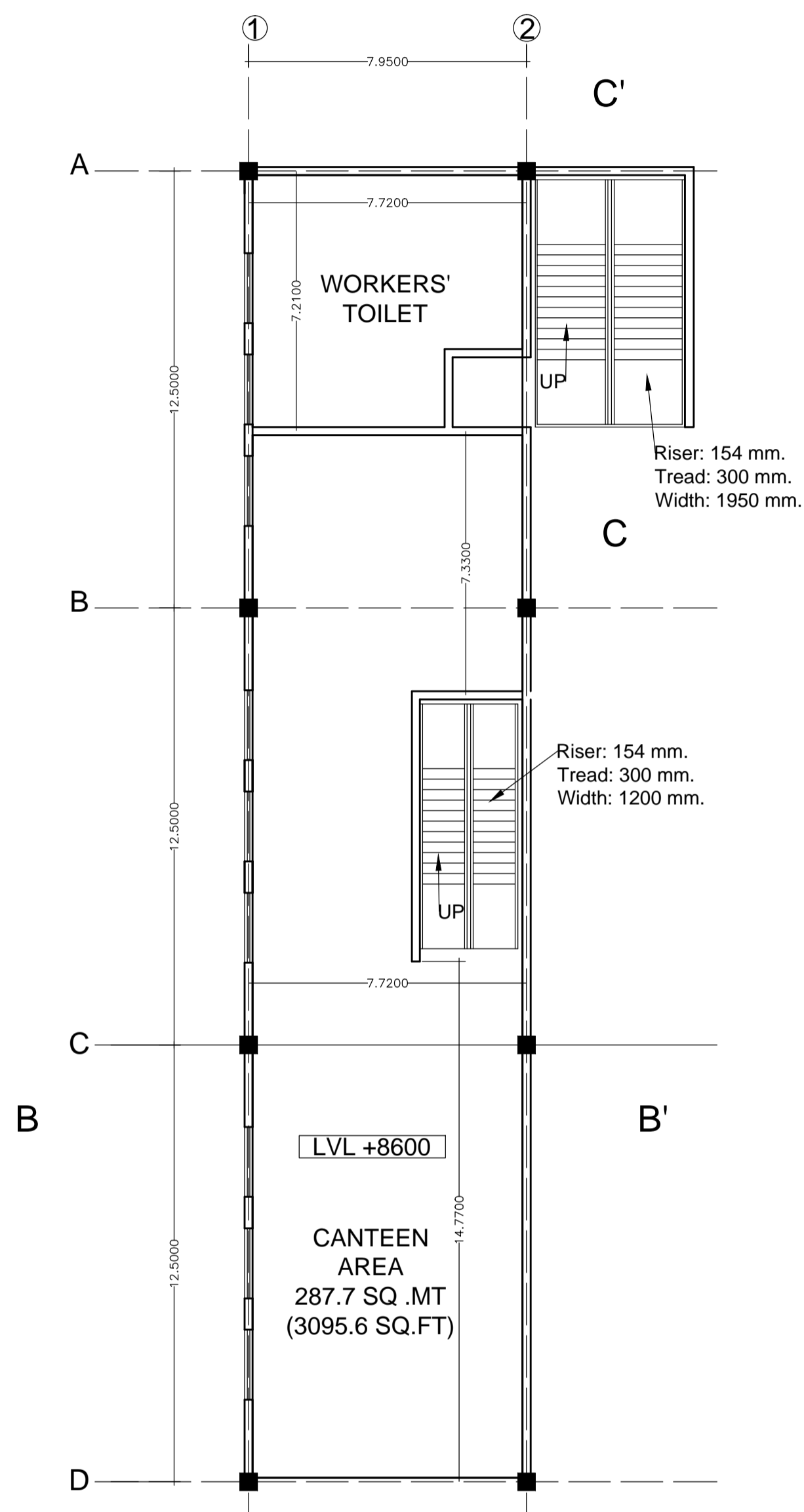


GROUND FLOOR PLAN

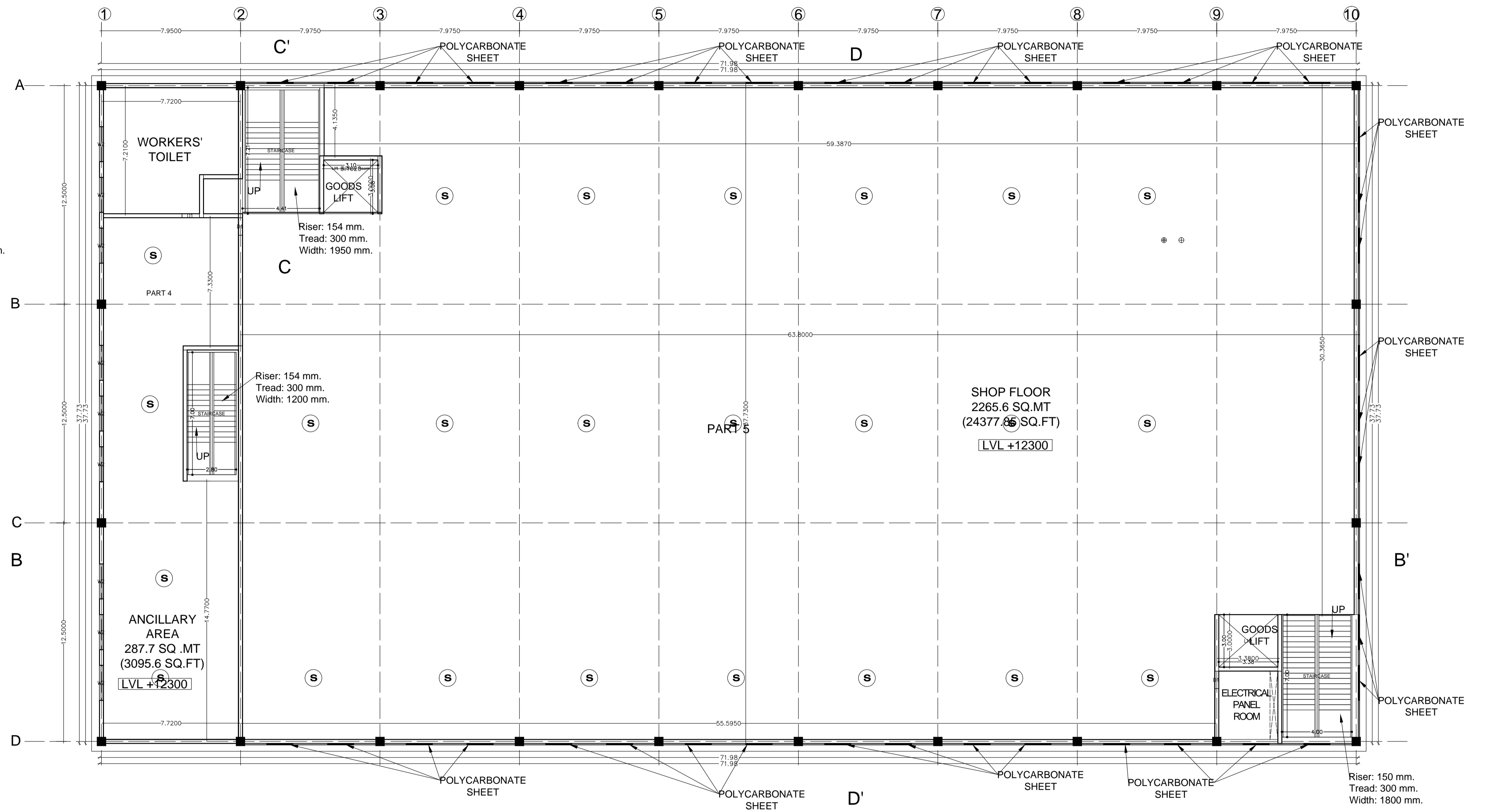


**FIRST FLOOR PLAN

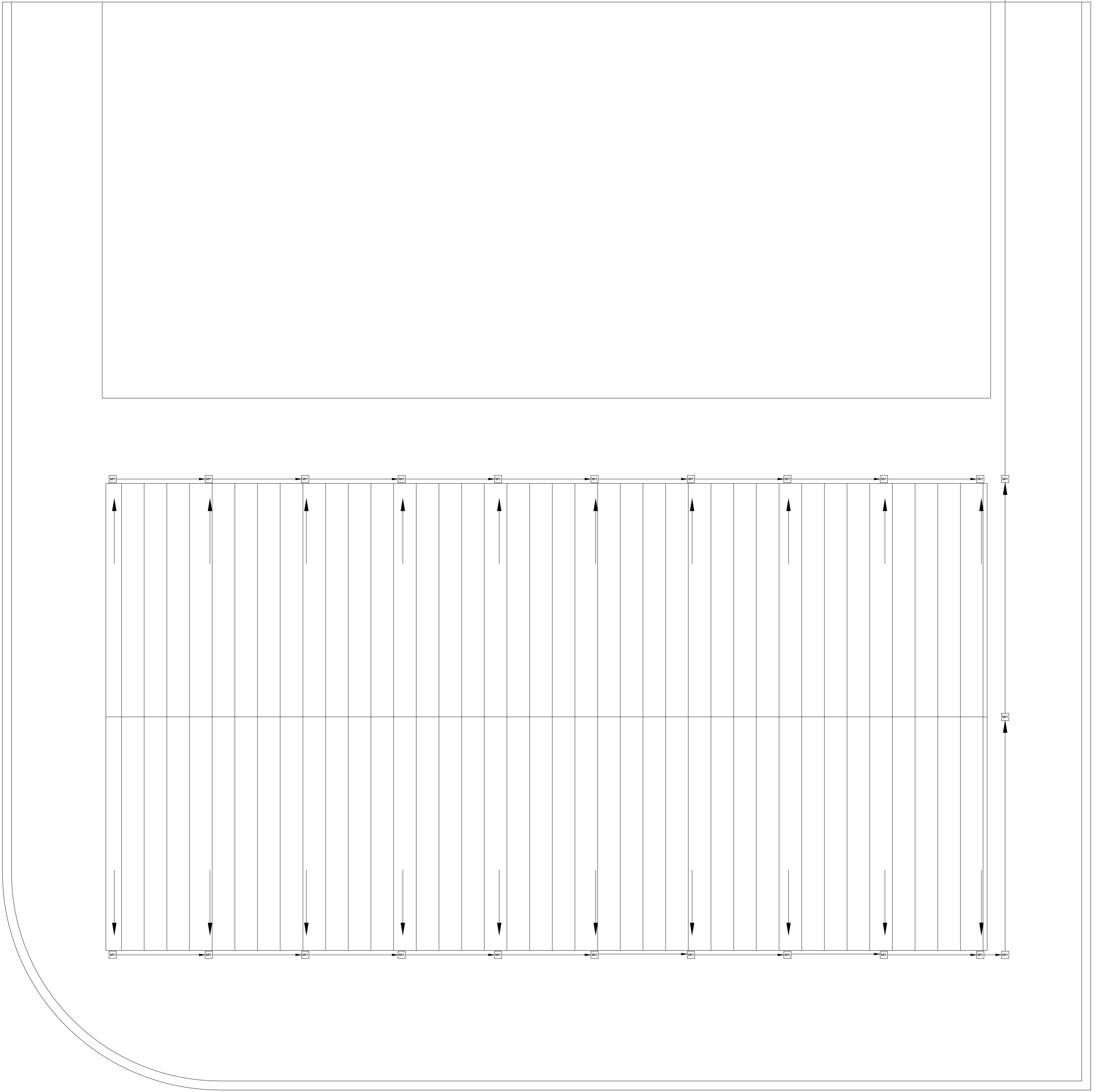


SECOND FLOOR PLAN  
LVL +8600

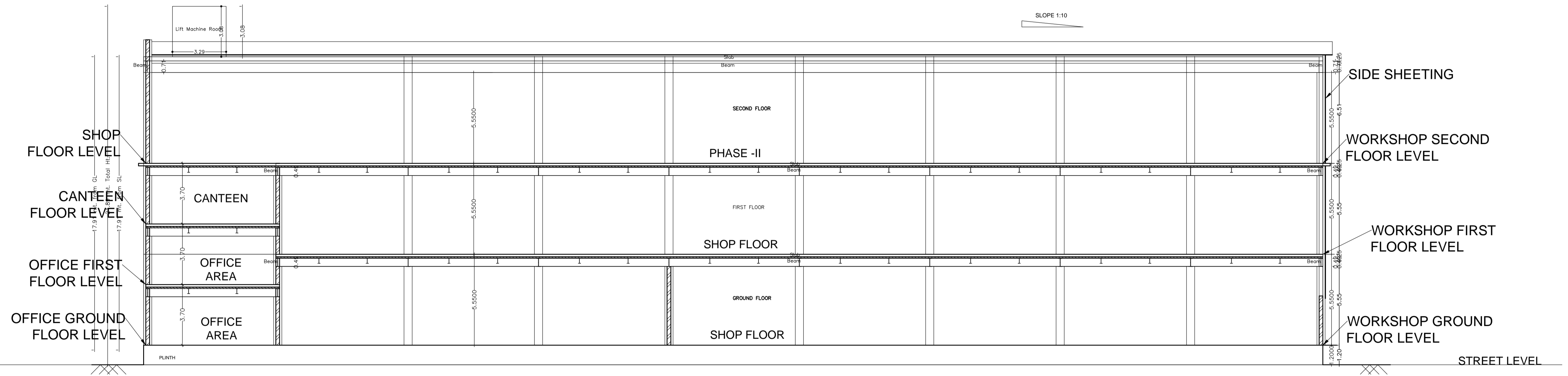


SECOND FLOOR PLAN

PIT

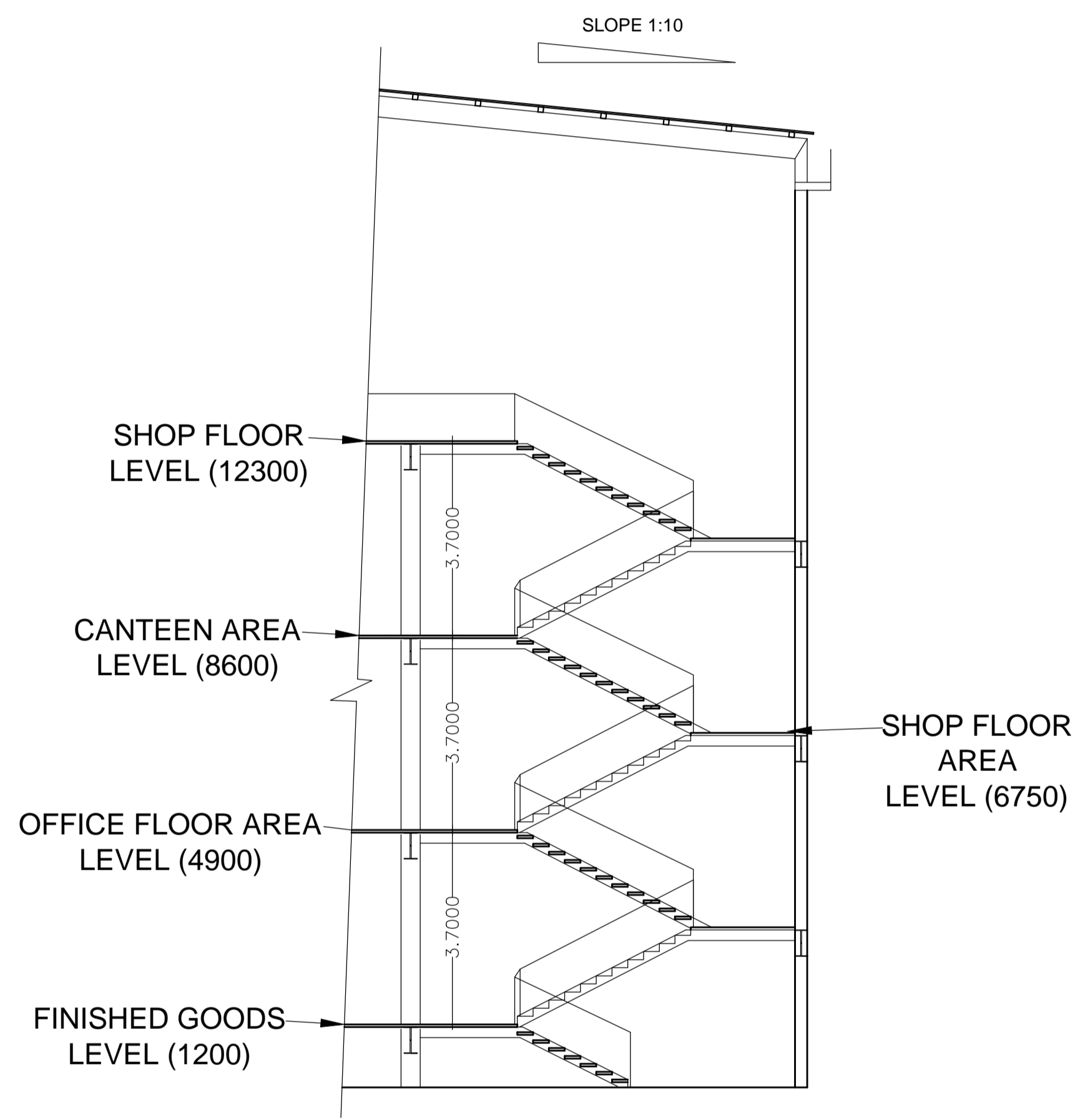
