With reference to above said letter in which you have mentioned that you want to Setup "Fabrication and general engineering machine shop" in the Lohardaga Industrial Area with a capacity of 2 tons/month (Approx).

In this regard this is to inform you that as per categorization of industrial Sectors by Central Pollution Control Board, Delhi. Engineering & Fabrication units (Dry process without any heat treatment/metal surface finishing operations/painting comes under Sl. no.-14 of white category.

Whereas the Board has adopted the above categorization vide letter no.-B-05, dated-03.05.2016 and Memo no.-B-2782 dated-03.05.2016 and thereby has also provided exemption from obtaining Consent to Establish (CTE)/ Consent to Operate (CTO) from the Board.

Therefore you unit is exempted from obtaining consent from the Board provided the manufacturing process does not involve any heat treatment/metal surface finishing operations/painting.
