VILL:- SHIRAMPUR.

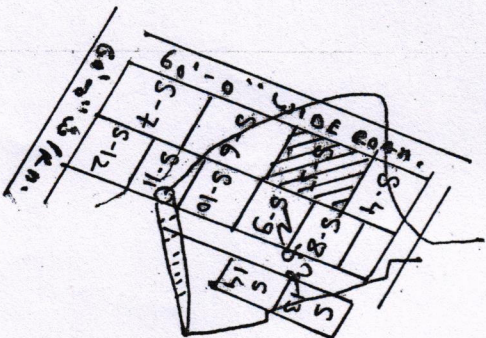

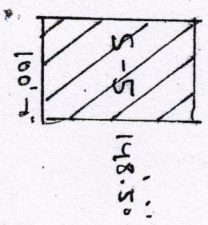
