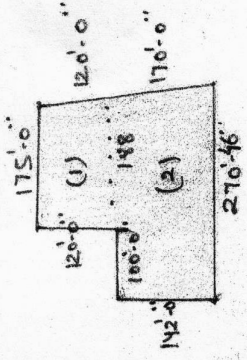

LAND PLAN OF: M/S FRIENDS ASSOCIATES

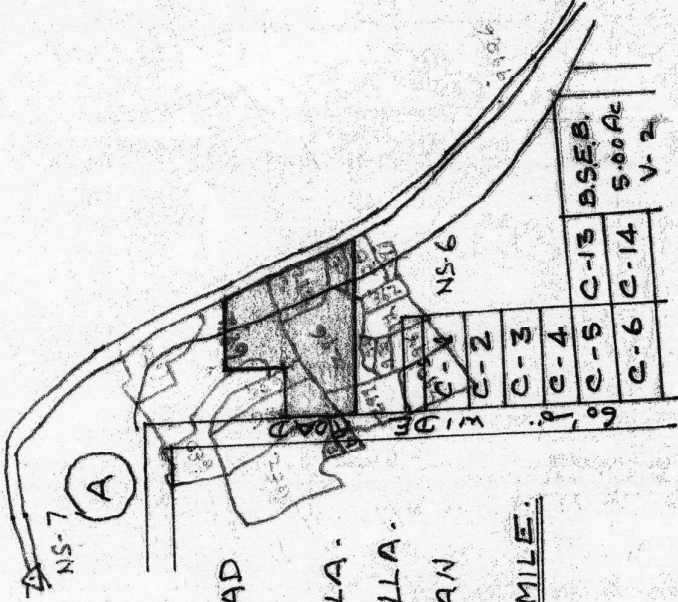

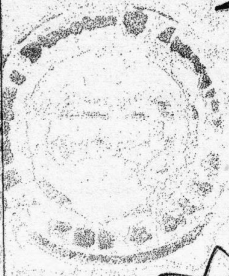

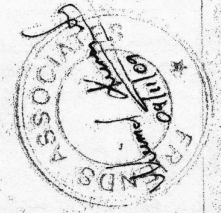
