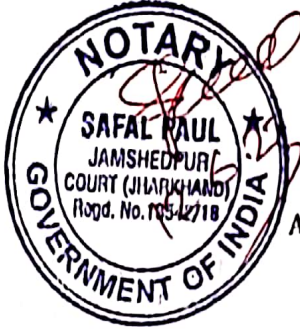

Whereas the Executant has submitted to the concerned Authority the plans for sanction of basement over Plot No(CS): 41(P) IC-4, Plot No(MSP): 41(P) IC-4, khata No: 60, Holding No, Village/ Mohalla: Mouza : Saraikela, Village: Bhatia, Thana no:- 127 ,P.s:-Saraikela, District : Saraikela Kharsawan, Jharkhand of JIADA Municipal Corporation /Municipal Council /Nagar Panchayats / Municipality/Notified Area Committee/Regional Development Authority/Industrial Area Development Authorities/Mineral Area Development Authority, Gram Panchayt are covered under development plan or planning scheme notified under Jharkhand Municipal Act 2011, Jharkhand Regional Development Authority Act 2002 , Mineral Area Development Authority Act Jharkhand Industrial Area Development Authority Act within the development plan area.....
