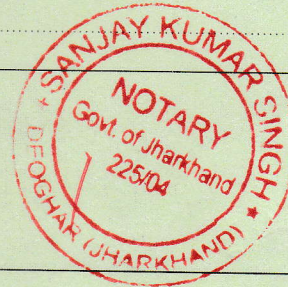
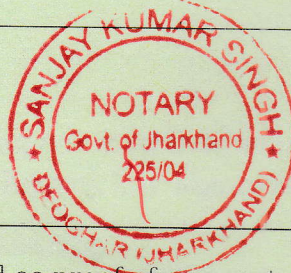

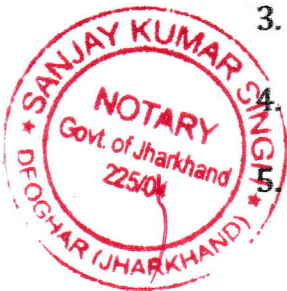

That after the donation of land nor I neither my any legal heir/successor will not claim at present and in future.


