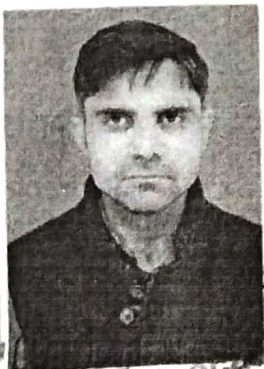

1. The First Trustees

(2). **SHAHDAB HAIDER**, S/o Late Mohammad Matinuddin Haider aged 28 years, residing at Resident of Nadi Ground, Tanzim Nagar, Near Akbaria Masjid, Hindpiri, PS and PO Hindpiri, Ranchi 834001 District -Ranchi, Jharkhand, (Aadhar Number XXXX XXXX 1073) (PAN AKZPH2388B)

All First "Trustees" shall hold office for their life unless they vacate the office as per vacancies clause of this trust deed. The First trustees shall have the right to co-opt any other person as a "Trustee" for life or for fixed period by consensus of all or by two third majority of the First trustees. However, the total number of trustees (including First Trustees) shall at no time exceed 21. The person amongst the first trustees during the creation of this Trust shall remain trustee for life and shall not be removed from the office through voting or election.

1. **Board of Trustees:** All the Trustees shall be collectively known as Board of Trustees.

2. **CATEGORIES OF MEMBERS:**

a. **Founder members:** The persons enumerated above as first trustees who are now establishing this Trust shall be the Founder Members. In case of the seizure of First trustee one among his close family member or such other person as nominated by the First Trustee shall be appointed as Life time Trustee.

b. **Ordinary members:** Such member shall be the trustees inducted by the First Trustees and shall contribute on annual subscription fee of Rs. 1000 and admission fee of Rs. 250 and this amount shall not be refundable in any event of cessation of the member from membership. The founder members shall have the right and privilege to remove an ordinary member in case the ordinary member is not contributing any value addition in the affairs of the Trust.

II. AIMS AND OBJECTS OF THE TRUST

1. The trust shall be a charitable trust, and having charitable and religious activities in terms of the tenets of Islam, the Trust shall be registered under the applicable provisions of the Income Tax Act, 1961 and the income thereof shall be exempted under section 2 (15), 11, 12, 13 and 80(G) of the Income Tax Act, 1961, no such amendment shall prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80 (G) of the Income Tax 1961 and also no such amendment shall be carried out without the prior approval of the Commissioner of Income Tax having the jurisdiction over the trust. (a) GENERAL

1. To inculcate interest in learning in general and to provide facility for advanced education and training and to work for cultural upliftment and to instill and develop the interest, aptitude and patience capability of youths of Jharkhand in particular and youths of India in general.
2. To promote, advance and foster education and culture and to sponsor, promote, establish various educational universities, providing, special facility for youth in such a manner as to safe guard, preserve, promote and advance their languages, culture and religion and to be conducive to the advancement, promotion and progress of the same.
3. To provide maximum facilities and opportunities to increase the taste and inclination of learning and social and cultural activities by awarding stipends and scholarship or monetary aids to meritorious and poor boys and girls in particular and general student at large.
4. To establish, continue and manage anywhere in the state of Jharkhand & other states, schools, collage, training institutions, technical and professional institutes, commerce and law college, medical college, university (ies), welfare cultures and to secure therefore recognition and affiliation from the Governments of Jharkhand or any other State Government or universities or other bodies or authorizes required under various laws. Thus the activities and benefits of the trust shall be open for all Indian students in general and for Muslim community in particular. The right to admit students from outside India shall rest with the Trustees as per the law settled in this regard.

5. To raise funds for the above objects by subscriptions, donations or in such other manner as may be resolved from time to time by the trust including borrowing, by unsecured loans on the pledge or mortgage of properties of the trust or means of debenture or such securities.
6. To acquire by purchase, gift, lease, exchange, grant, concession or otherwise and land, building or other properties both morale and immovable in the interest of the trust. All the properties now existing or that may hereafter to acquire shall vest in the trust which shall have power to control there on and manage the same.
7. To enter into any agreement with the Government, Government instrument/authorities or other authorities i.e. municipal, local or other bodies which may seem conducive to the furtherance of all or any of the objectives of the trust and obtain from such source any right privileges assistance and concession which the trust may think fit or desirable not in consistent with the aims and objects of the trust.
8. To manage and deal with the funds and money, land, building and other properties as aforesaid and to collect rent and income and to invest the said money in government or reputed and dependable organization in the safe investment otherwise for the purpose as stated above for the benefits of the trust and in furtherance of its objects.
9. To start from time to time any such other institutions, technical or general including university, libraries and scholarship funds or to affiliate or take over such existing institution as the trust decides upon for the imparting and spread of education under written agreement.

(b) EDUCATION

1. To establish and maintain educational institutions of every kind especially for the downtrodden sections of Indian population and to build, administer and maintain hostels as well as other institutions.
2. To impart training and education for **NEET IIT JEE, Civil Services, Teaching courses and banking and all other professional courses** through residential programme or coaching programmes for the betterment of the youth.
3. To impart training of various durations in professional, vocational and useful courses, particularly in engineering, medicine and pharmacy, information management and mass communications, humanities, etc. and to establish production cum sales facilities for the trainees in its institutions.
4. To establish and run primary and secondary schools etc. to impart value-based quality education.
5. Providing grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc.
6. To establish career guidance centers and counseling centers.
7. To work or network in collaboration with 'like-minded' other charitable/ religious trusts or institutes of the region/s in furtherance of the objectives of the Trust.
8. One of the major aims and objectives for the establishment of the Community Centre and the Trust is that children from Muslim Community would be educated to socially, economically, and financially contribute their part to the development of our Nation.

(c) RELIEF TO POOR

1. To give financial assistance.
2. To give assistance in kind by way of distribution of books, notebooks, clothes, uniforms and meals for the poor and indigent.
3. To provide shelters (houses).
4. To develop entrepreneurship.
5. To run self-employment schemes.
6. To establish, run, assist and maintain orphanages (both for girls and boys separately).
7. To assist through microfinance schemes.
8. To provide immediate relief and to rehabilitate the victims of natural calamities and manmade calamities.
9. To establish, run, maintain and assist any medical institution, hospital including multi-specialty hospitals, nursing homes and/or clinics, or to grant assistance to needy and indigent person for meeting the cost of medical treatment.
10. To establish community kitchen for the distribution of food.

(d) OTHER OBJECTS

1. To acquire property for the sole use of public good by making it available for public purposes as for example having a library, clinic, crèche, and or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.
2. To facilitate the provision of infrastructure essential for the socio-economic development of the rural sector.

- b. Grants from the Government.
- c. To invest and deal with the money and funds belonging to the trust and not immediately required in such manner, as may from time to time be determined by the board or committee.
- d. Through Philanthropies donations from the public or from any other organize/ organization or body duly recognized by the government for educational benefits to poor oppressed person in general.
- e. To take on lease or purchase or accept by way of gift any land, building, or any other property both movable and immovable.
- f. To remunerate any firm or institution for service rendered to the trust, all costs, charges or expenses incidental to its establishment, registration and advertisement.
- g. To give donations or subscriptions to any trust, society, institution or association, bodies, organizations etc. performing similar activities and having exemption under section 12A of the Income Tax Act or any other relevant provisions of any Act enacted in place of the existing Act.
- h. To adopt and take any other lawful means as may be incidental and conducive to the accomplishment of all or any of the objectives.

- i. The income and property of the trust howsoever derived shall be applied towards the promotion and advancement of the objectives set forth above without any profit motive.
- j. No portion of the income and property of the trust shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise by way of profit, to the persons who at any time are or have been trustees, or to any of them, or any persons claiming through them provided that nothing here contained shall prevent the payment in good faith the remuneration, travelling expenses and other similar allowances.
- k. To raise funds through Bank borrowing and financial assistance from bank, financial organization, NBFC, Nationalized or Private Bank for the advancement of the objects of the Trust.
- l. The trust is free to take and fetch loan for the construction activity, establishment activity, management activity for running school, colleges, university, diploma courses, management degree course, medical education and allied education, social, welfare to fulfil the main objectives of the trust.
- m. To create and organize a Corpus Fund.

III. MANAGEMENT OF THE TRUST

A. BOARD OF TRUSTEES

The names of persons as "first trustees" in this deed shall be the trustees constituting the first board with whom the management of the trust shall be vested.

B. Executive Committee:

The trustees shall elect following office-bearers, as the executive committee, from among themselves by a simple majority.

- (a) President 1
- (b) Secretary 1
- (c) Treasurer 1

Note: The board may add office-bearer as and when necessity arises.

C. ELECTIONS:

The election of the office-bearers as above shall be done by a simple majority of trustees present in a formally convened meeting and shall hold office for four years. The election of a new team of office bearers shall be done within six months from the date of expiry of the term of office of the existing office bearers. The elected office bearer or office bearers may be removed by 2/3rd majority of the trustees present in a formally convened meeting and new office bearer or office bearers shall be elected by a simple majority of the trustees in that meeting. The term of office of such mid-term elected office bearer or office bearers shall end with the original term on which the term of office of the replaced office bearer or office bearers would have expired.

IV. POWERS AND FUNCTIONS OF OFFICE-BEARERS:

1. PRESIDENT

- (a) The person amongst the first trustees, nominated as President during the creation of this Trust shall remain the President for life and shall not be removed from the office through voting or election.
- (b) He/she shall preside over all the meetings of the board.
- (c) He/she shall have general control over all the affairs of the trust and the institutions under its control and its employees.
- (d) He/she shall take necessary and prompt action in case of an emergency and to report at a meeting of the board to be called within a fortnight from the date of the emergency.
- (e) He/ she will carry out all the resolutions of the Trust and for that purpose he/she shall have power to incur necessary expenditure from and out of the funds of the Trust, subject to maximum of **Rs. 25000/- (Rs. Twenty Five Thousand only)** and anything in excess of **Rs. 25000/- (Rs. Twenty Five Thousand only)** is to be incurred with the sanction of the Board of Trustees.

- (b) In absence of the President the Secretary shall preside over meetings. In absence of both the President and Secretary the board shall elect a President from amongst the trustees present.
- (c) He/ She shall be in charge and responsible for the safe custody of all the records and documents relating to the trust and its properties.
- (d) He/ She shall convene meetings of the executive committee and the board of trustees with consent of the President and maintain regular record of the proceedings of such meetings.
- (e) He/ She shall be the custodian of all correspondence and all financial statements in connection with the management of the trust.
- (f) He shall implement all decisions of the executive committee and resolutions of the board.
- (g) He/ She shall also carry out such other duties and responsibilities entrusted to him from time to time by the PRESIDENT and the board.
- (h) The trust may sue or be sued in the name of the secretary.
- (i) He can enter into an agreement or contract or execute or register documents in the name of the trust as per decision of the board.
- (j) He can take any other step deemed fit to meet any contingencies affecting the interest of the trust and report same to the board in the next meeting.
- (k) With the approval of the President, he can appear on behalf of the trust before any Government Authorities, Courts, Tribunals, Statutory Bodies or any other competent authority as an authorized person of the trust.
- (l) He/she shall have power to incur necessary expenditure from and out of the funds of the Trust, subject to maximum of **Rs. 20000/- (Rs. Twenty Thousand only)** and anything in excess of **Rs. 20000/-** is to be incurred with the sanction of the Board of Trustees.

3. TREASURER

- (a) Treasurer means the in charge of financial account of the trust.
- (b) He/ She shall be the custodian of cash, negotiable instruments and other valuables.
- (c) He/ She shall receive and make all payments made to the trust and pass necessary receipts.
- (d) He/ She shall maintain or cause to maintain regular books of accounts of the trust.
- (e) All legacies, donations, subscriptions shall be paid to the treasurer whose receipts shall be valid and binding on the trust.
- (f) He shall get the accounts of the trust audited as decided by the board.

V. POWER OF THE BOARD

Without prejudice to the generality of powers vested in the trustees the Board of Trustees shall have following specific powers:

1. To acquire, purchase, gift, grant, exchange, lease, hire or otherwise properties of all kinds including movable and immovable properties and to improve and add to the corpus of the trust, finance and property subject to the terms and conditions as may be decided by the board.
2. To acquire or construct buildings and purchase properties and to rent out or lease the same.
3. To sell, mortgage, lease out or give on license otherwise alienate all or any of the properties of the trust at such time and such consideration and terms as the board may deem fit.
4. To invest money of the trust in such investments as per the decisions of the board and as permissible by and in accordance with the prevailing law as applicable to the trust.

5. To cancel recall or vary all or any of the investments from time to time.
6. To sign, endorse and negotiate all kind of shares, securities, dividend warrants, cheques and other negotiable instruments.
7. To enter into any compromise and to refer any matter to arbitration.
8. To engage the services of any person or persons or such other staff found necessary upon any remuneration or terms as the board may deem fit.
9. To take disciplinary actions against the employees of the trust and also to terminate their services.
10. To incur all costs and expenses considered by the board as necessary in connections with the affairs of the trust and for future efficient management of the affairs and properties of the trust.
11. To open accounts in such bank or banks as the board may deem fit, and to operate upon all such account or accounts jointly and/or severally as decided by the board authorizing either to themselves or any employee or any other persons to be the authorized signatories on such accounts by passing a resolution. A certified copy of such resolution be signed by any two of the trustees.
12. To borrow or otherwise raise any money with or without security and upon such terms and conditions as the board may deem fit from financial institutions or others, however, to the condition that no interest is required to be paid on such borrowings.

VI. MEETINGS OF THE BOARD

- B. The Board of Trustees can also hold meeting through video conferencing/circular (by hand or email). The Board shall adhere to the applicable norms issued by the Government from time to time for holding meetings through video conferencing and/or circular.

C. Special meeting

1. A trustee may in writing send requisition to the secretary or anyone in his charge to convene a special meeting of the board clearly indicating the subject matter to be discussed at such a special meeting and the secretary there upon shall call upon a meeting giving 7 clear days of notice to the trustees.
2. In case the secretary fails to convene such a requisitioned special meeting, the President or any of the office-bearers shall convene such a meeting giving 7 clear days to other trustees and the decision taken by 2/3 majority of the members present at such meeting of the board of trustees shall be valid and binding provided the quorum as indicated in this deed has been attained.

D. Meetings

1. 8. The powers not decided in this deed are vested with the board, which shall decide its discretion in deciding matter/s that come up before them from time to time.
9. **Duration of trust:** The trust is irrevocable and shall continue in perpetuity.
10. **Amendments to the trust:** The Trustees may amend the Trust Deed for advancement of its objects and for administrative purposes for better and improved functioning of the trust, with the approval of the $\frac{2}{3}$ majority of the members present in any meeting of the board. However, no such amendment shall prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80(G) of the Income Tax 1961 and also no such amendment shall be carried out without the prior approval of the Commissioner of Income Tax having the jurisdiction over the trust.


