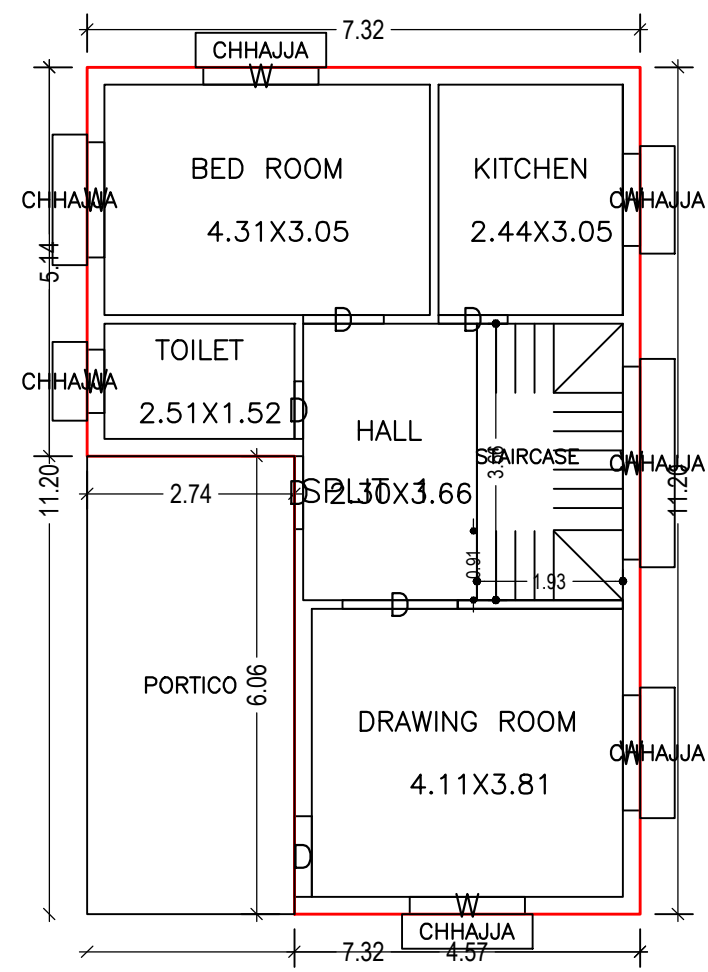

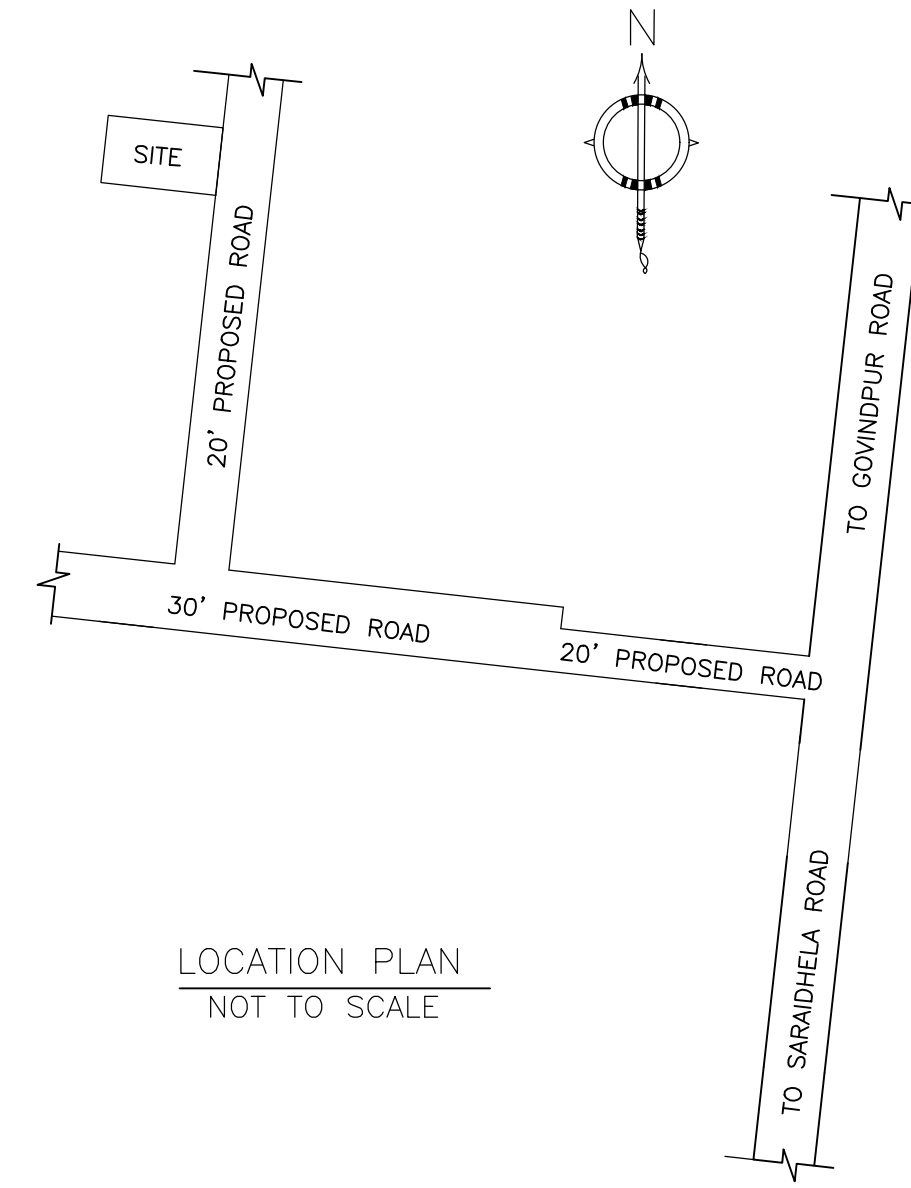
GROUND FLOOR PLAN

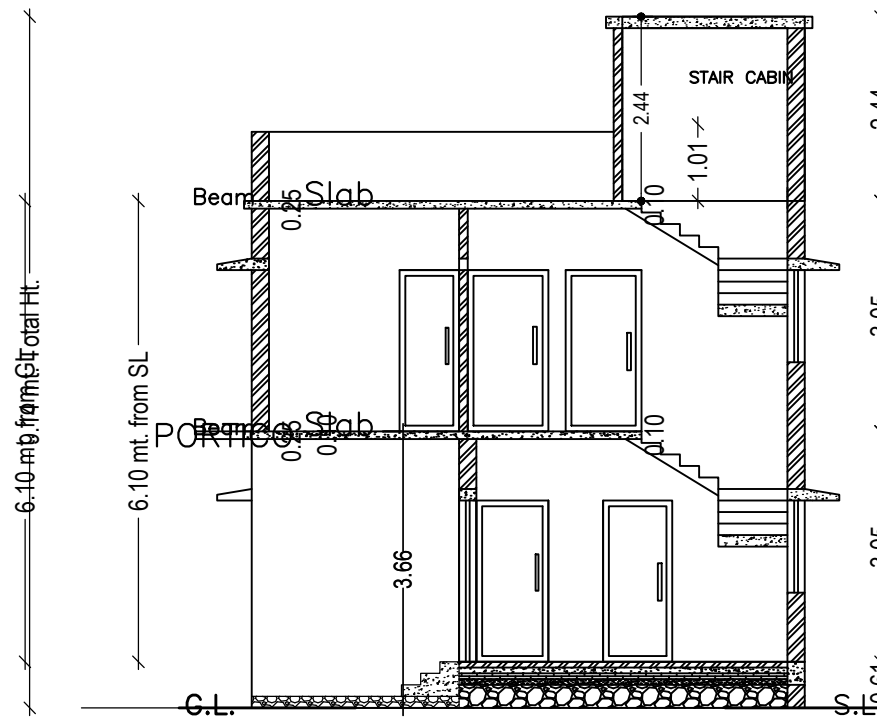
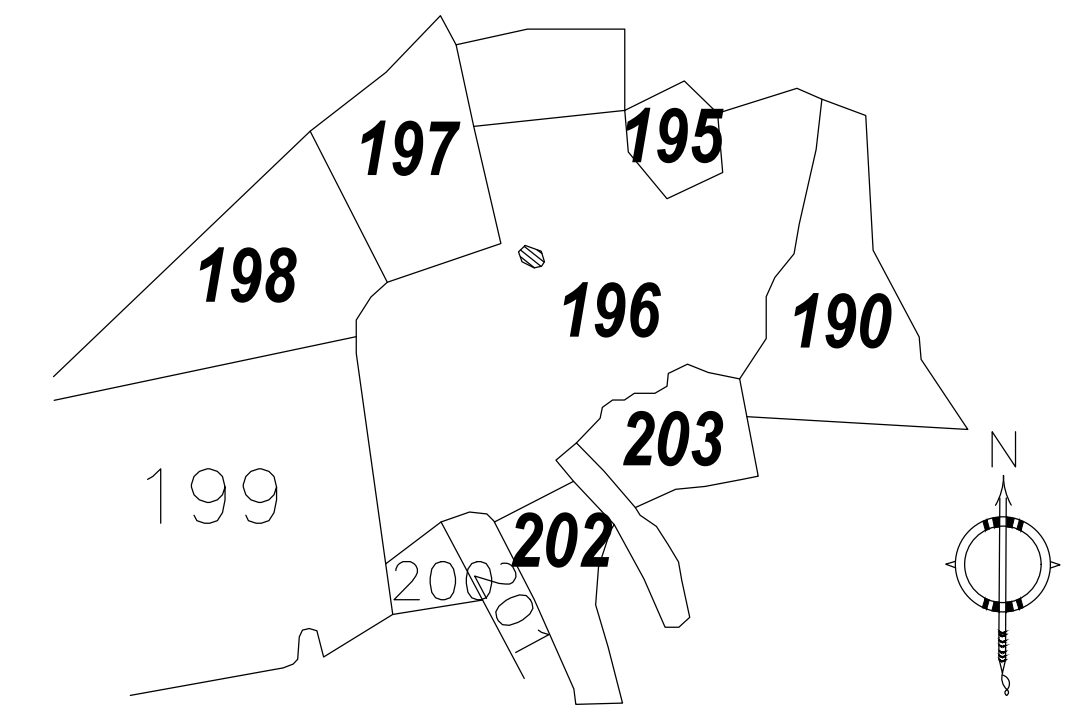
FIRST FLOOR PLAN

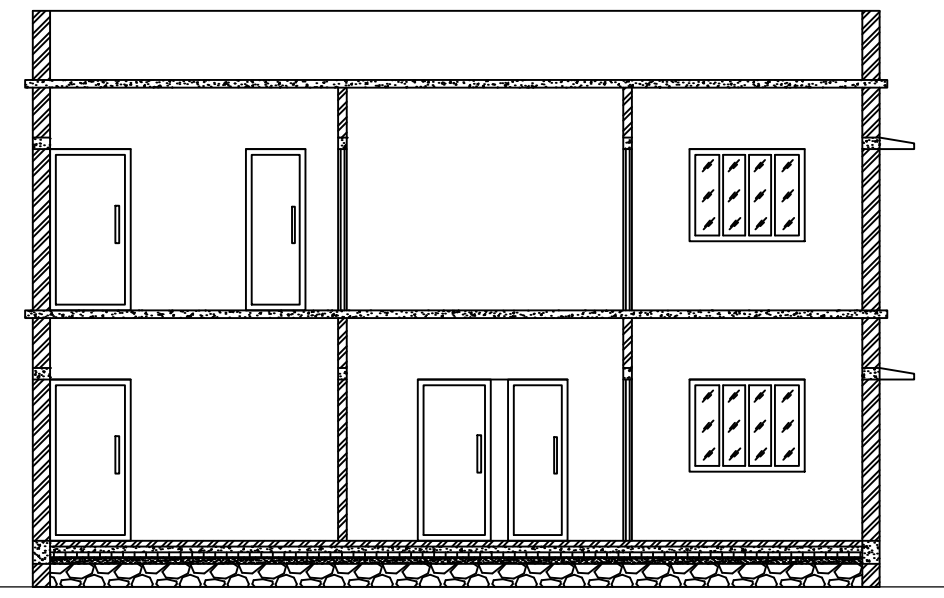
TERRACE FLOOR PLAN

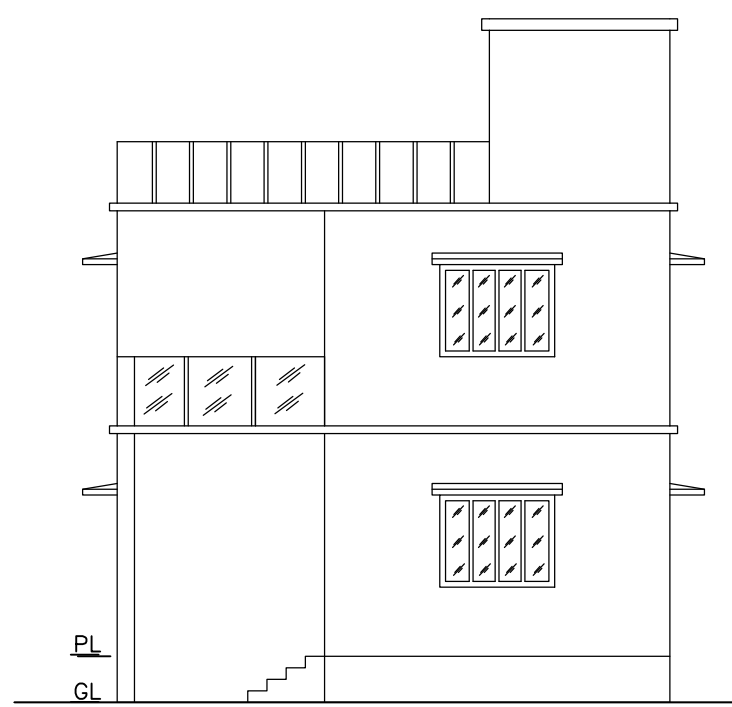
LOCATION PLAN

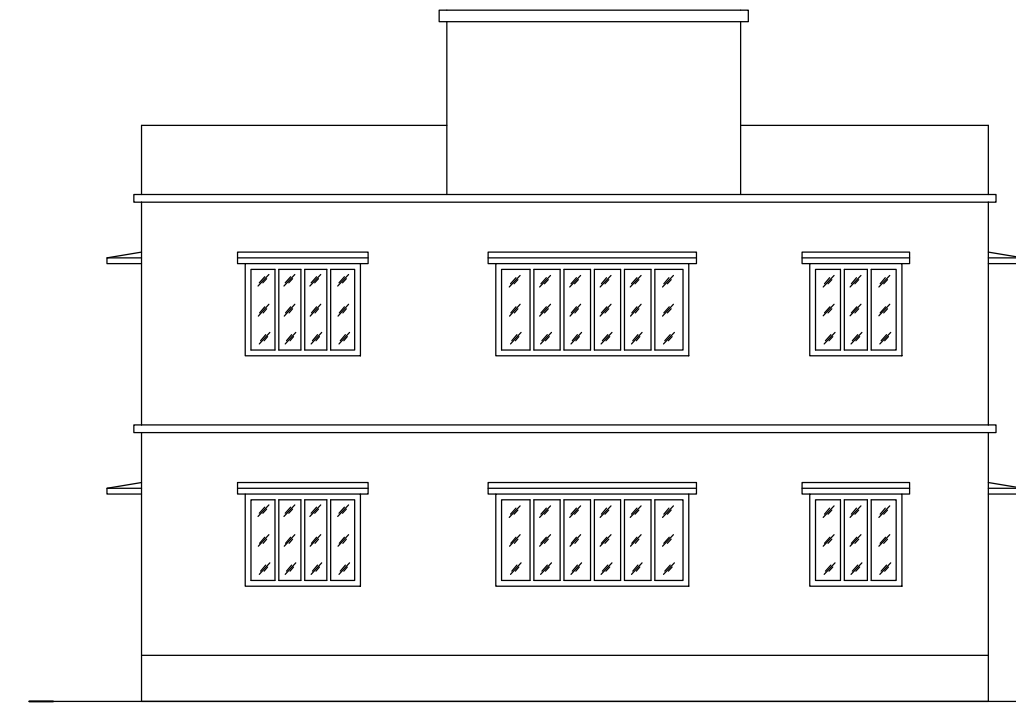

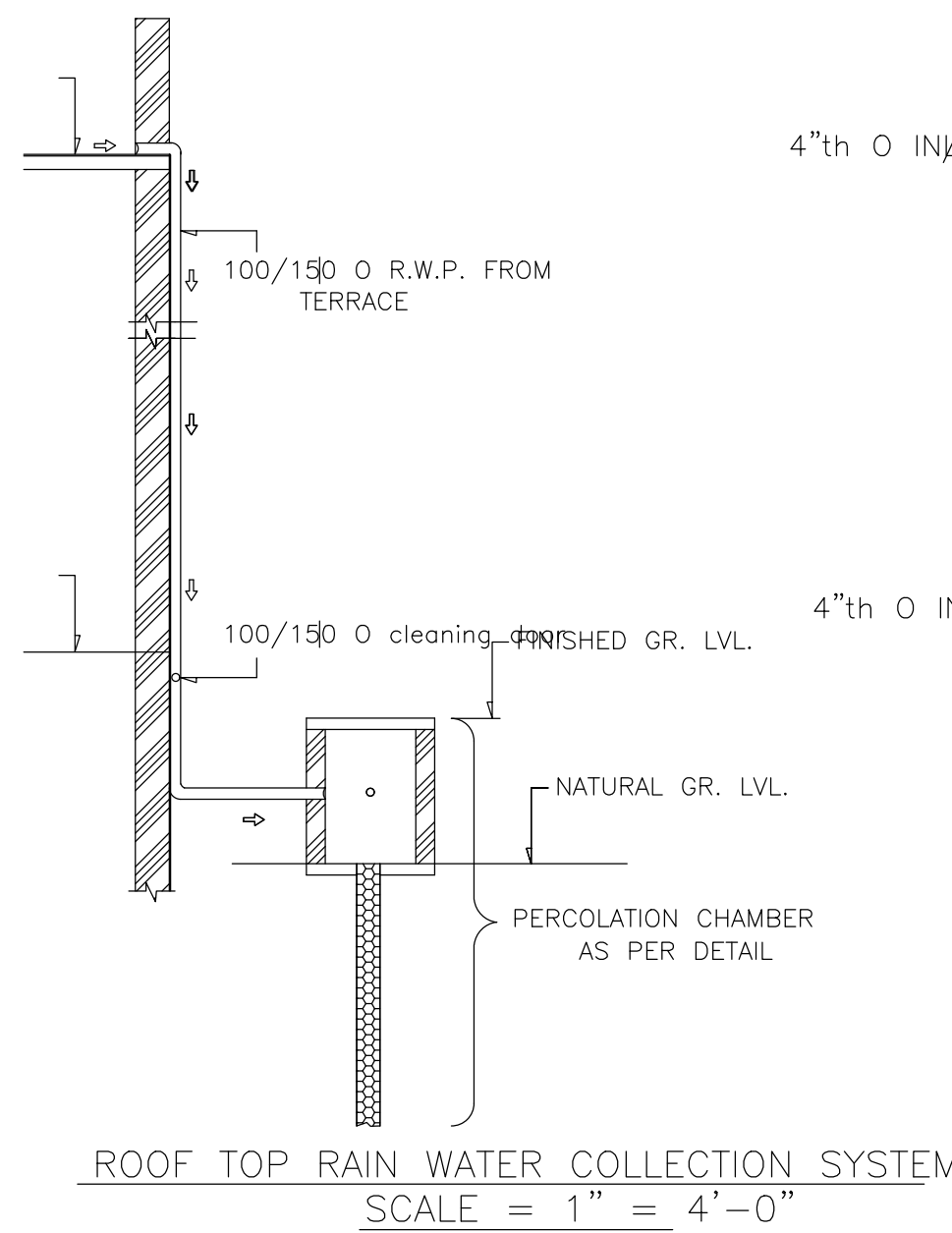

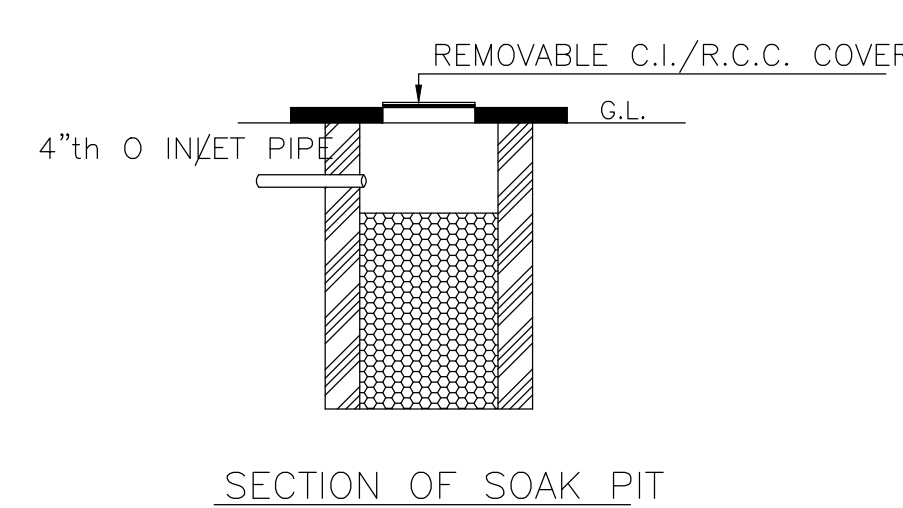
FRONT ELEVATION

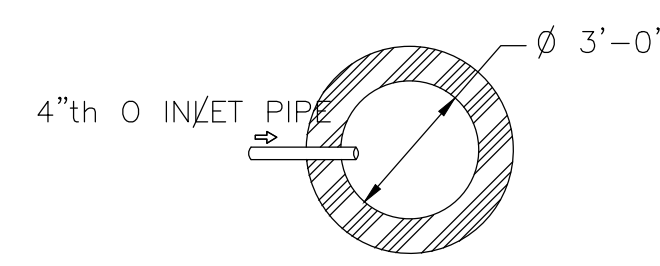
RIGHT SIDE ELEVATION

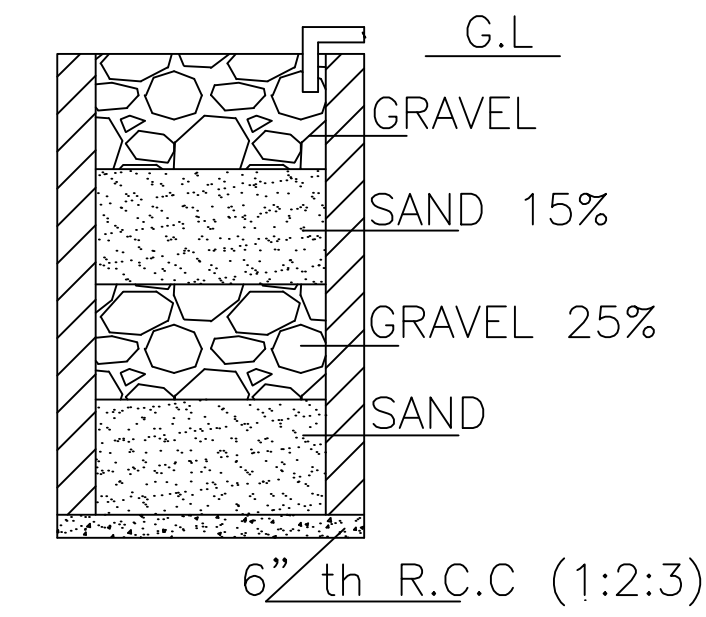
ROOF TOP RAIN WATER COLLECTION SYSTEM

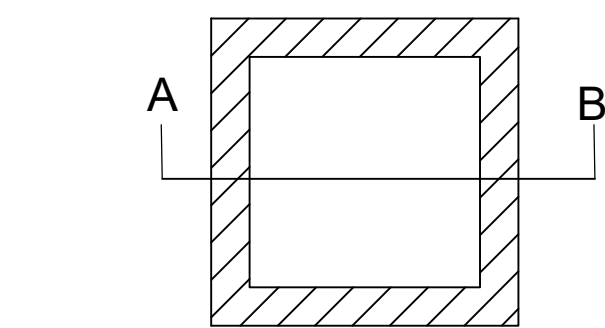
SECTION OF SOAK PIT

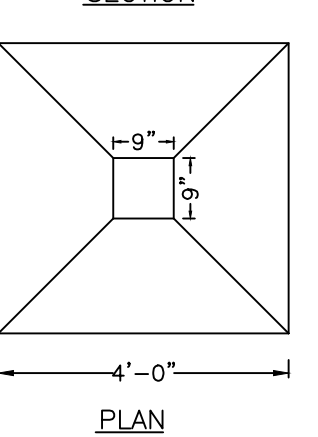
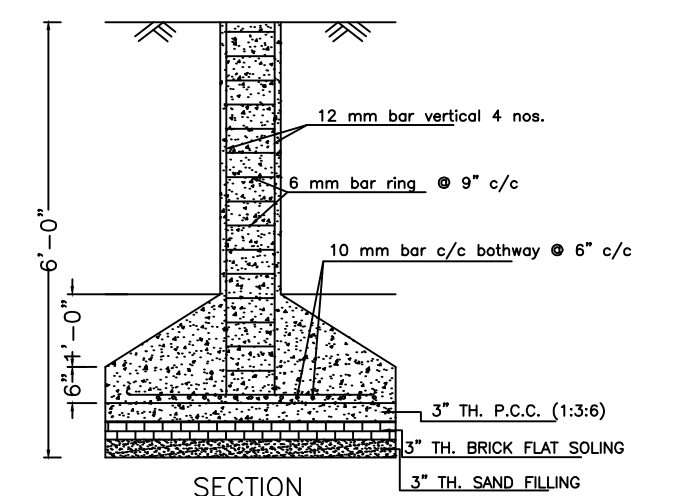

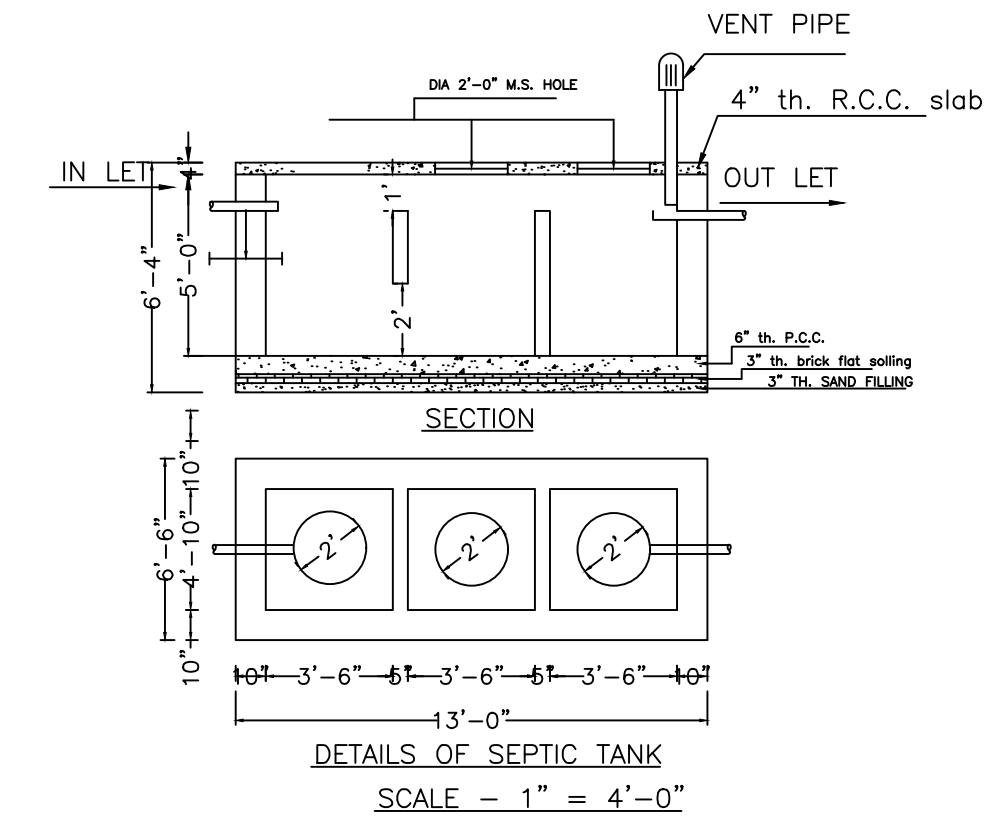


DETAILS DRAWING OF
