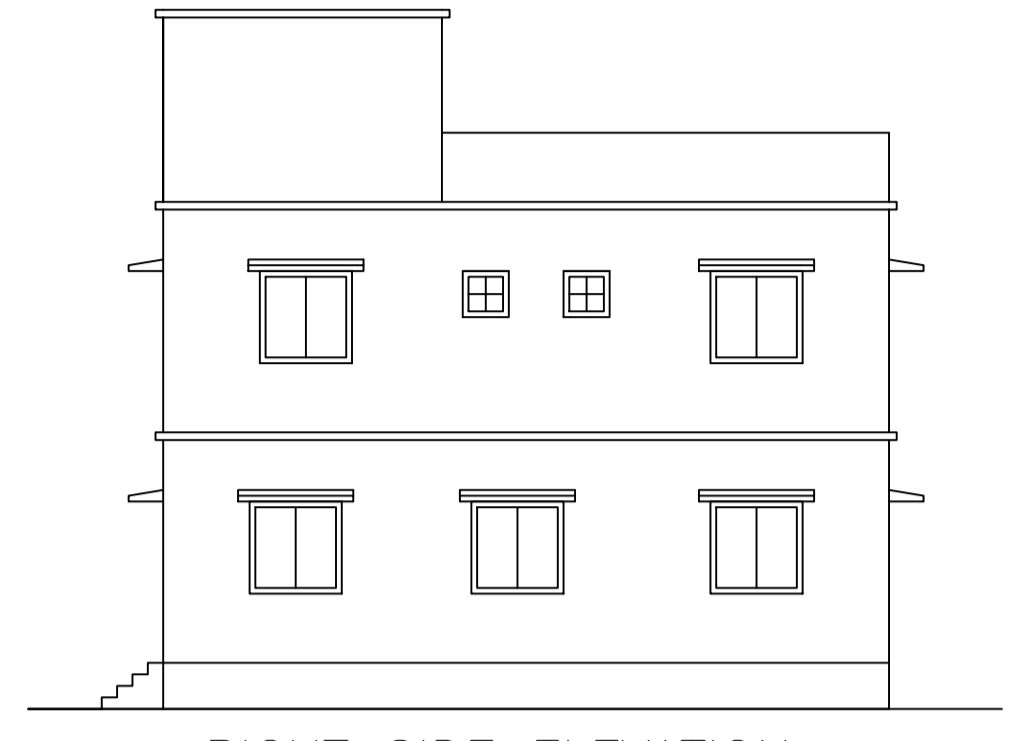
SITE PLAN

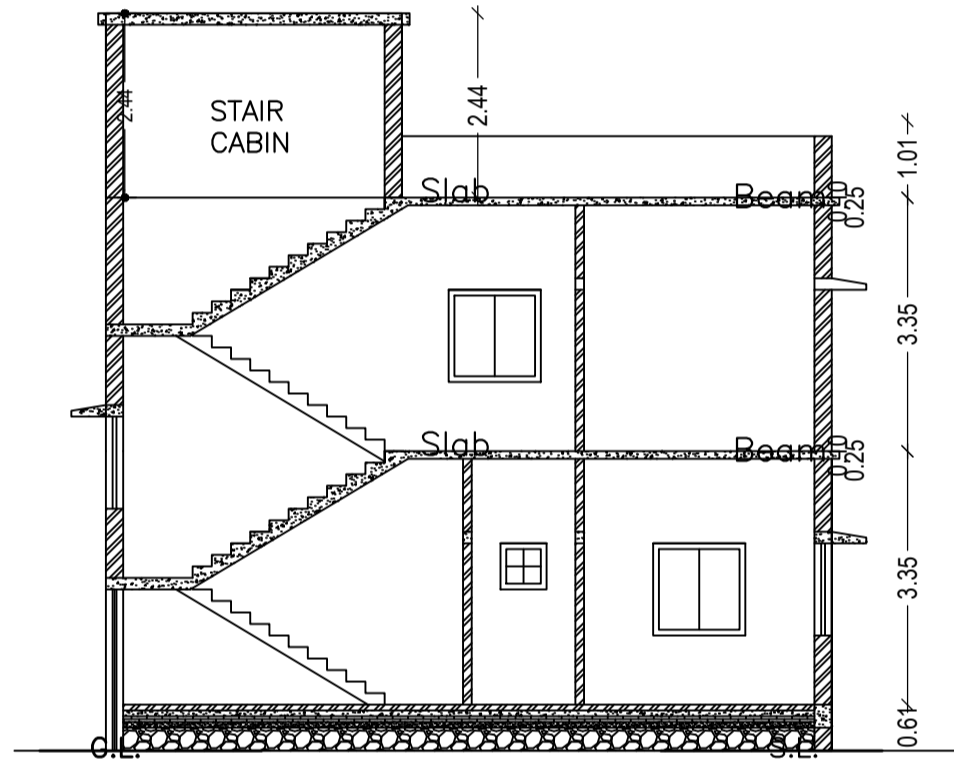
KEY PLAN

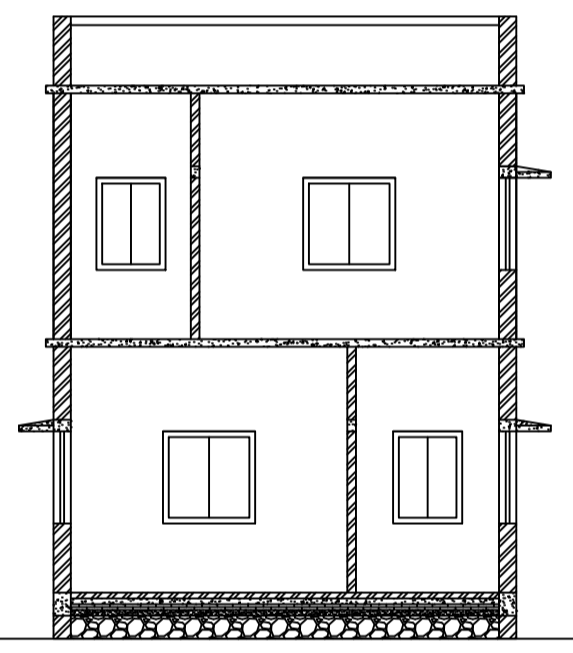
FRONT ELEVATION

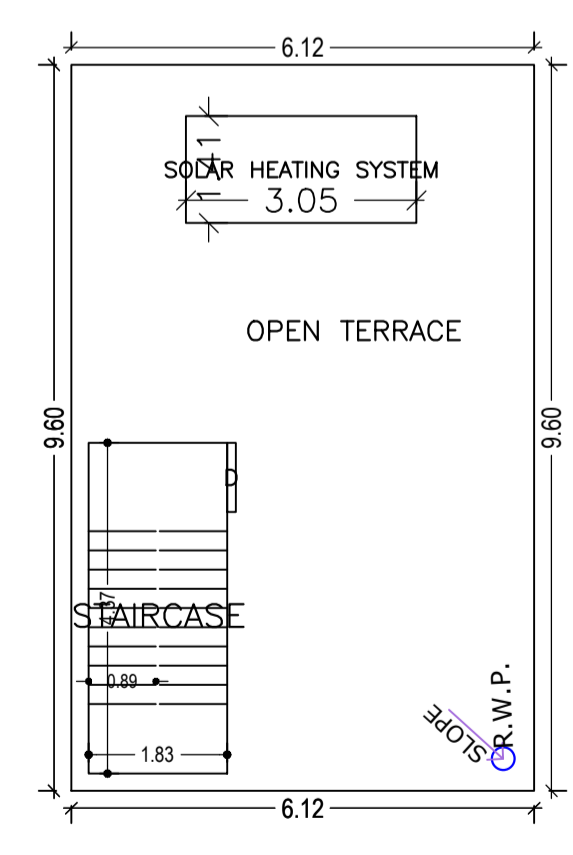

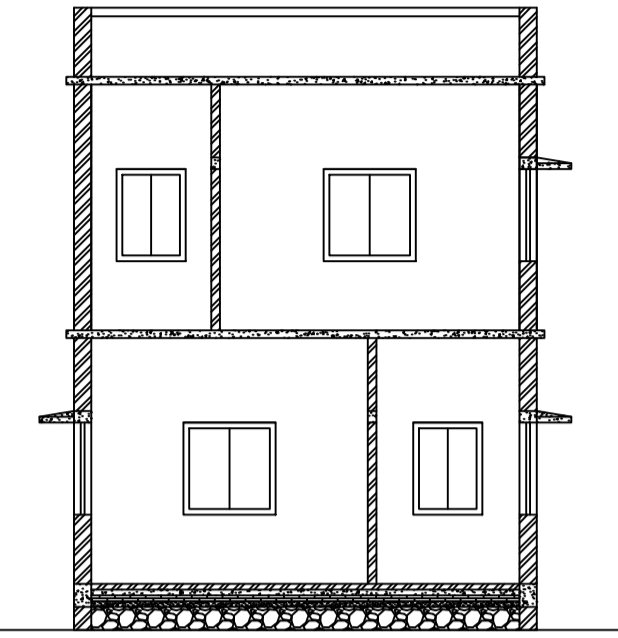

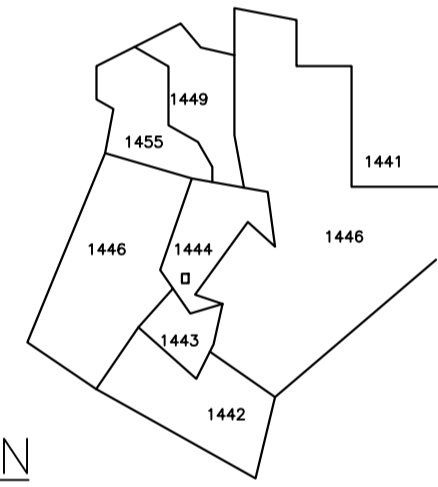

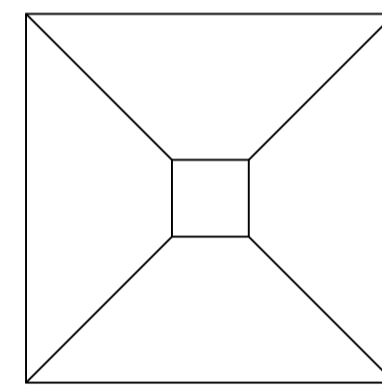

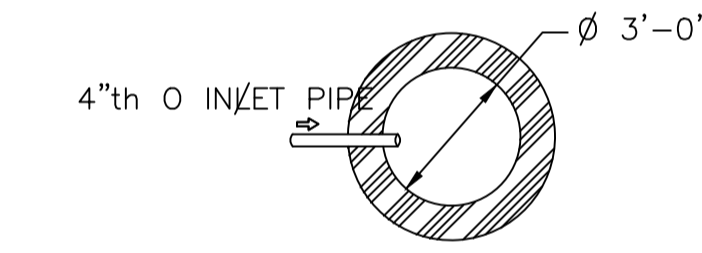
DETAILS OF COLUMN FOUNDATION

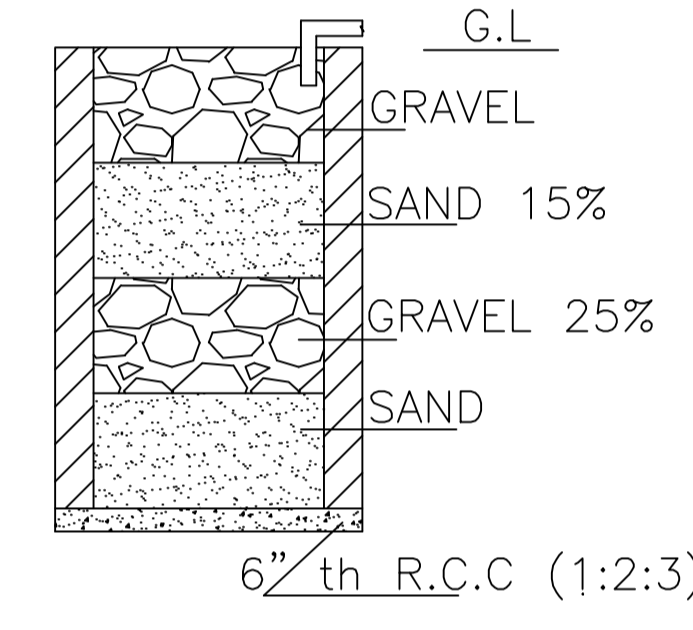
ROOF TOP RAIN WATER COLLECTION SYSTEM

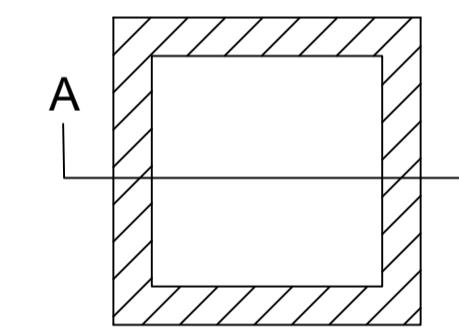
SECTION OF SOAK PIT



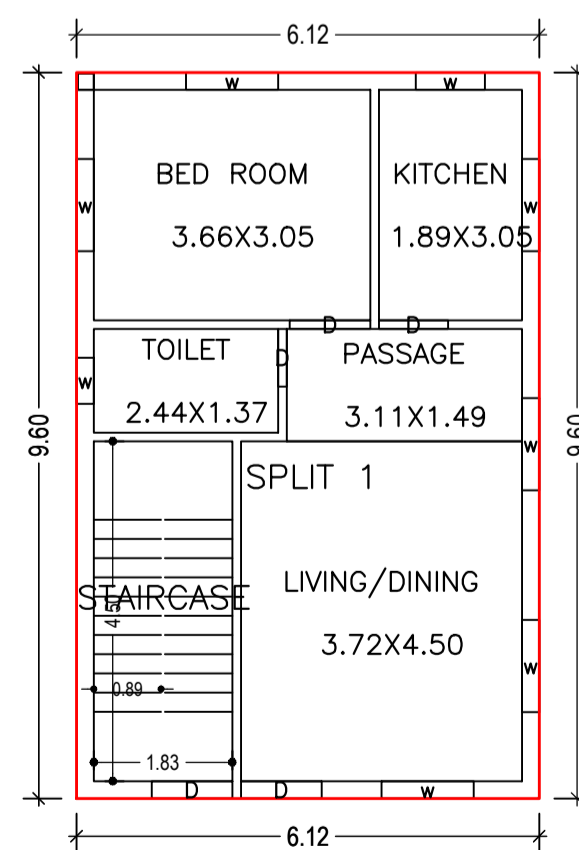

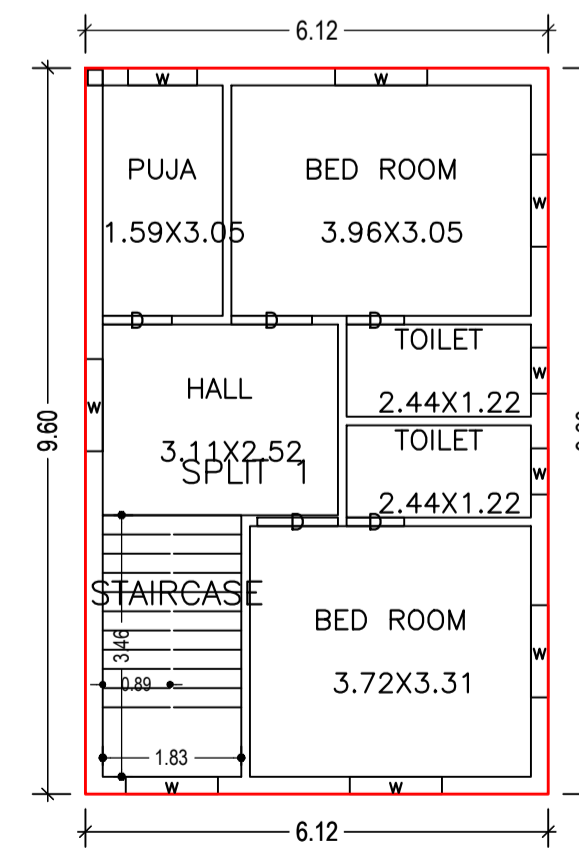

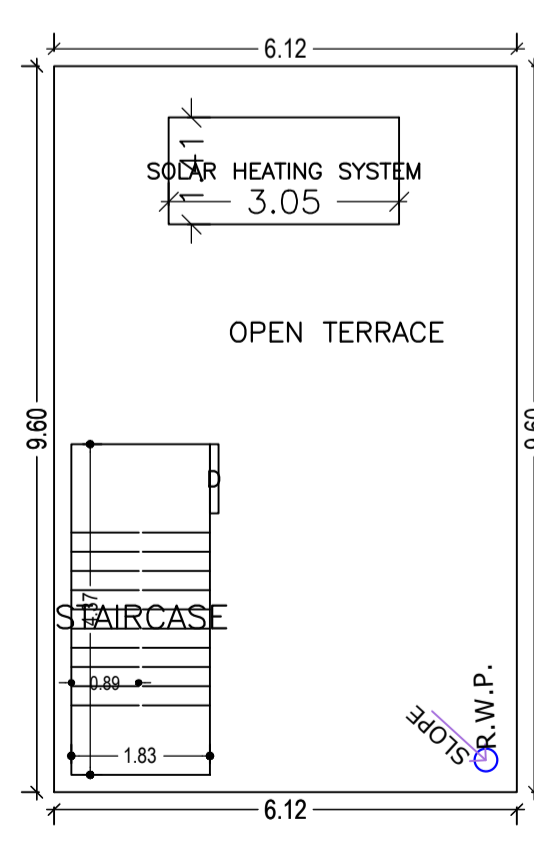
DETAILS DRAWING OF RAIN WATER HARVESTING

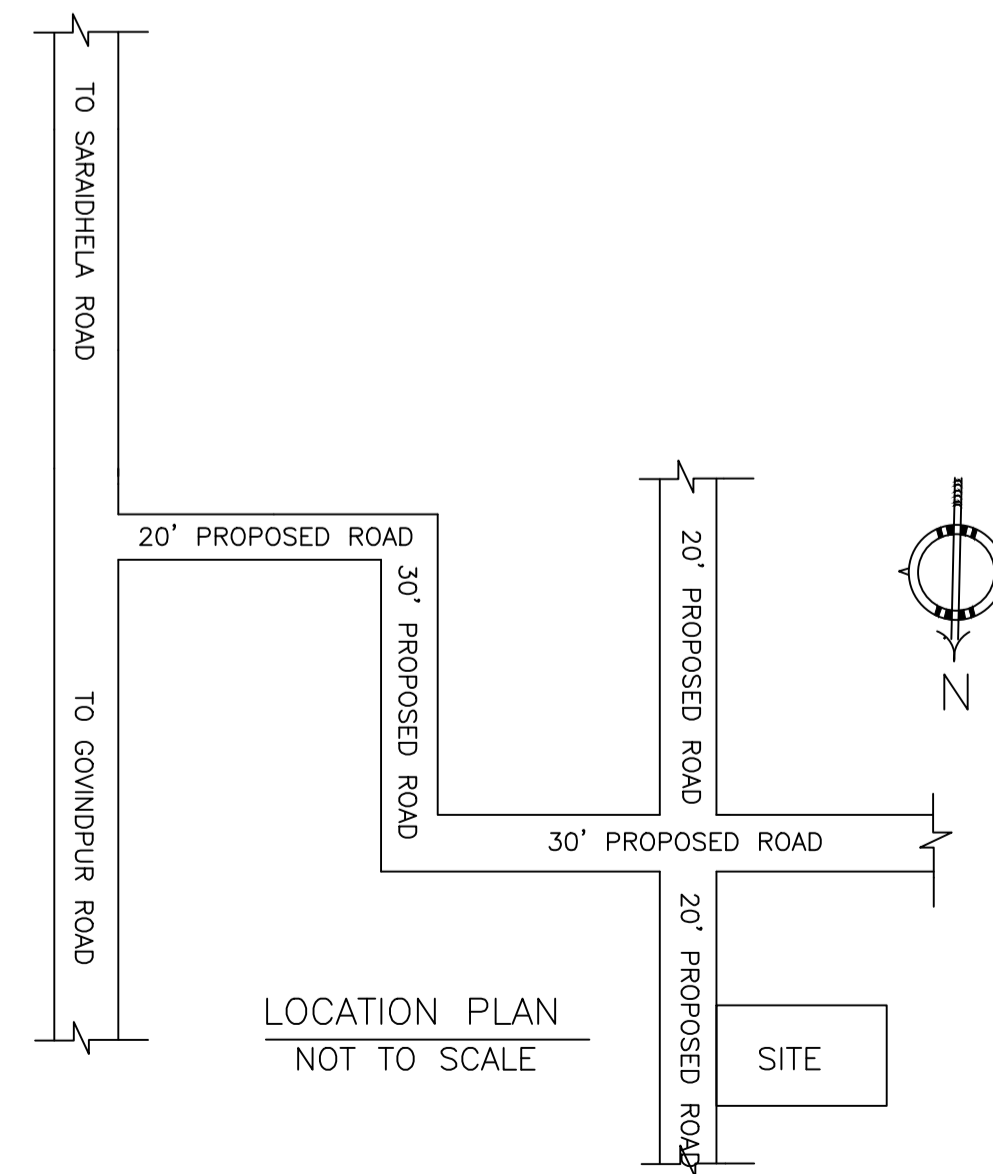
GROUND FLOOR PLAN (Proposed)

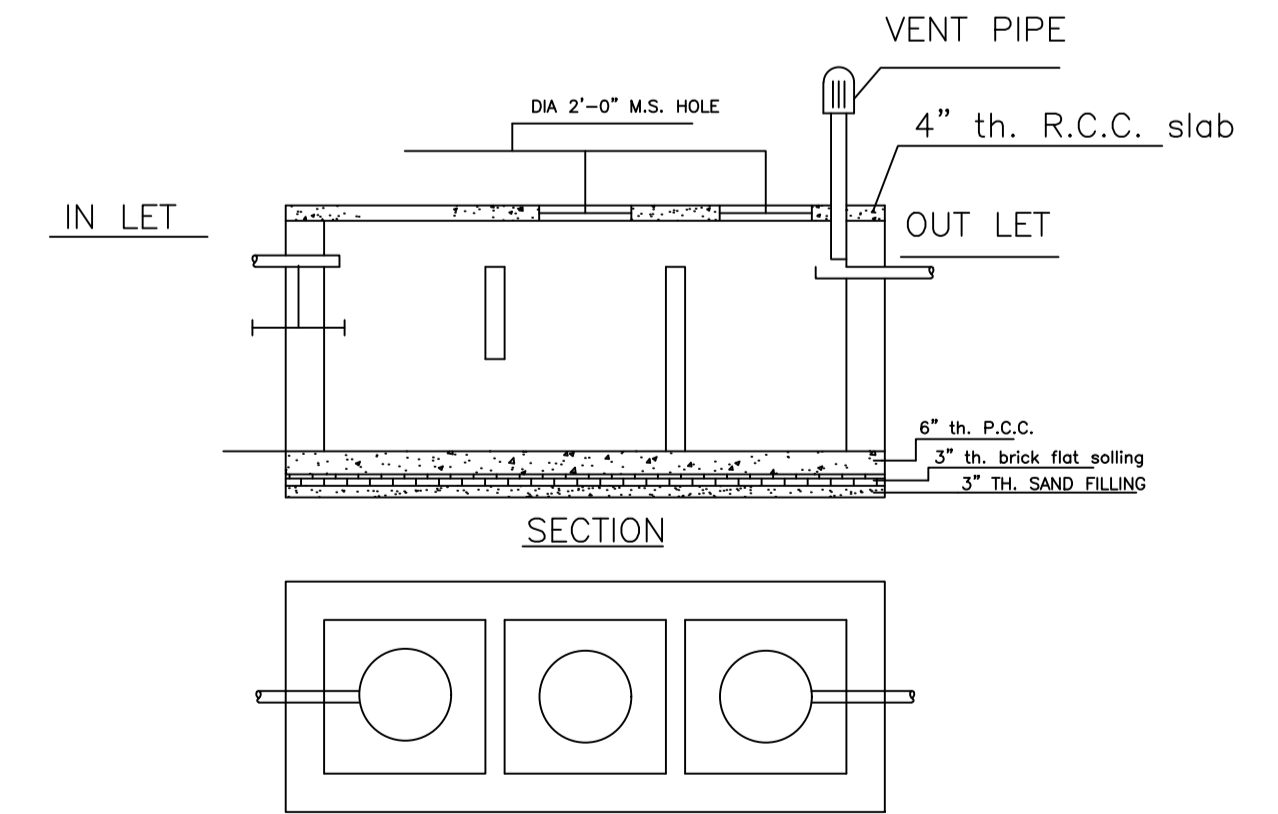
FIRST FLOOR PLAN (Proposed)
