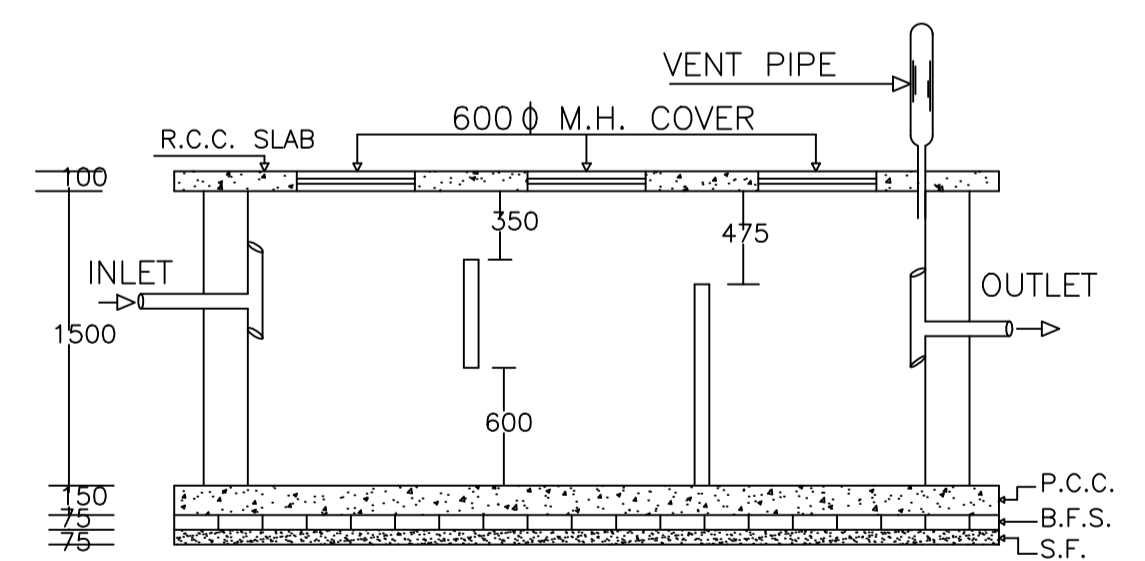

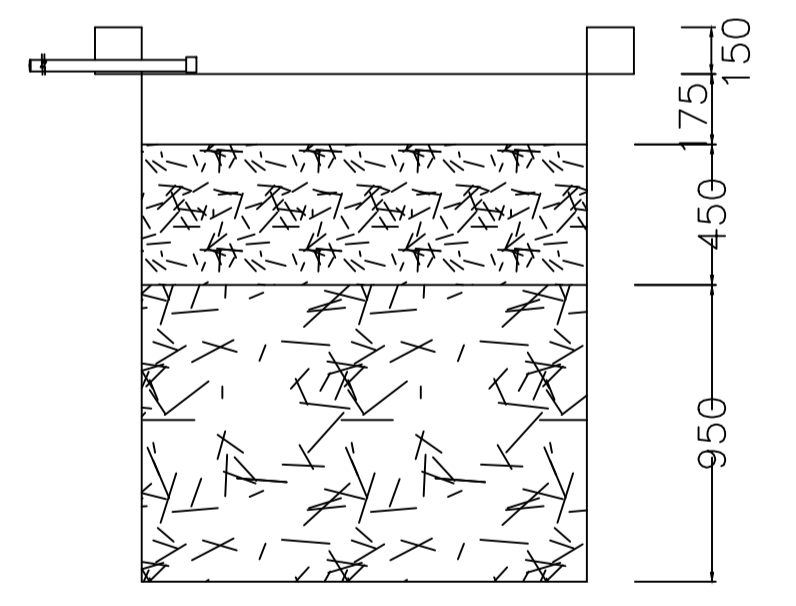
LOCATION PLAN

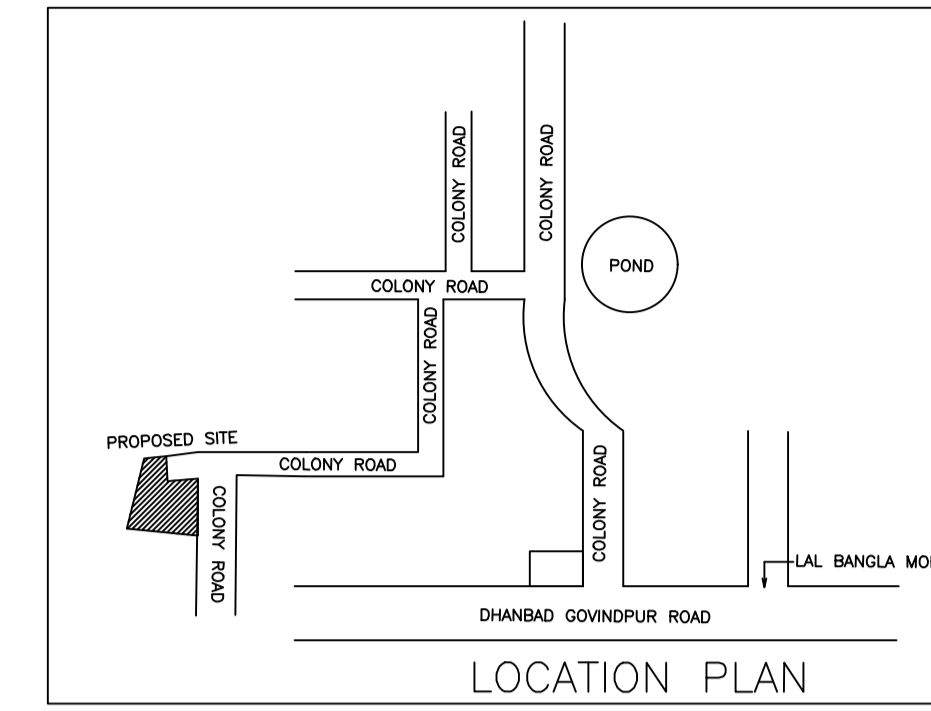
FIRST FLOOR PLAN

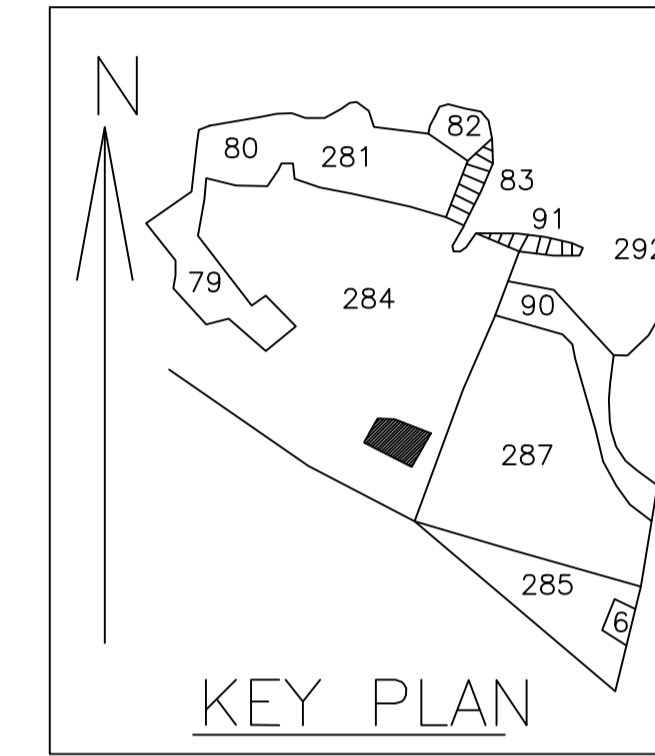
SECOND FLOOR PLAN

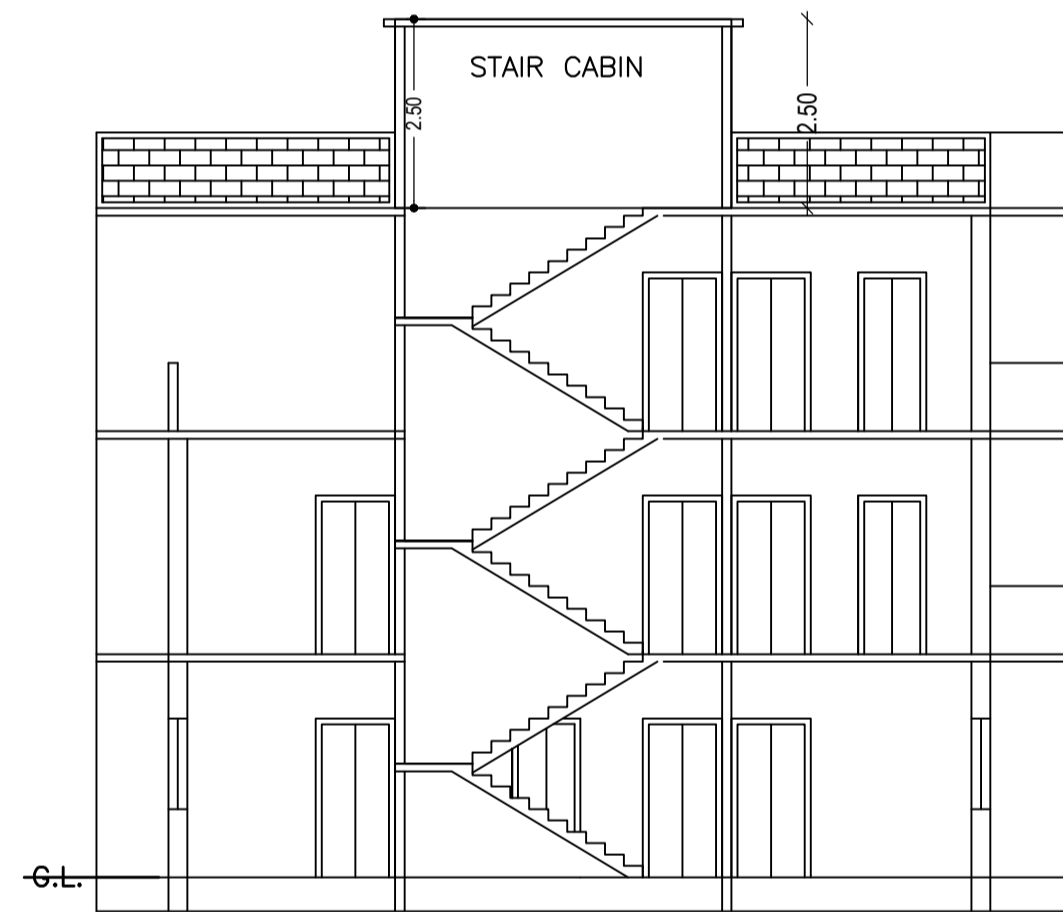
TERRACE FLOOR PLAN

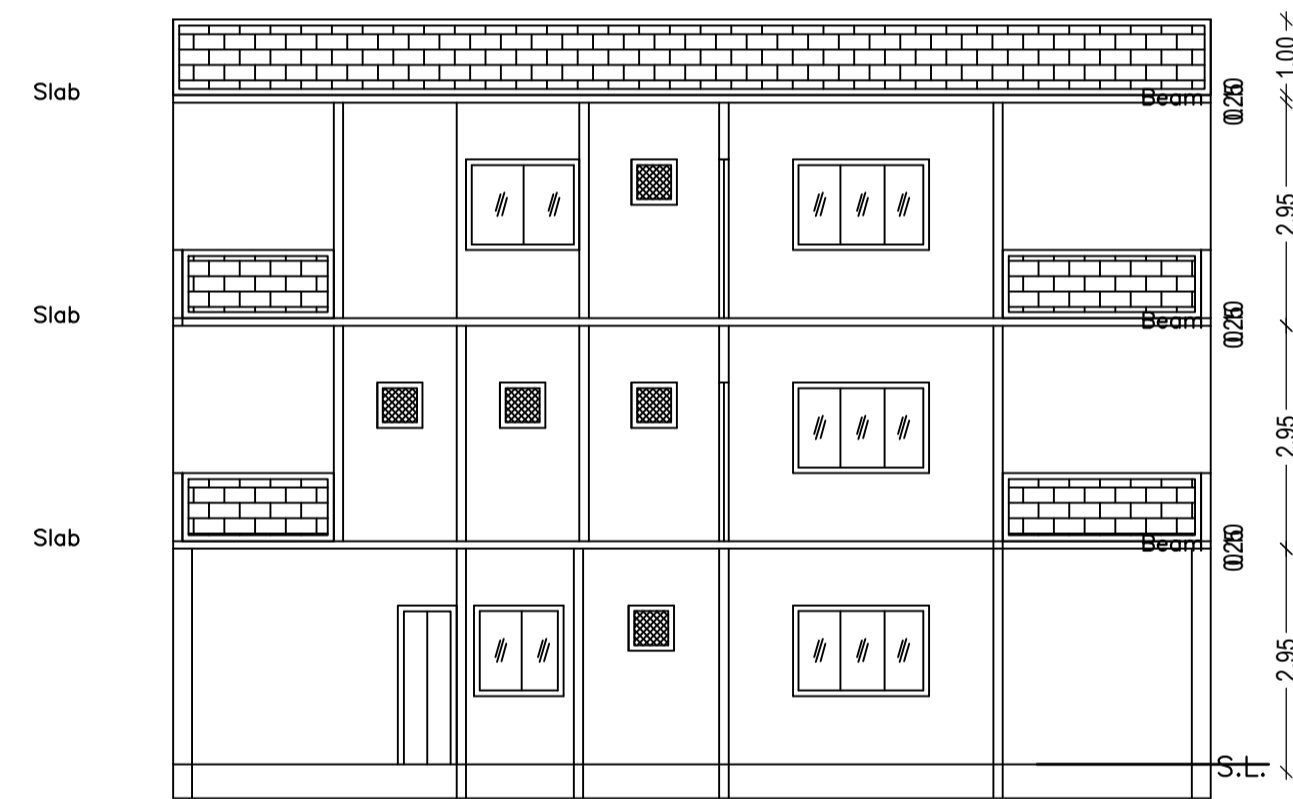

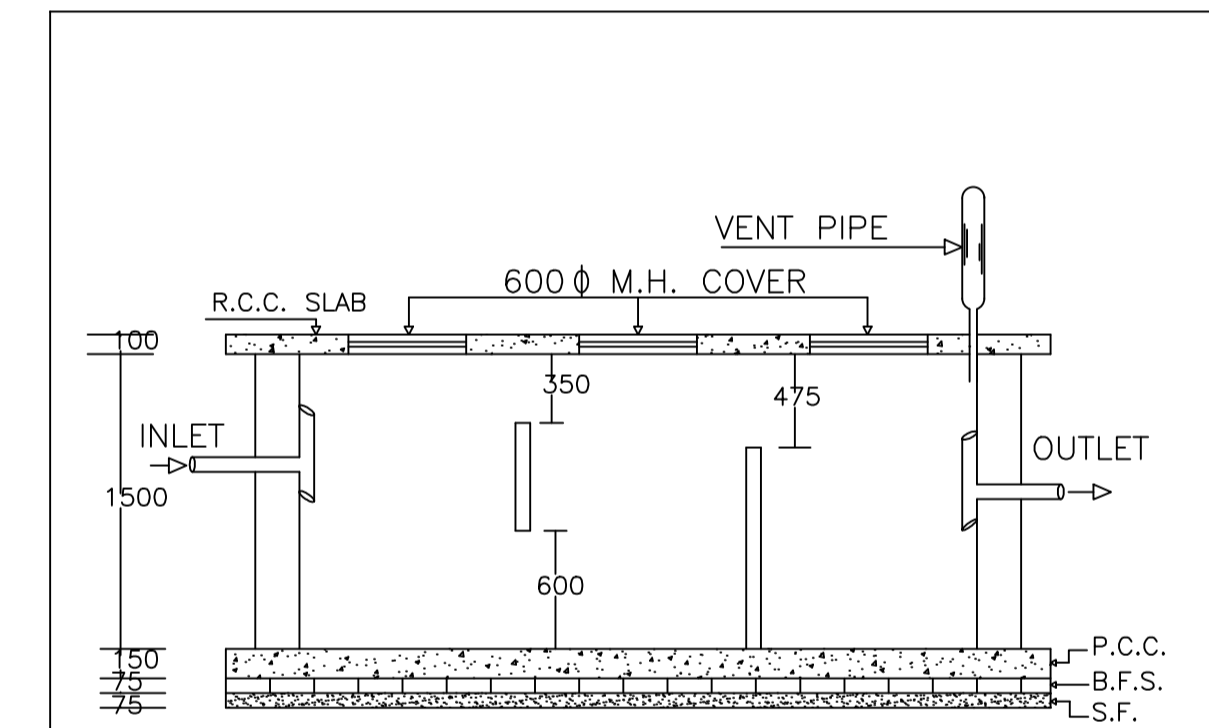

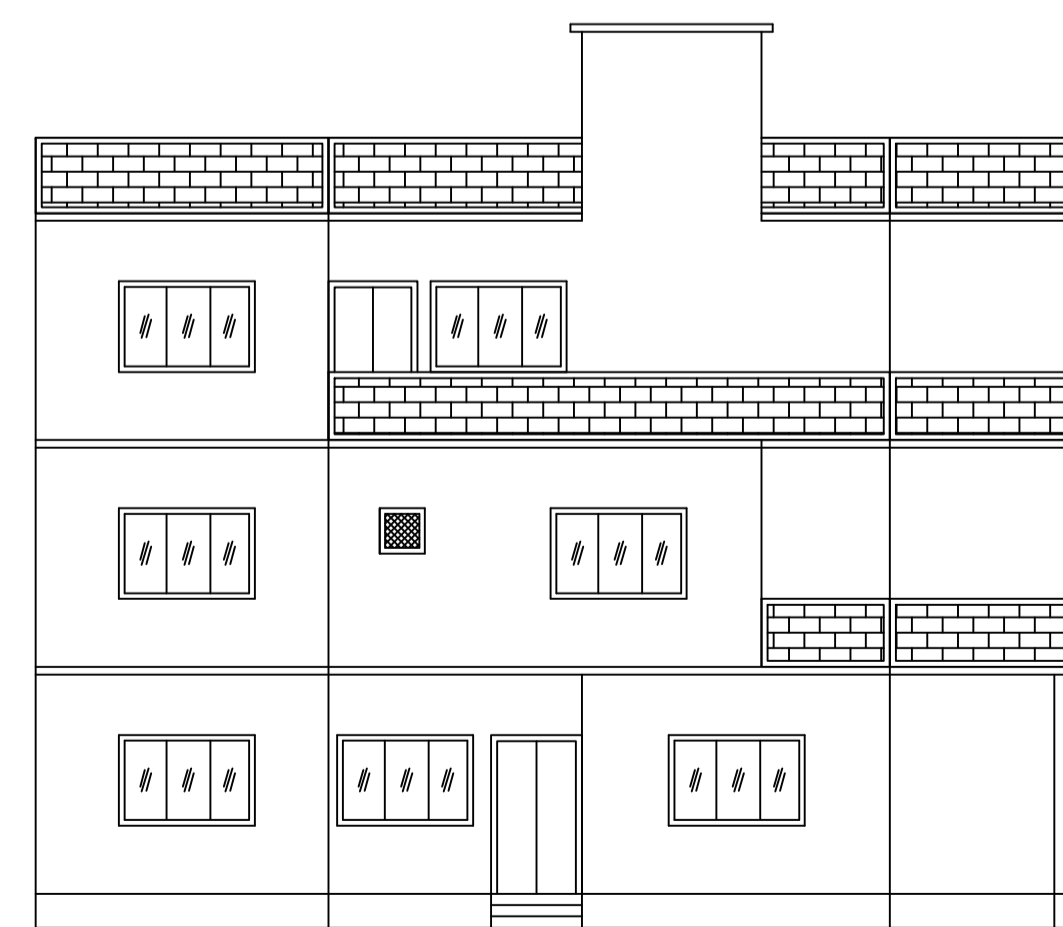


PLAN OF RECHARGE WELL

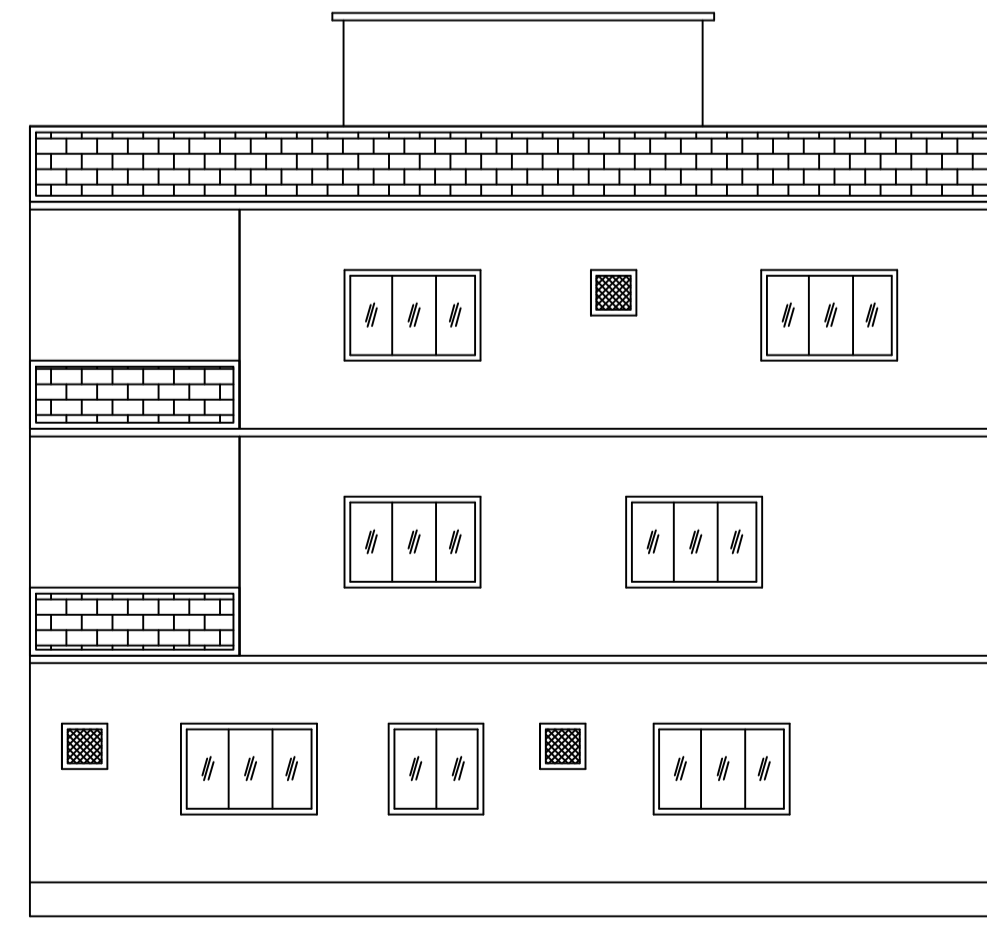
