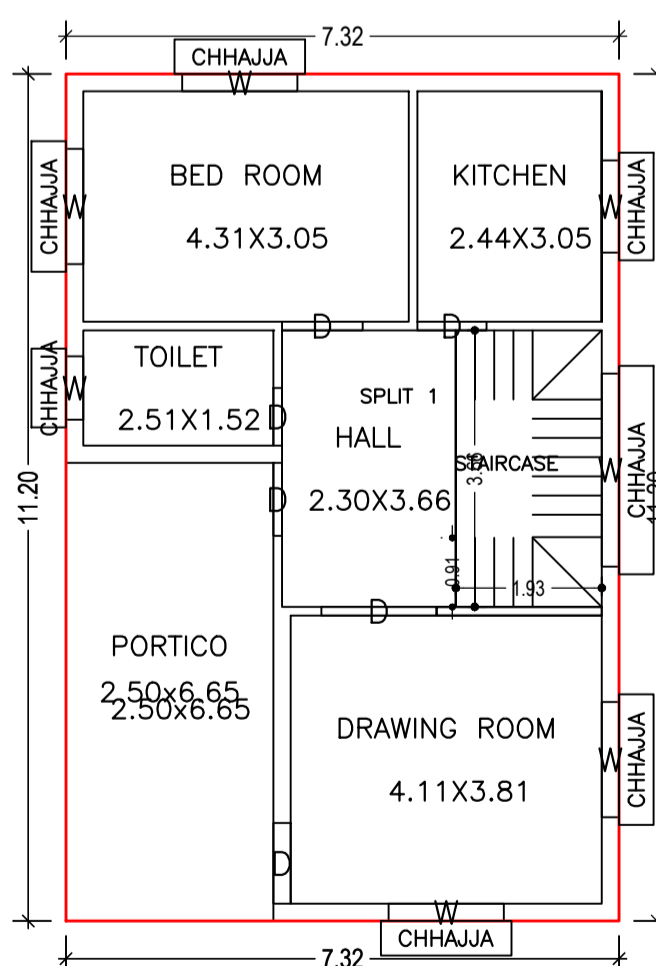

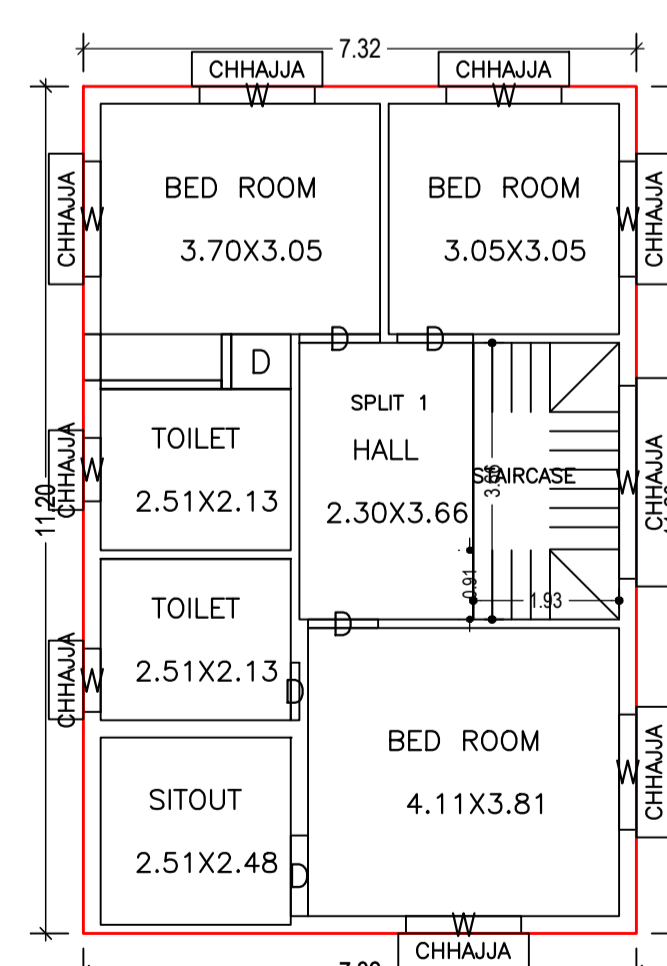
DETAILS OF COLUMN FOUNDATION



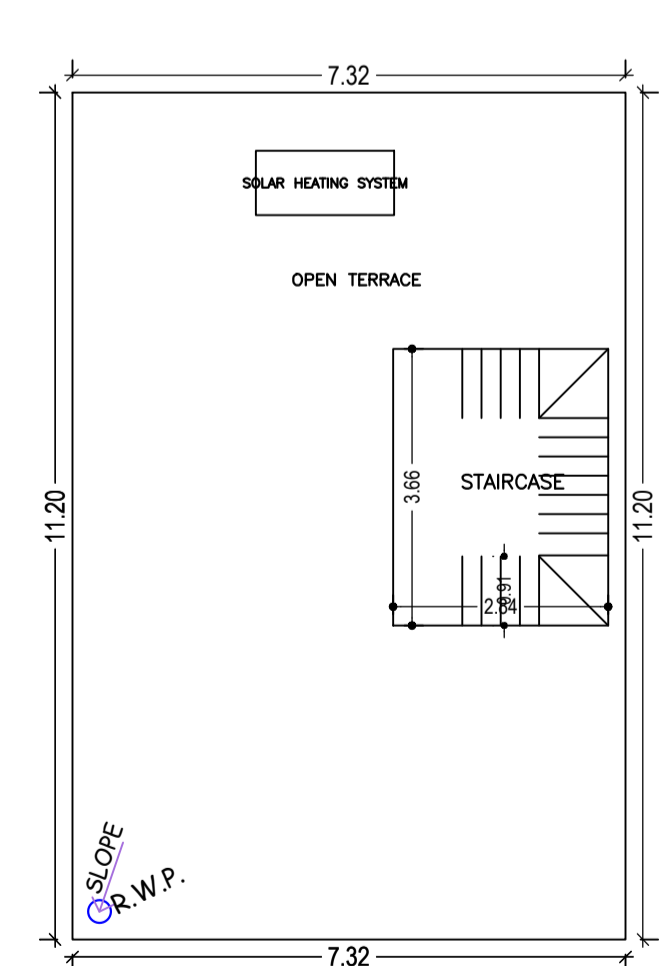
DETAILS OF SEPTIC TANK
